Pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Hon'ble National Company Law Tribunal ("NCLT"), Amravati Bench, vide its order dated April 06, 2026, has admitted the petition filed under Section 7 of the Insolvency and Bankruptcy Code, 2016 ("IBC") against the Company and Corporate Insolvency Resolution Process ("CIRP") has been initiated.

Consequent upon commencement of CIRP, the powers of the Board of Directors stand suspended and are being exercised by the Interim Resolution Professional / Resolution Professional ("IRP/RP") in accordance with the provisions of the IBC.

In view of the ongoing CIRP process, transition in management control, collection and reconciliation of financial information, coordination with various stakeholders, and operational challenges arising therefrom, the Company is facing practical difficulties in finalization of the Audited Financial Results for the quarter and financial year ended March 31, 2026 within the prescribed timeline under Regulation 33 of the SEBI (LODR) Regulations, 2015.

Accordingly, the Company humbly requests your good office to grant extension of time up to 15th June 2026 for submission of the aforesaid Audited Financial Results and related filings.

The Company assures the Exchange that all efforts are being made to complete the financial statements and statutory audit at the earliest possible time and the same shall be submitted immediately upon completion.
