The securities transferred under this special window shall be:

Credited only in **dematerialized (Demat) form** to the transferee's demat account. Subject to a **lock-in period of one year** from the date of registration of transfer. During the lock-in period, such securities **cannot be transferred, pledged, or lien-marked**.

To avail of this facility, the lodger(s) must: Possess the **original share certificate(s)**; and Submit all the prescribed documents as specified in the above-mentioned SEBI Circular, along with the original share certificate(s), to the Company's Registrar and Share Transfer Agent (RTA).

Please note that cases involving disputes between the transferor and transferee are **not eligible** under this special window and may be resolved through the appropriate judicial forum, including the Court or the National Company Law Tribunal (NCLT), as applicable.
