O R D E R

1. Delay condoned.
2. Leave granted.
3. These appeals are filed against the common judgment and orders dated 13.02.2024 and 22.05.2024 passed by the Division Bench of the High Court of Madhya Pradesh in Writ Petitions and Review petitions respectively.
4. The Award determining compensation for land that has been acquired in these cases was passed on 31.10.2022 by the Additional Collector on the basis of an Order of Delegation passed by the Collector on 27.01.2022.
5. However, later, i.e. on 28.11.2022, the Government of Madhya Pradesh, Department of Revenue issued a clarification withdrawing delegation. Relevant portion is extracted hereinbelow:

DATED: 03/01/2022

Under the subject, by the referenced notification of the Ministry of Road Transport and Highways, Government of India, all the collectors of the state have been given arbitrator powers under subsection (5) of section 3G of the National Highways Act 1956. These rights cannot be delegated to the Additional Collector or anyone else in division of work or in any other form.

Please take action accordingly in reference to the said notification.

6. The above-referred clarification dated 28.11.2022, it is assumed the effect of invalidating the award dated 31.10.2022 as it was passed by the Additional Collector. It is evident from the record that the appellant challenged the award dated 31.10.2022 by filing objections under Section 34 of the Arbitration and Conciliation Act, 1996 on 31.10.2022. However, in view of subsequent clarification dated 28.11.2022, the appellant withdrew the Section 34 objections on 13.02.2023.

7. In the meanwhile, the respondent filed a writ petition under Article 226 of the Constitution of India challenging the clarification dated 28.11.2022 on the ground that Additional Collector is entitled to pass an award, as delegation by the Collector to the Additional Collector is legal and valid in law.

The High Court, by the order impugned before us, allowed the writ petition and directed that the Collector could not have recalled the award passed by the Additional Collector in the absence of any express provision for reviewing the arbitral award.

8. Heard learned counsel for the appellant (NHAI) and the respondents. As the award has already been passed on 31.10.2022 i.e., much before the issuance of the clarification dated 28.11.2022, we are of the opinion that orders impugned need not be interfered with. The Award passed by the Additional Collector dated 27.01.2022 as restored and the judgment and order of the High Court to this extent is affirmed. The question of law about the legality and validity of delegation, particularly in view of the provisions of the General Clauses Act is academic for the present case. This question is, however, kept open for being considered in an appropriate case. This approach is adopted only to ensure that the acquisition proceedings that have started way back in 2014 conclude as expeditiously as possible.

9. We make it clear that the statutory remedies under sections 34 and 37 of the Act are available for being adopted by either party, if necessary and if so advised.

10. We are informed that the appellant-NHAI has filed an application for restoration of the objections under Section 34 of the Act which it withdrew on 13.02.2023 and that the said application was allowed on 02.09.2024 and the objections under Section 34 are restored. Parties are entitled to pursue their

remedies.

11. With these clarifications as indicated hereinabove, the Civil Appeals stand disposed of.

12. Pending application(s), if any, shall stand disposed of.
