**Sub: Corrigendum to Earlier Disclosure made under Regulation 30 of SEBI (LODR) Regulations, 2015 regarding Show Cause Notice received from DGGI**

Dear Sir/Madam,

This is with reference to the disclosure submitted by the Company on 26th May, 2026 under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 regarding receipt of a Show Cause Notice (“SCN”) from the Directorate General of GST Intelligence (“DGGI”), Delhi Zonal Unit.

The Company wishes to clarify that, due to inadvertence the complete copy of the SCN was annexed along with the aforesaid disclosure.

**1. Nature of the Notice:**

The SCN received by the Company is a preliminary communication containing the initial observations and allegations of the tax authorities. It is not a final demand order and does not constitute a finding of fraud or suppression by the Company.

**2. Company’s Position:**

The Company categorically denies all allegations of tax evasion or willful suppression of facts. The matter pertains to a difference in interpretation of the GST classification (HSN). The Company, based on professional legal advice, maintains that its classification is compliant with the applicable taxes under the GST Act and supported by established industry practices.

**3. Action Taken:**

The Company is in the process of filing a comprehensive, evidence-based reply to the authorities. We are confident of our legal position and believe this dispute will be resolved in the Company's favor through the due legal process.

**4. Impact:**

This development is in the nature of a routine tax-related classification dispute. It does not have any material impact on the Company's operational continuity or its ability to carry out day-to-day business activities.

We request the stakeholders to treat the previously uploaded document as a procedural filing and rely on this clarification for the Company's stance on the matter.

We apologize for any inconvenience caused by the inadvertent disclosure of the full notice.
