We wish to inform you that our Company has received today letters dated 20th May, 2026 (“Request Letters”) from, following, being part of promoter group of the company seeking re-classification from the ‘promoter and promoter group’ of our Company pursuant to Regulation 31A of the SEBI Listing Regulations.


