1. Mr. Purushottam Sharma Tripathi, learned counsel appearing for the petitioner submits that the Pharmacy Council of India rejected the petitioner's application for B. In view of the fact that the counselling is not yet over, as an exceptional case, we direct the Pharmacy Council of India to process the application and pass the appropriate order for grant of approval which was earlier rejected on 03.07.2026 so that the petitioner may participate in the counselling.

4. Accordingly the Writ Petition is disposed of.
