Sub: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Execution of a Port Operations Agreement with Indo Energy International Limited for exclusive handling of permitted dry bulk cargo at Sanegaon Jetty, Raigad District, Maharashtra.

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), read with Paragraph B of Part A of Schedule III thereto and the SEBI Master Circular for compliance with the provisions of the Listing Regulations (as amended and updated from time to time), and in terms of the Company's Policy for Determination of Materiality of Events or Information, we wish to inform you that Shreeji Shipping Global Limited ("the Company") has, on September 14, 2026, executed Port Operations Agreement ("Agreement") with Indo Energy International Limited ("IEIL") in respect of the cargo jetty situated at Sanegaon, Raigad District, Maharashtra ("Sanegaon Jetty").

Under the Agreement, IEIL has granted the Company the exclusive right to handle all permitted dry bulk cargo at the Sanegaon Jetty, together with adjoining land for cargo storage, stacking and deployment of equipment, for the term specified under Agreement, commencing from 15th September 2026.

The arrangement extends the Company's dry bulk cargo handling operations to the Maharashtra coast and adds dedicated, exclusive jetty capacity and back-up land to the Company's existing shore-based handling infrastructure.

The Sanegaon Jetty is strategically positioned to serve the industrial hinterland of Mumbai, Raigad, Pune, Nashik and adjoining regions. Further, its rail connectivity through Roha provides access to a significantly larger hinterland, thereby enhancing the Company's cargo handling reach and creating synergies with its existing logistics and cargo handling capabilities. The strategic location and connectivity of the Sanegaon Jetty are expected to strengthen the Company's ability to cater to dry bulk cargo requirements across a wider geographic area and support the expansion of its integrated cargo handling operations.
