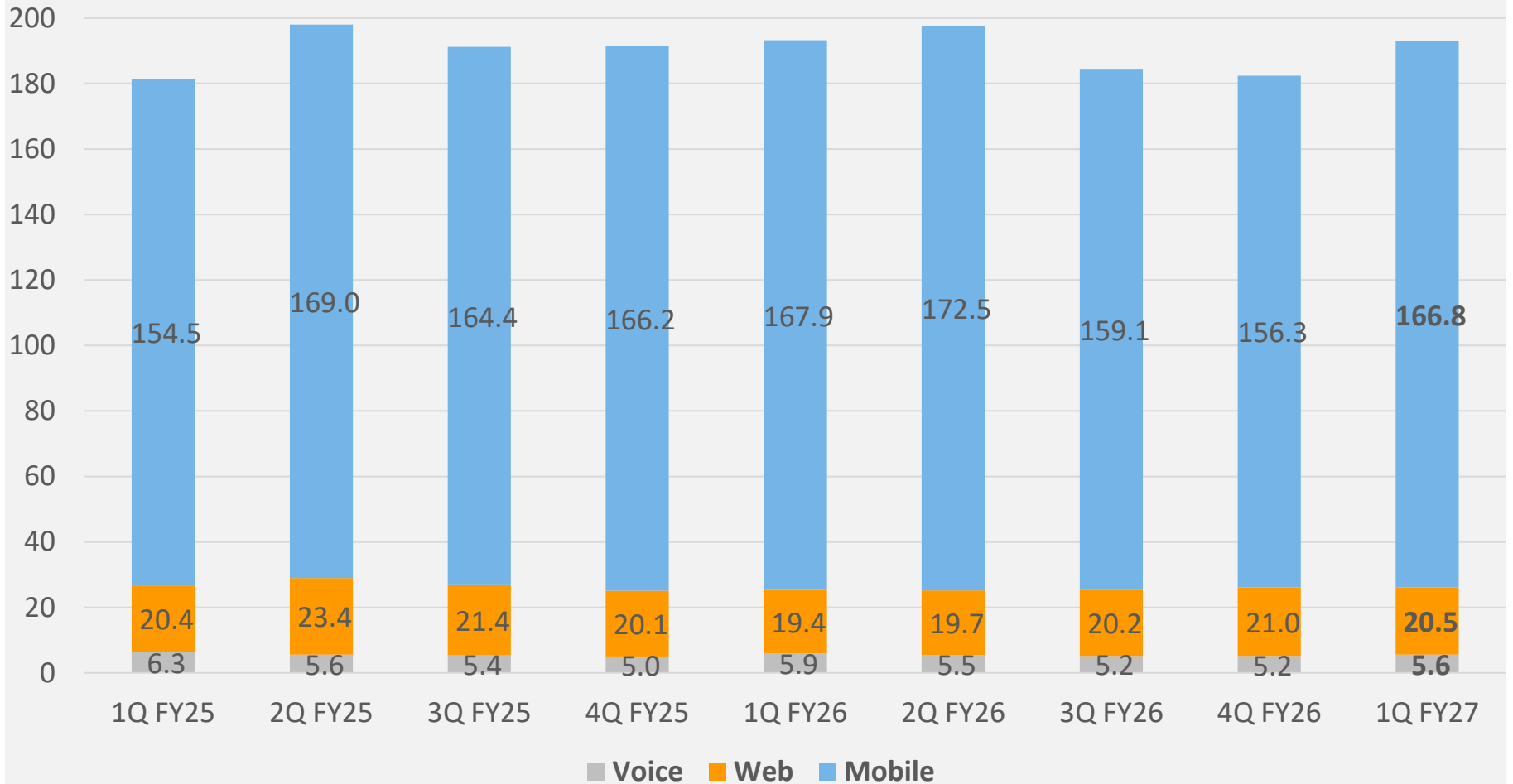

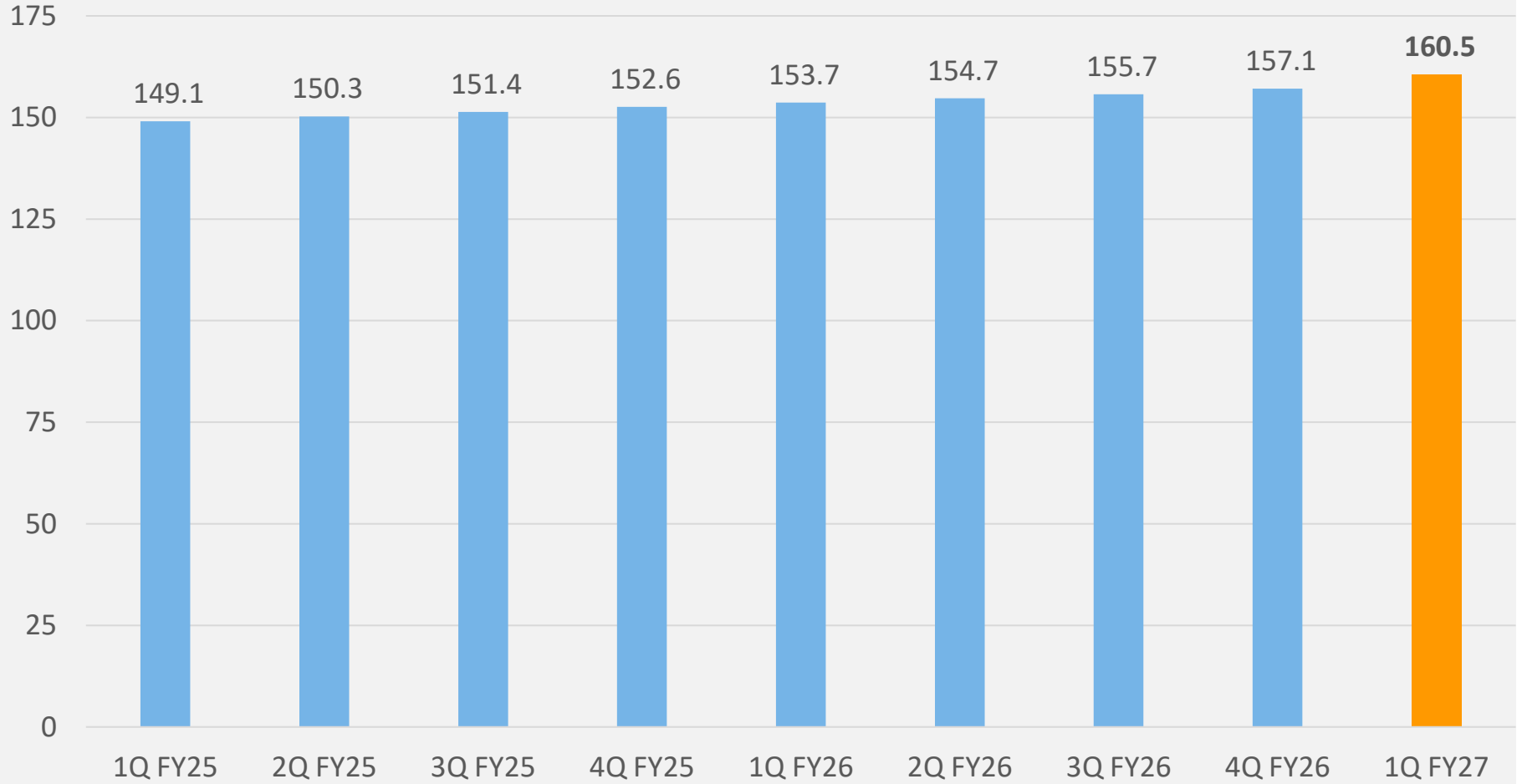
Quarterly Unique Visitors split (million)

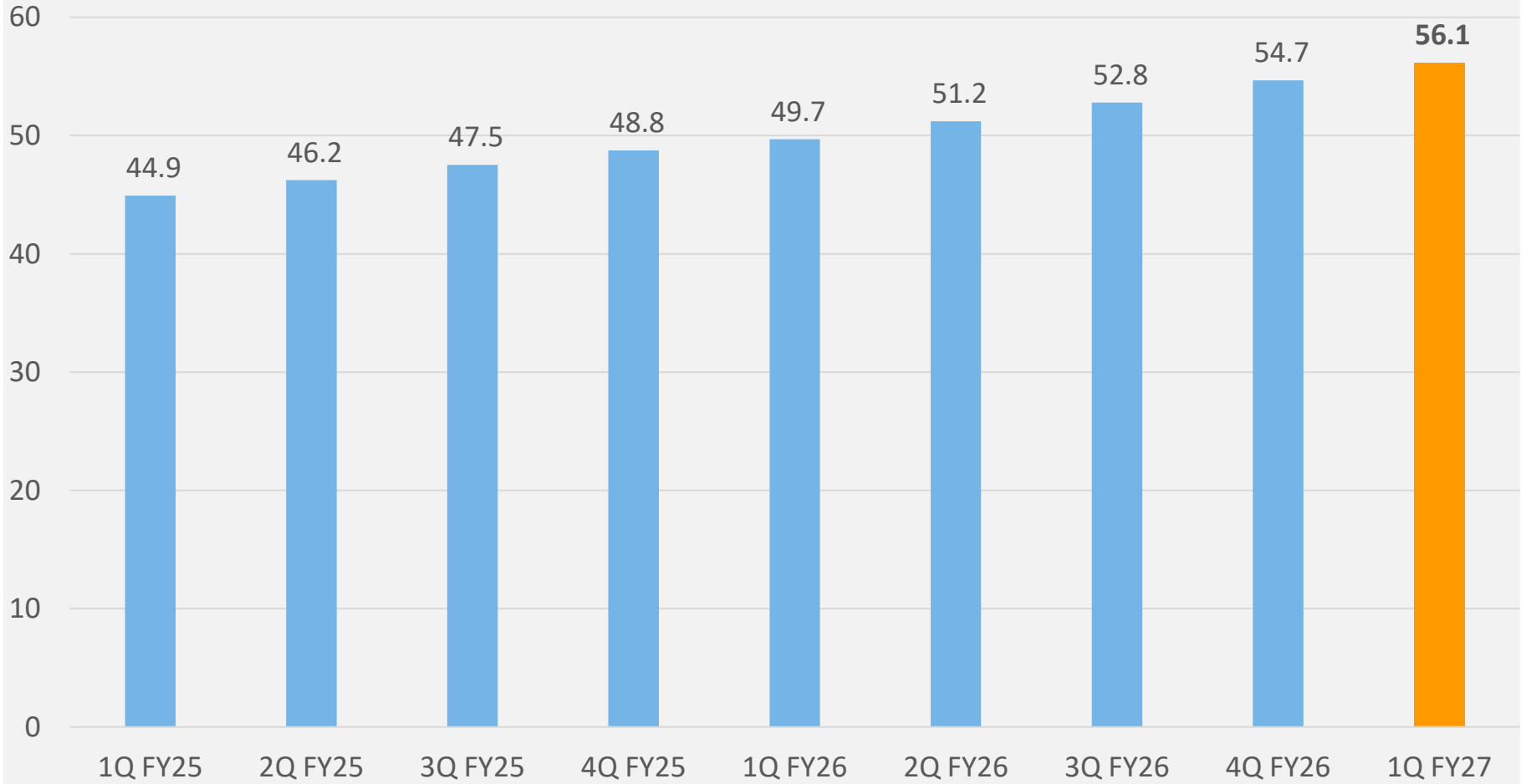

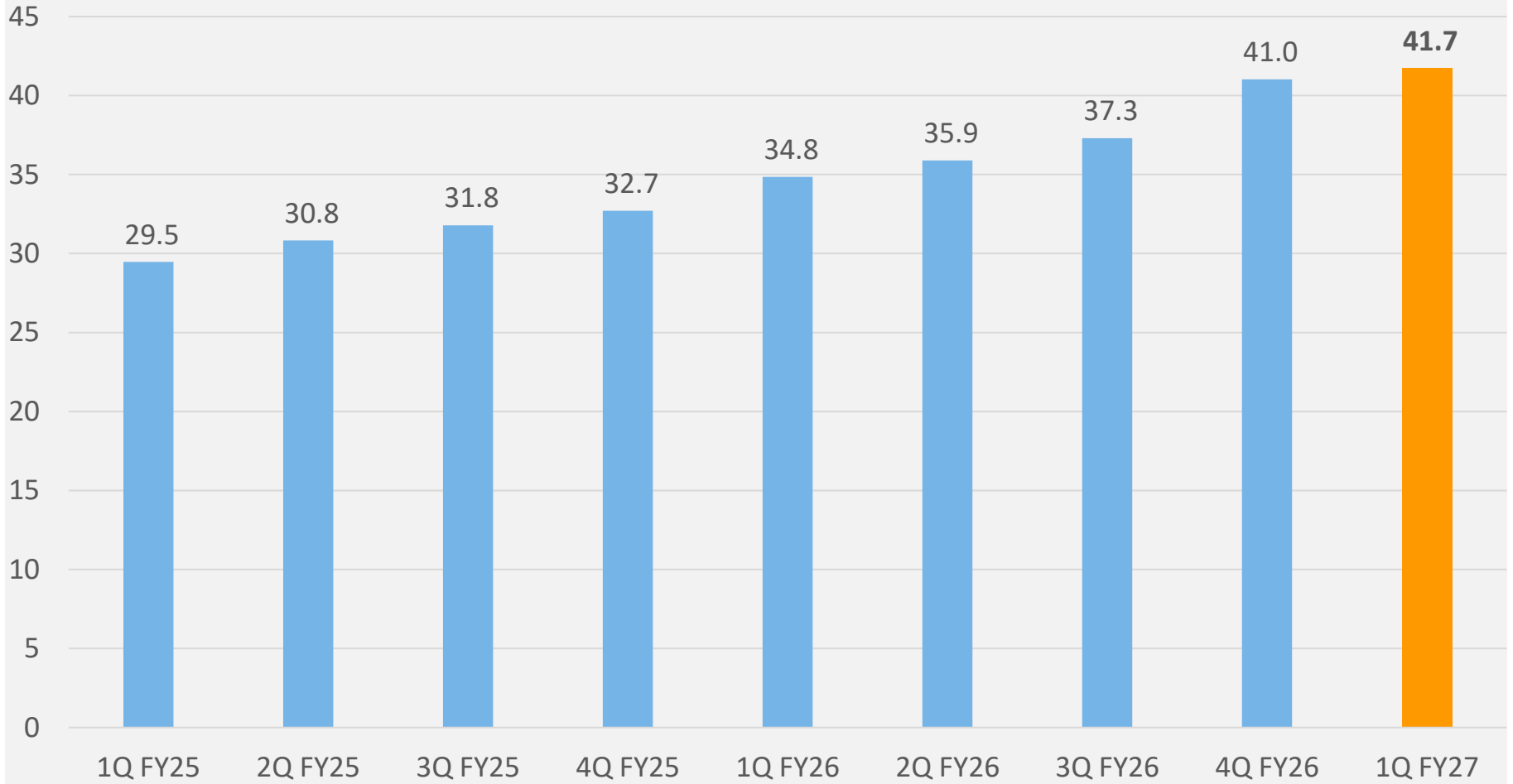

Active Listings - period end (million)



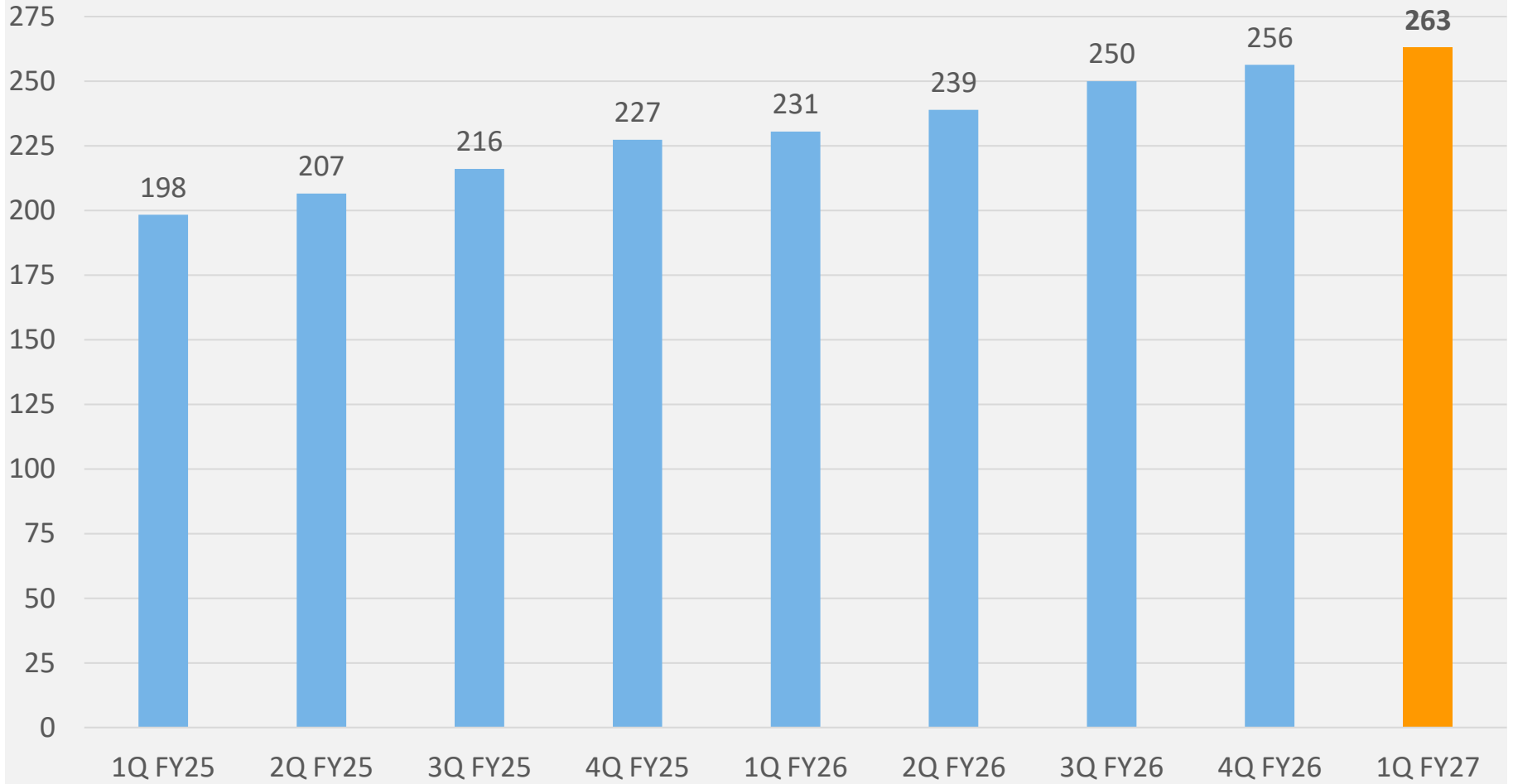

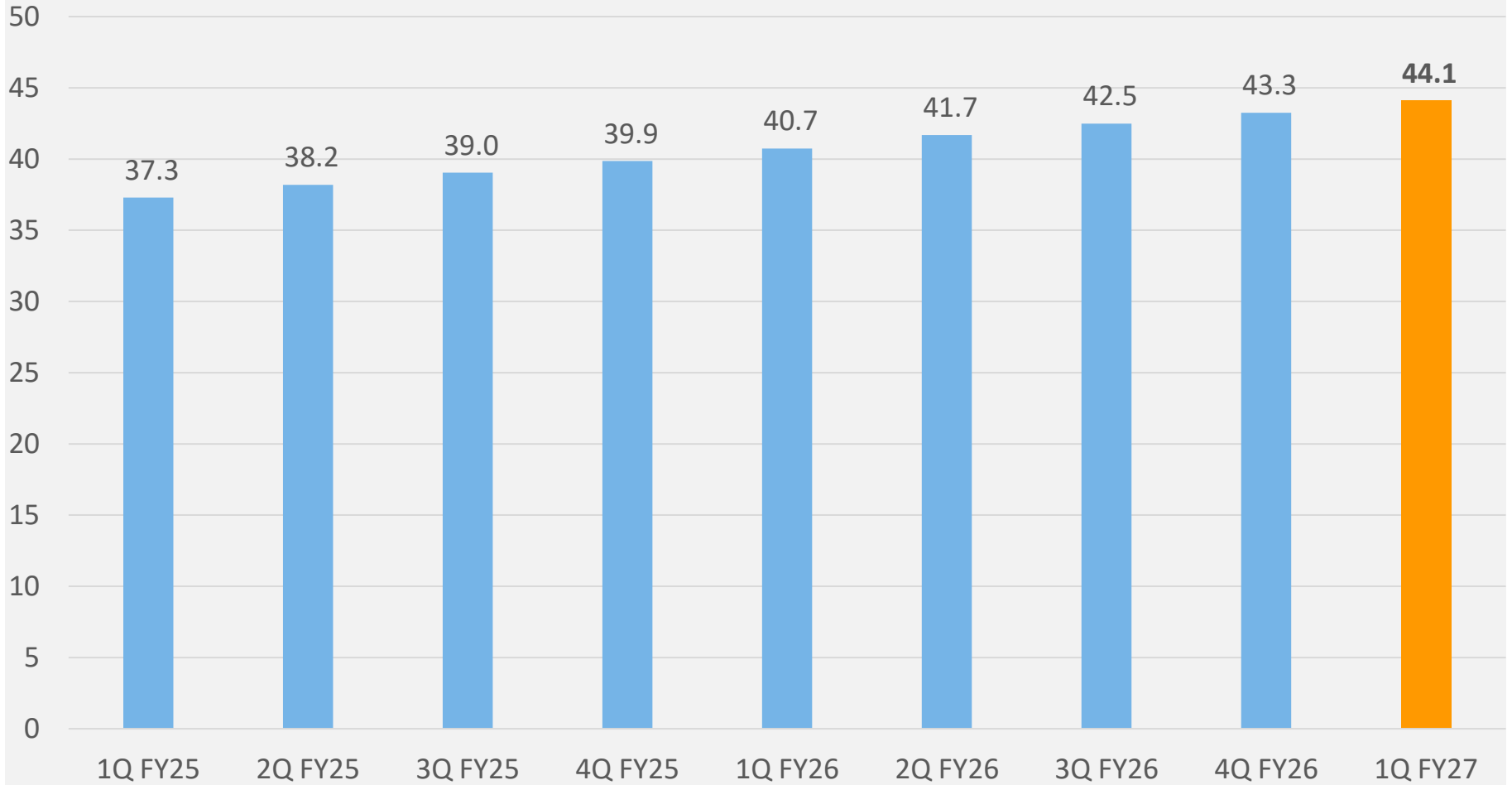

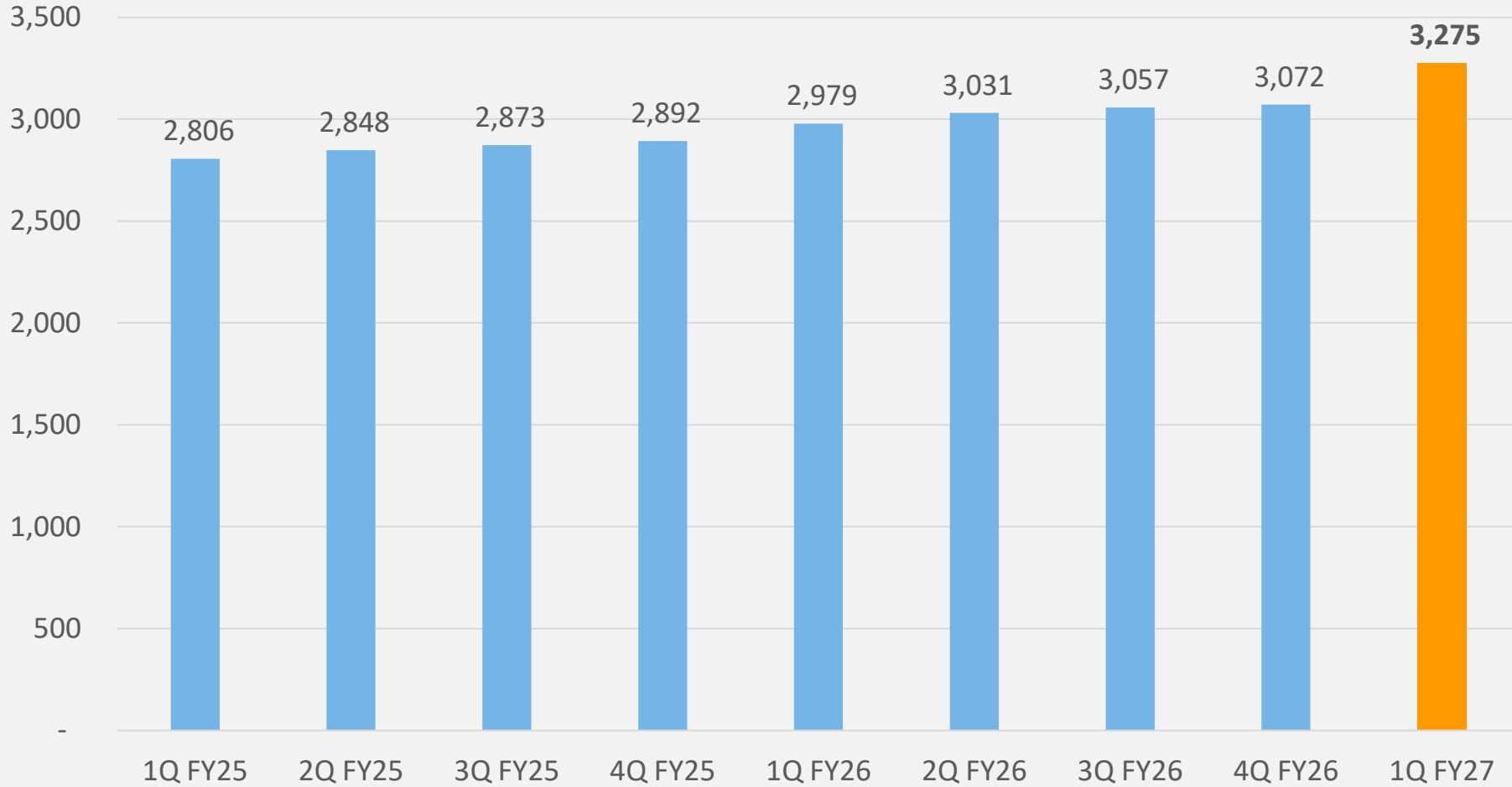

Cumulative JD App Downloads (million)



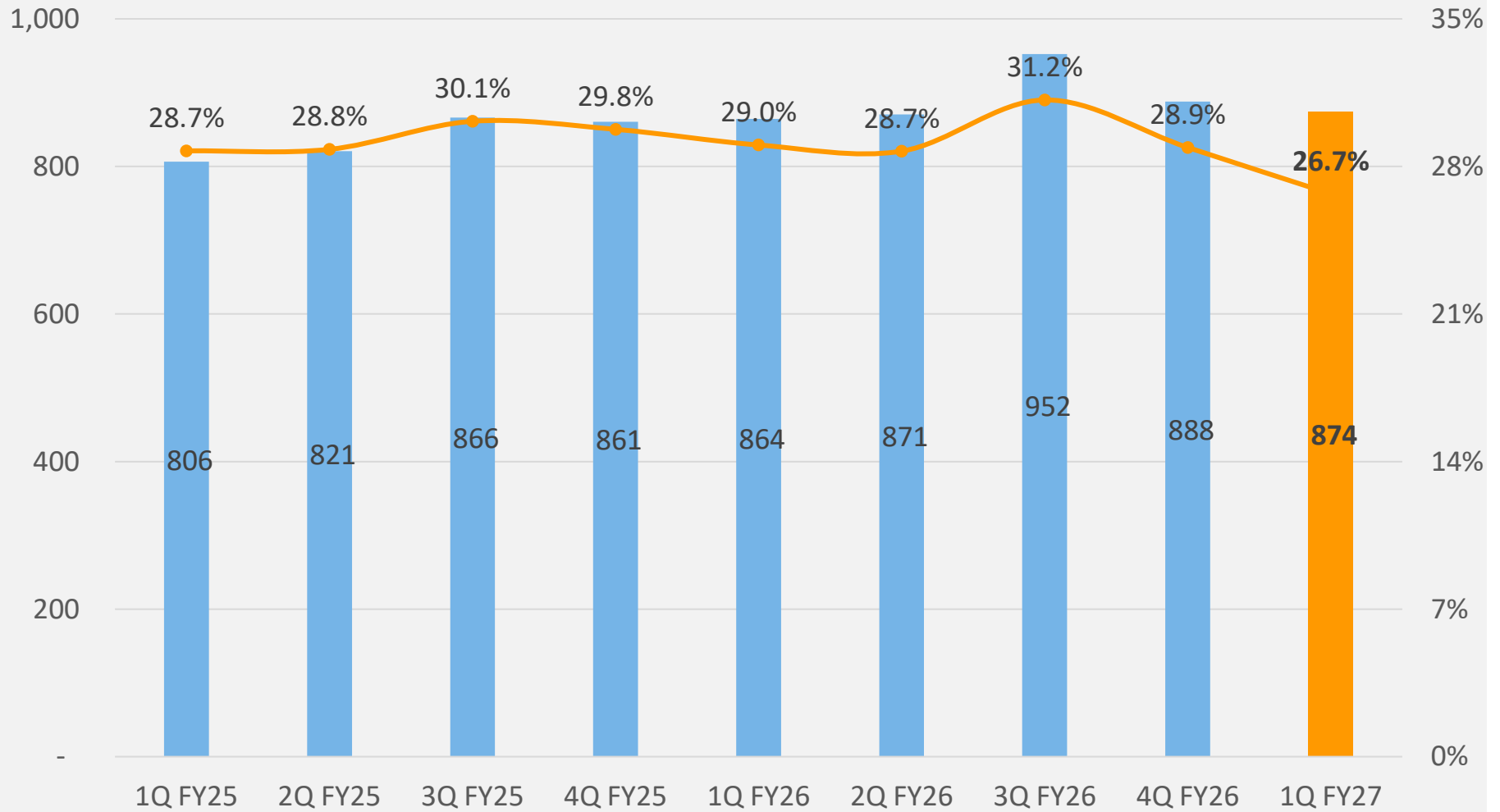

Operating Revenue (Rs million)



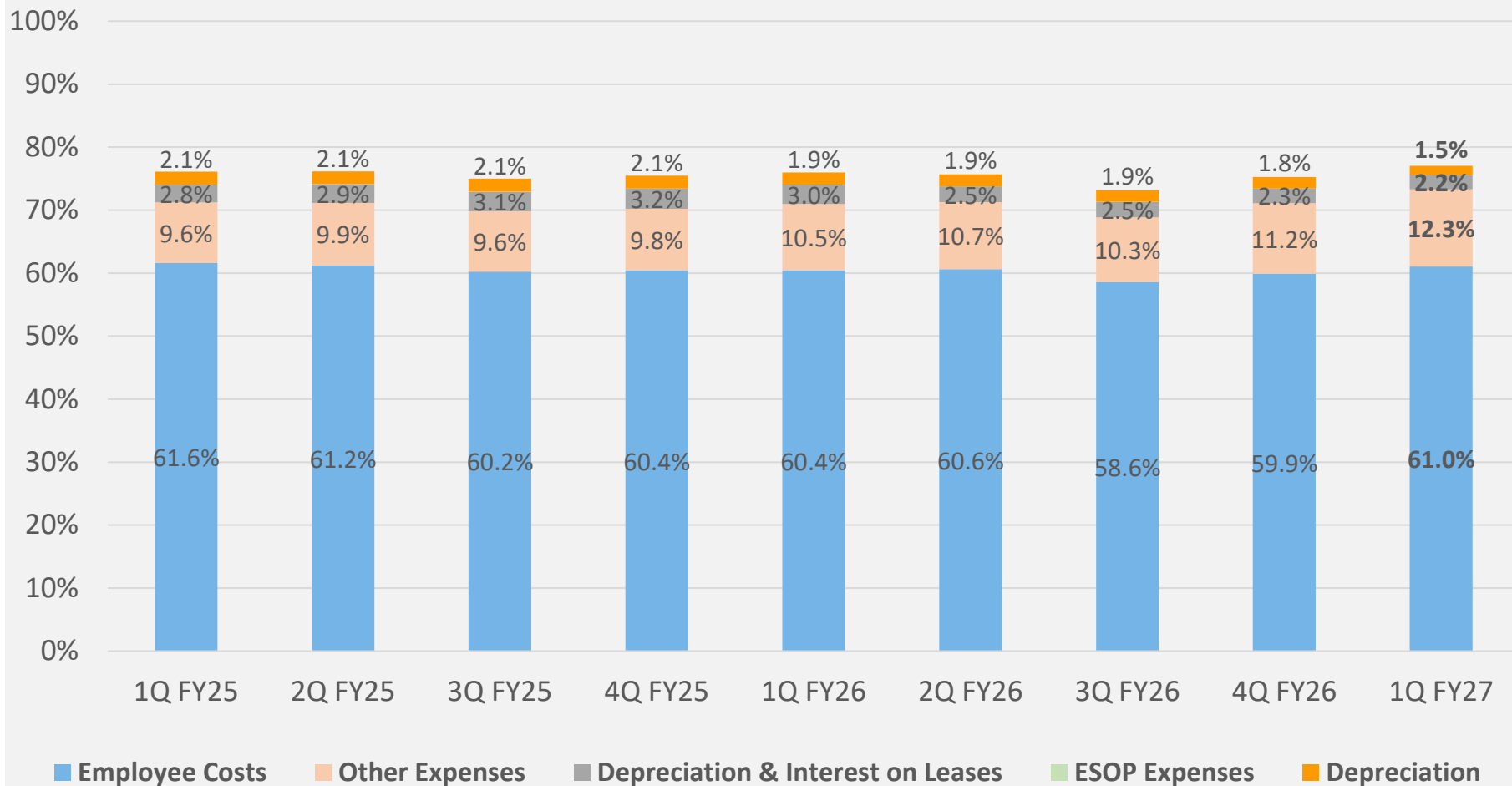
OPERATING MARGIN

EBITDA (Rs million) & Margin %

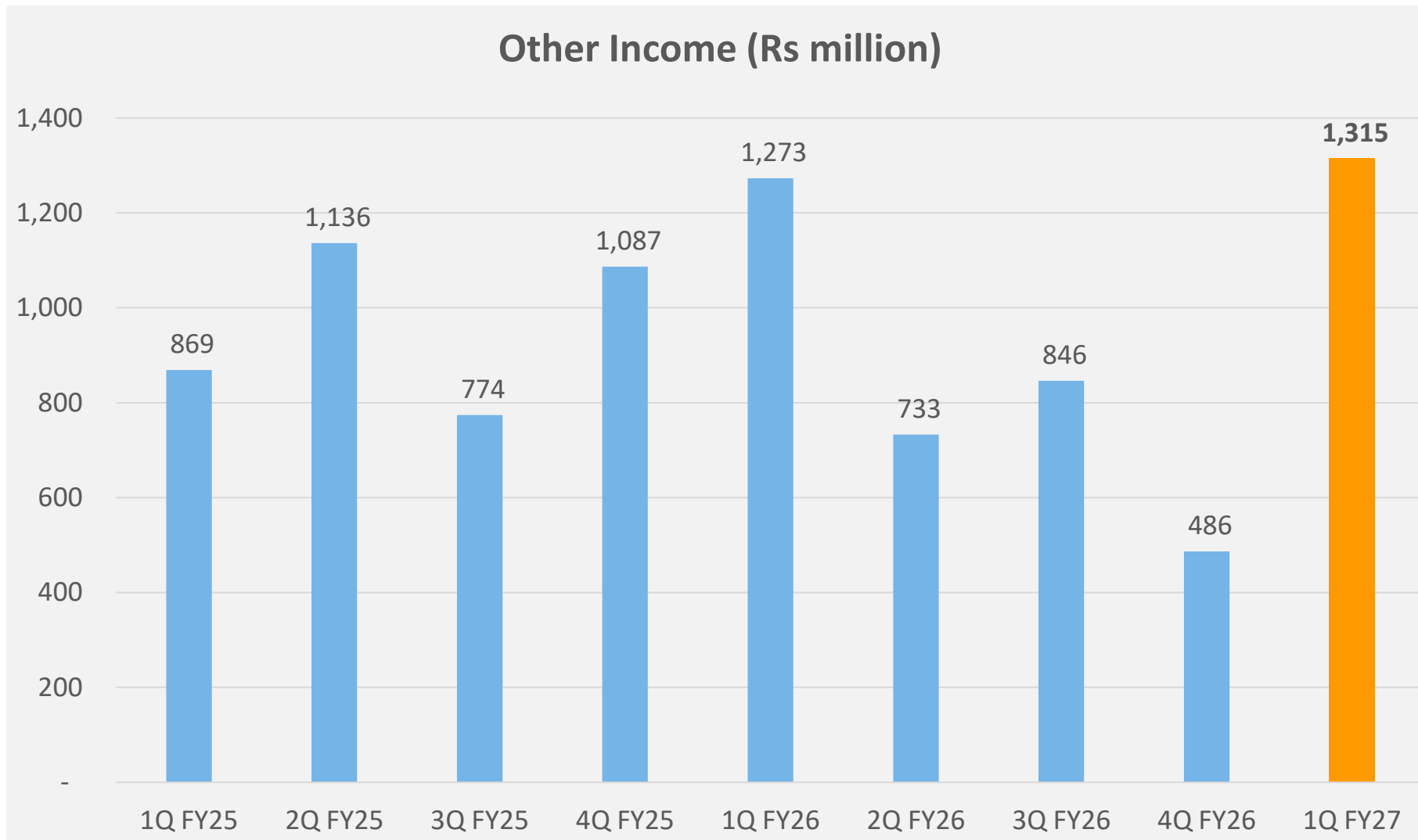


COST STRUCTURE

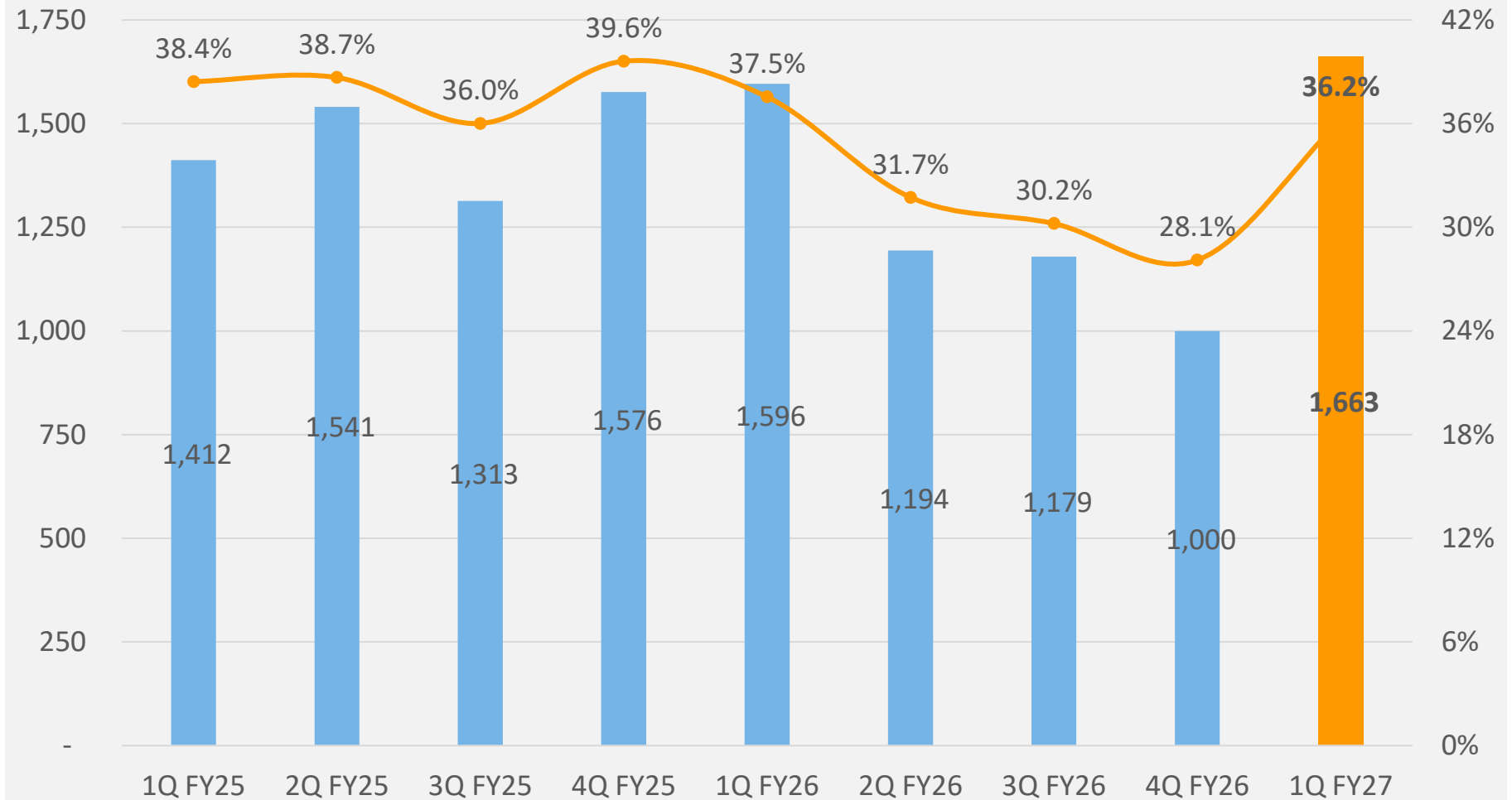

Net Profit (Rs million) & PAT Margin %

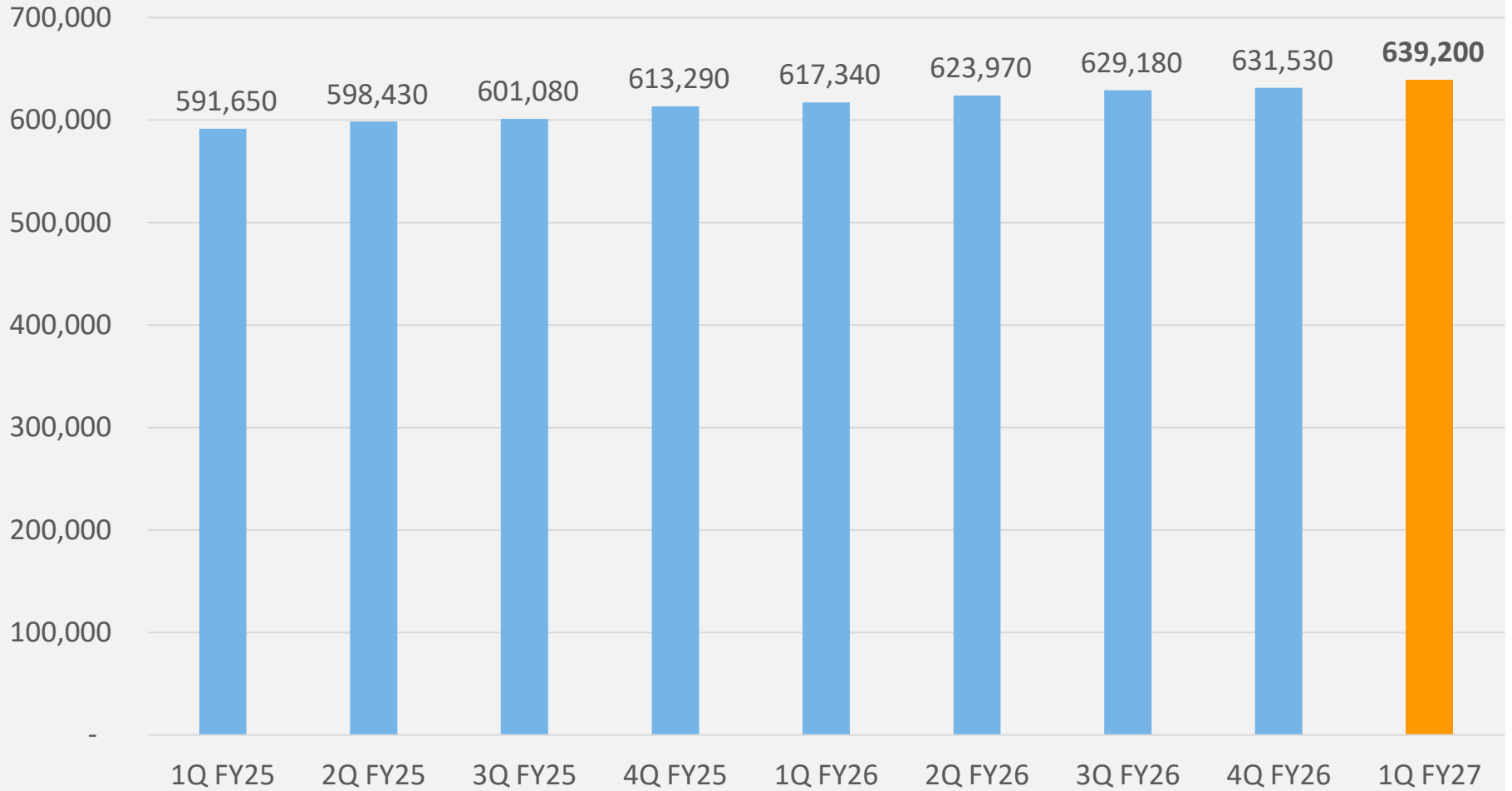

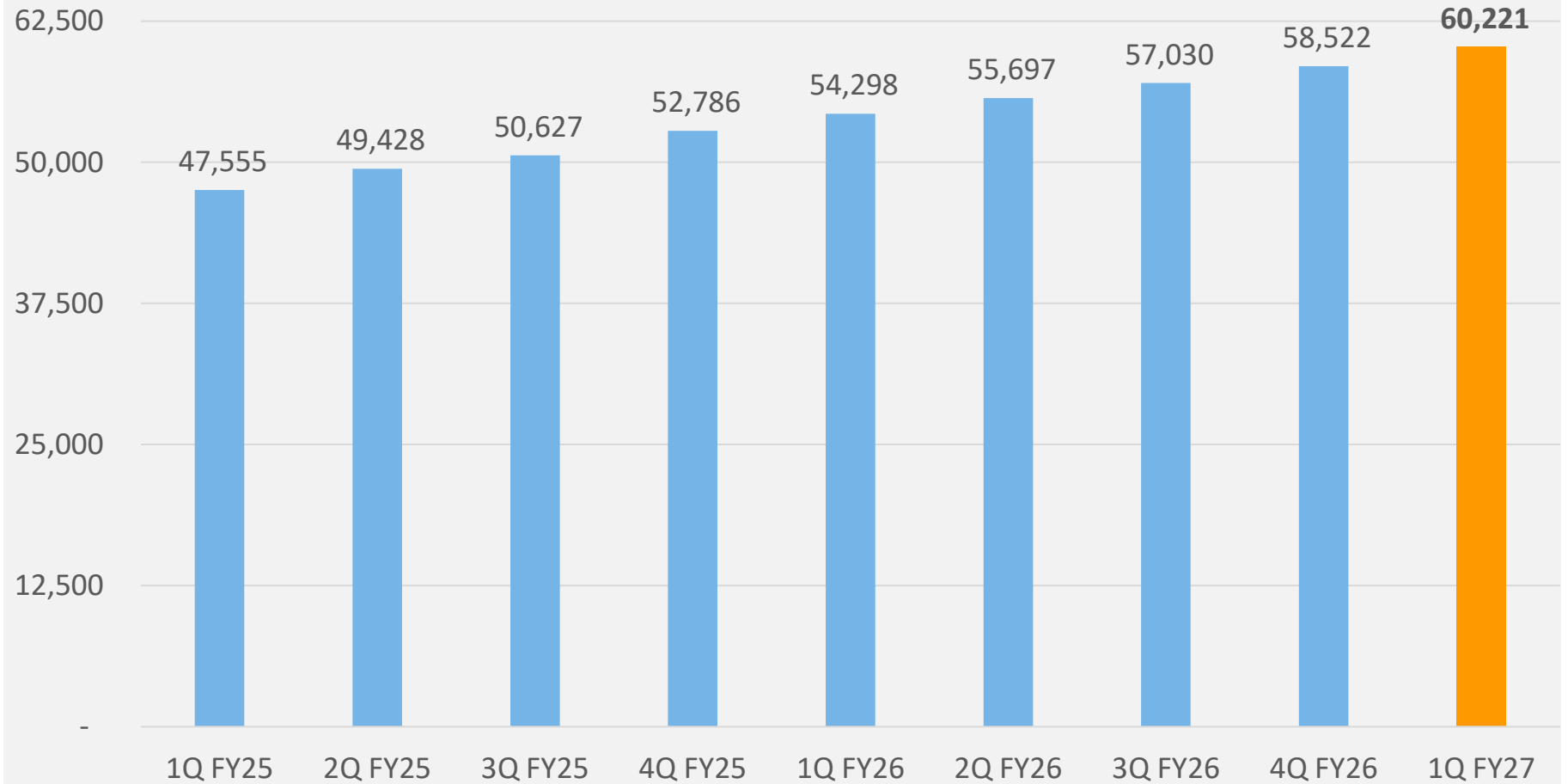

Active Paid Campaigns - period end



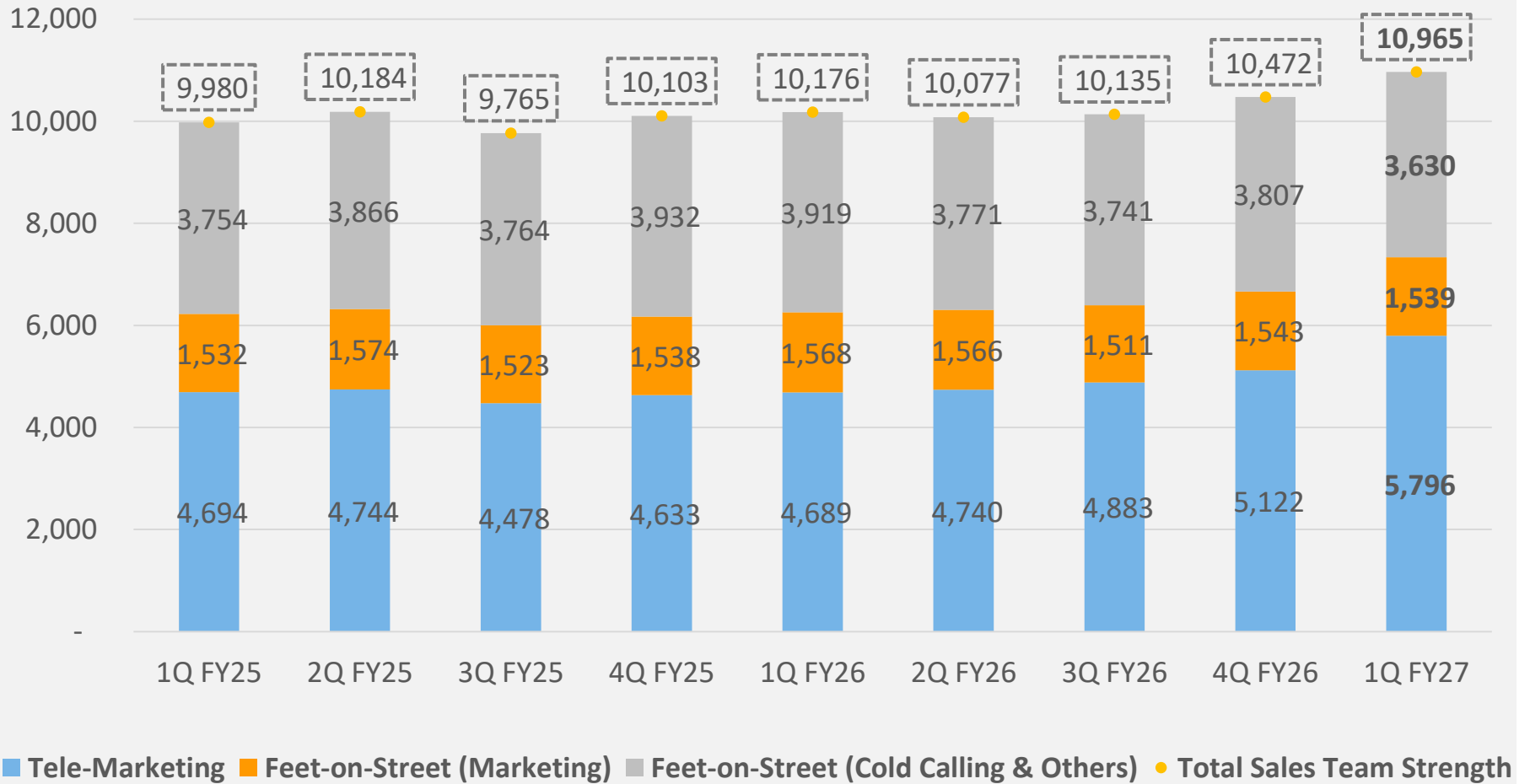

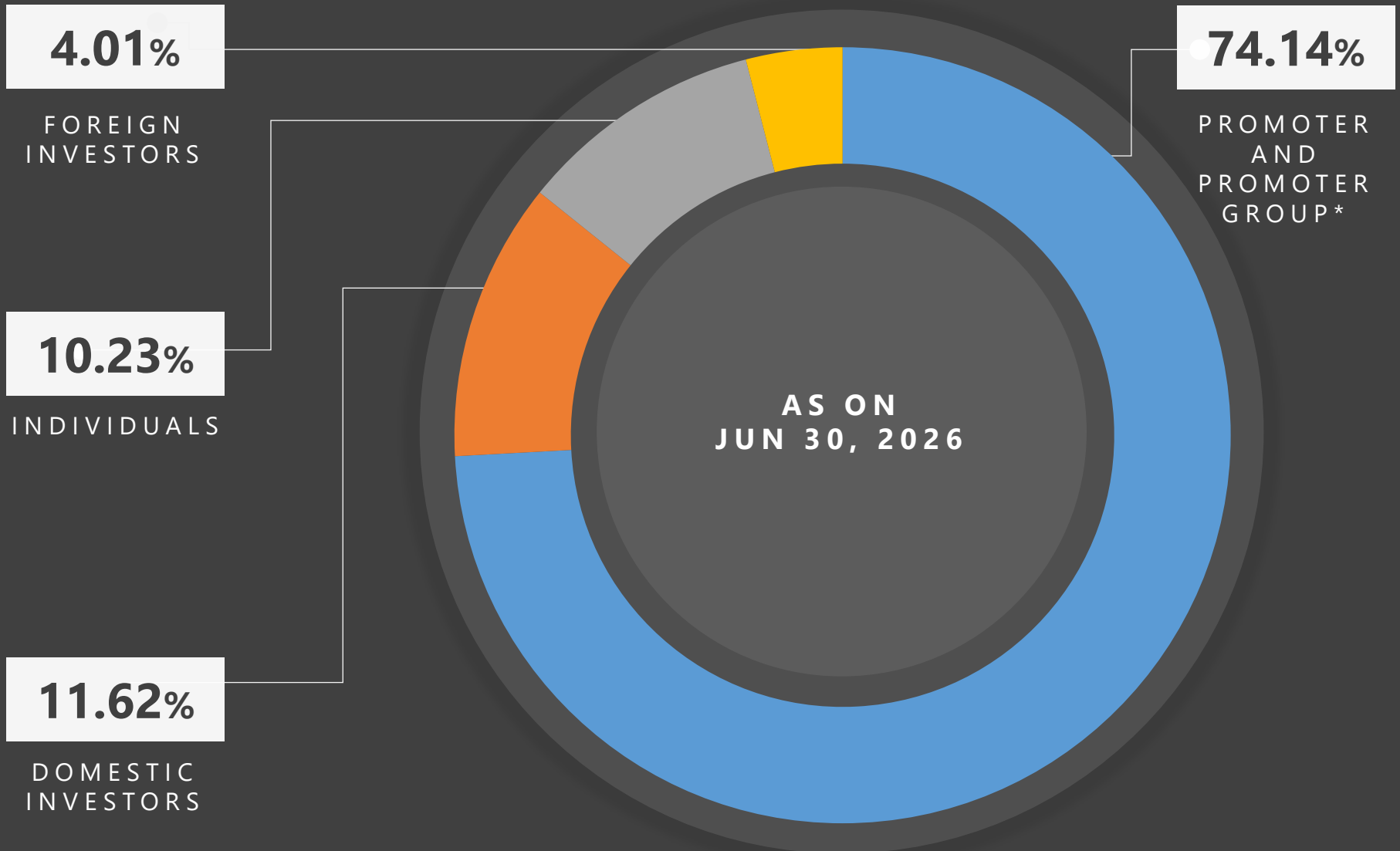
