3. Learned counsel for the petitioners submit that a patent illegality has been committed by the respondents and the ground on which the relief has been denied is primarily acquiescence.

It is submitted that such acquiescence cannot be a consideration in the facts and circumstances of the present case, which is similar to a matter already considered and decided by this Court in the case of *Arvind Kumar & Ors. Vs. State of Uttar Pradesh & Ors.*, and other connected cases, vide order dated 24.07.2026, especially paragraph 11 thereof.
