UPON hearing the counsel the Court made the following

O R D E R

1. Having heard learned senior counsel for the parties, we dispose of this petition observing that the

petitioners shall approach the competent authority of the Kolkata Municipal Corporation, including the concerned Appellate Tribunal, by moving fresh application for enlistment and change of user/ conversion. If, the issue of change of user/ conversion is already pending consideration before the concerned Appellate Tribunal of the Kolkata Municipal Corporation, the same shall be considered and disposed of in accordance with law.

2. Needles to say, since we are directing the concerned authorities to consider the petitioners' application in respect of enlistment and change of user/ conversion, the concerned authorities shall consider the same without being influenced by any of the observations made in the impugned order either way and, the competent authorities or the appellate authority/ tribunal, as the case may be, shall decide the proceedings within two months from today.
