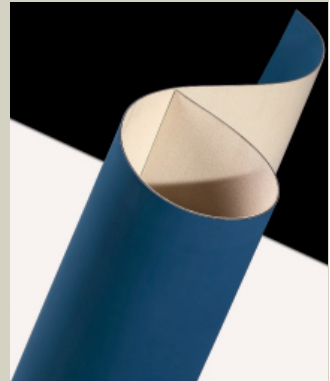
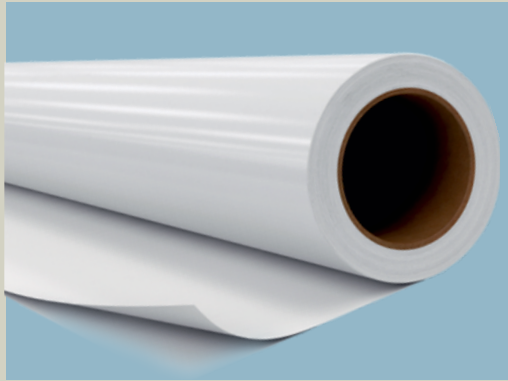

1. The explanatory statement pursuant to Section 102 of the Companies Act, 2013 ("the Act") read with Secretarial Standard-2 on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India ("ICSI") and Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") is annexed hereto and forms part of this Notice.
2. The Ministry of Corporate Affairs, Government of India ("MCA") vide General Circular Nos. 14/2020, 17/2020, 20/2020, 02/2021, 21/2021, 02/2022, 10/2022, 09/2023, 09/2024, 03/2025 dated April 8, 2020, April 13, 2020, May 5, 2020, January 13, 2021, December 14, 2021, May 5, 2022, December 28, 2022, September 25, 2023, and September 19, 2024, September 22, 2025, respectively (Collectively referred to as "the MCA Circulars") has allowed conducting Annual General Meeting ("AGM") through VC/OAVM, without the physical presence of the Members at a common venue, up to September 30, 2026, in accordance with the requirements provided in paragraphs 3 and 4 of MCA General Circular No. 20/2020. In compliance with the MCA Circulars, relevant SEBI Circulars, provisions of the Companies Act, 2013 ("Act") and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("the SEBI (LODR) Regulations, 2015"), In terms of the said circulars, the 35th Annual General Meeting ("AGM") of the Members will be held through VC/OAVM, which does not require the physical presence of the Members. The deemed venue for the AGM shall be the Registered Office of the Company.
3. Since this AGM is being held through VC/OAVM, the physical attendance of the Members has been dispensed with. Accordingly, the facility for appointment of the Proxies by the Members will not be available for the AGM and hence the Proxy Form, Attendance Slip and Route Map are not annexed to the Notice. However, a Body Corporate Member are entitled to appoint an Authorized Representatives to attend the AGM through VC/OAVM and participate thereat and cast their votes through e-voting. The Body Corporate Member intending to authorize its Representative to attend the AGM is requested to submit to the Company, a certified true copy of the Board Resolution/Authorization document, authorizing their Representative to attend and vote, on its behalf at the AGM.
4. The Register of Members and Transfer Book of the Company will remain closed from Friday, September 18, 2026 to Friday, September 25, 2026 (Both days inclusive) for the purpose of AGM.
5. The Company has engaged the services of MUFG Intime India Private Limited (formerly known as Link Intime India Private Limited), who is also a Registrar to an Issue and Share Transfer Agent ("MUFG/ RTA") of the Company, as the Authorized Agency for conducting the e-AGM, providing Remote E-Voting and E-voting facility for/during the AGM of the Company. The instruction for participation by the Members is given in the subsequent paragraphs.
6. The attendance of the Members attending the AGM through VC/OAVM will be counted for the purpose of reckoning the Quorum under Section 103 of the Act.
7. The Explanatory Statement setting out material facts, pursuant to Section 102 of the Act, Secretarial Standard - 2 on the General Meetings and Regulation 36 of the SEBI (LODR) Regulations, 2015, in respect of the Special Businesses mentioned at Item No. 4 to 7 of the Notice is annexed hereto.
8. In compliance with the MCA Circulars and the SEBI Circulars, the Notice of 35th AGM along with the Annual Report for the F.Y. 2025-26, is being sent only through electronic mode to those Members whose E-mail IDs are registered with the Company or National Securities Depository Limited ("NSDL")/Central Depository Services (India) Limited ("CDSL") (the "Depositories") or RTA of the Company. The Members may note that the Notice and the Annual Report for the F.Y. 2025-26 will also be available on the Company's website i.e. <https://mrtglobal.com/>; on the website of the BSE Limited ("BSE") and the National Stock Exchange of India Limited ("NSE") (collectively "Stock Exchanges") i.e. www.bseindia.com & www.nseindia.com, respectively and also on the website of MUFG/ RTA at <https://in.mpms.mufg.com/>. Since the AGM will be held through VC/ OAVM facility, hence the Route Map is not annexed in this Notice.

9. The Notice of the 35th AGM of the Company, inter alia, indicating the process and manner of e-voting is being sent to the Members, whose e-mail IDs are registered with the Company/Depositories/RTA, for communication purposes. In case the Shareholder's e-mail ID is already registered with the Company/Depositories/RTA, login details for E-voting shall be sent on the registered E-mail IDs.
10. In case the Shareholder holding Shares in physical mode has not registered his/her E-mail ID with the Company/Depositories/RTA, He/ She may do so by sending a duly signed request letter to MUFG by providing Folio No. and Name of Shareholder at MUFG Intime India Private Limited (Unit: Mahalaxmi Rubtech Limited), 5th Floor, 506-508, Amarnath Business Centre-I, (ABC-I), Beside Gala Business Centre, Nr. 11. In case the Shares held in demat mode, the Shareholder may contact the Depository Participant ("DP") and register the E-mail ID in the demat account as per the process followed and advised by the DP.
12. Brief resume of the Directors proposed to be appointed/re-appointed, nature of expertise in functional areas, names of the Companies in which he/she hold Directorship and Membership/Chairmanship of the Board Committees and the Shareholding and other details, are hereto furnished as stipulated under Regulation 36 of the SEBI (LODR) Regulations, 2015 and other requisite information as per Secretarial Standards – 2 on the General Meetings are provided along with the Notice.
13. The SEBI vide its Master Circular dated May 7, 2024, has mandated Listed Companies to issue securities in demat form only while processing any service requests viz. issue of Duplicate Securities Certificate; claim from Unclaimed Suspense Account; Renewal/Exchange of Securities Certificate; Endorsement; Sub-Division/Splitting of Securities Certificate; Consolidation of Securities Certificates/ Folios; Transmission and Transposition. In view of the same and to eliminate all risks associated with physical Shares and avail various benefits of dematerialisation, the Members are advised to dematerialise the Shares held by them in physical form.

Further, SEBI, vide its circular May 18, 2022, has simplified the procedure and standardised the format of documents for the transmission of securities. Accordingly, members are requested to make service requests by submitting a duly filled and signed Form ISR-4 & ISR-5, as the case may be, the formats of which are available on the website of MUFG/RTA at <https://in.mpms.mufg.com/>. Members are requested to note that any service request will only be processed after the folio is KYC Compliant. Members may note that, in terms of the SEBI Listing Regulations, equity shares of the Company can only be transferred in dematerialised form.
14. The Members are advised to avail the nomination facility in respect of Shares held by them pursuant to the provisions of Section 72 of the Act. The Members holding Shares in dematerialized mode are requested to intimate all changes pertaining to their bank details, power of attorney, change of address/name, Income Tax Permanent Account Number (PAN), etc. to their DP only. Members who have not yet registered their nomination are requested to register the same by submitting Form No. SH-13. The Members holding the Shares in physical mode are requested to intimate all above mentioned changes to MUFG or the Company as soon as the change occurs.
15. The Members holding Shares in physical form and wishing to avail of the nomination facility, are requested to send the duly filled in nomination in the prescribed Form SH-13 and for cancellation/variation in nomination in the prescribed Form SH-14 with the Company's RTA. In respect with Shares held in electronic/demat form, the nomination form may be filed with the respective DP. If a member desires to opt-out or cancel the earlier nomination and record a fresh nomination, he/ she may submit the same in Form No. ISR-3 or Form No. SH14, as the case may be. Changes intimated to the DP will be automatically reflected on the Company's record which will help the Company and its RTA to provide efficient & better services.
16. The SEBI, vide Circular No.: SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated 16th March, 2023, has made it mandatory to furnish PAN, nomination, contact details, bank account details and specimen signature, by holders of physical Securities.

Folios wherein any one of the said document/details are not available on or after 01st October, 2023, shall be frozen by the Company/ RTA. The Shareholders whose Folios have been frozen shall be eligible to lodge grievance or avail any service request from the RTA only after furnishing the complete documents/details as mentioned and for any payment including Dividend, interest or redemption payment only through electronic mode with effect from 01st April, 2024.

Further, the Shareholders holding Shares in physical mode were to link their PAN with Aadhaar number, by March 31, 2023, as extended by the Central Board of Direct Taxes (CBDT). Accordingly, from 01st April, 2023 or any other date as may be specified by the CBDT, the RTA shall accept only operative PAN i.e. linked with Aadhar number. The folios in which PANs are not linked with Aadhar numbers as on the notified cut-off date of March 31, 2023 or any other date as may be specified by the CBDT, shall be frozen.

Further, as per the above Circular of the SEBI, the frozen Folios shall be referred by the RTA/Company to the Administering Authority under the Benami Transactions (Prohibitions) Act, 1988 and/or Prevention of Money Laundering Act, 2002, if they continue to remain frozen as on 31st December, 2026. Keeping the above statutory requirements in view, the Members holding Shares in physical form are requested to furnish valid PAN, nomination, contact details, bank account details and specimen signature, immediately to the RTA/Company in the required forms, to ensure that, their Folios are not frozen on or after 01st October, 2023. The Company had sent communication letters on above to respective Shareholders for submission of required documents.



17. The Members seeking any information or clarification on the accounts are requested to send in written queries to the Company, atleast one week before the date of the AGM, replies will be provided in respect of such queries received in writing, only at the AGM.
18. MANAGEMENT DISCUSSION AND ANALYSIS

ECONOMIC OVERVIEW & OUTLOOK

GLOBAL ECONOMY:

The global economy continued to exhibit resilience during the year despite heightened geopolitical tensions and persistent trade uncertainties. According to the International Monetary Fund (IMF) – World Economic Outlook Update, July 2026, global GDP growth is projected at 3.0% in 2026, improving to 3.4% in 2027. While global growth remains below its historical average, technological advancements, particularly in artificial intelligence (AI), and continued investment have supported economic activity.

Growth performance remains uneven across regions, with emerging and developing economies continuing to outpace most advanced economies. Although global inflationary pressures have moderated, central banks remain cautious in their monetary policy approach amid lingering risks from geopolitical conflicts, trade fragmentation, elevated public debt, and volatile commodity prices. The IMF emphasizes that prudent macroeconomic policies, structural reforms, and international cooperation will be essential to sustain growth and strengthen global economic resilience. The global economy continues to demonstrate resilience despite persistent geopolitical tensions and trade uncertainties. Growth remains uneven across regions, with AI-driven investment supporting technology-intensive economies, while higher energy prices and geopolitical conflicts continue to weigh on energy-importing and vulnerable economies. Although financial conditions have eased, global disinflation has stalled, and inflationary pressures remain a key concern. Emerging and developing economies, particularly in Asia, are expected to remain the primary drivers of global growth, supported by resilient domestic demand and investment. Overall, the outlook remains cautiously positive, though downside risks from geopolitical conflicts, trade fragmentation, and financial market volatility persist. Within the broader textile sector, the technical textiles industry, the segment in which your Company operates, continued to record growth ahead of the sector as a whole. Technical textiles are engineered for functional performance rather than aesthetic appeal, and demand is therefore driven by industrial, infrastructure, healthcare, mobility and defense end-uses rather than by fashion or apparel cycles. The global technical textiles market was valued at approximately US\$247 billion in 2025 and is projected to reach approximately US\$325 billion by 2030, representing a compound annual growth rate of about 5.6%. The Asia-Pacific region accounts for approximately 47% of global consumption, led by China, India, Japan and South Korea. The global market for coated and laminated fabrics, the sub-segment most directly relevant to your Company, continued to expand on the substitution of conventional materials such as metal, rigid plastic and uncoated canvas with engineered polymer-coated substrates that are lighter, stronger, weather-resistant and longer-lasting. Demand for offset rubber printing blankets, the Company's other principal product line, is linked to the commercial and packaging printing industry, where growth in packaging, labelling and security printing has more than offset the structural decline in publication and newspaper printing. A printing blanket is a consumable, replaced on a defined wear cycle rather than a capital item, which lends this demand a recurring character comparatively insulated from the capital expenditure cycles of the printing industry.

INDIAN ECONOMY:

India remained one of the fastest-growing major economies during FY2025-26, supported by strong domestic demand, sustained infrastructure spending and improving manufacturing activity. Real GDP growth was estimated at 7.7%, driven by resilient consumption, healthy investment momentum and improving industrial output. Rising localisation initiatives, strong government focus on infrastructure development and improving supply chain resilience further supported economic activity during the year. India's technical textiles sector continued to strengthen during the year, supported by sustained policy focus, expanding domestic manufacturing capability and increasing substitution of imported specialty materials. Unlike conventional textiles, where India competes principally on scale and cost, the technical textiles segment competes on specification, qualification and consistency of performance — characteristics that favor established manufacturers with in-house testing capability and international accreditations. Domestic demand was underpinned during the year by infrastructure execution, defense procurement, healthcare expenditure and the continued expansion of organized packaging and logistics.

The Indian economy continued to benefit from stable monetary conditions and a resilient financial system. Retail CPI inflation remained within the RBI's tolerance band despite some recent moderation, while the Reserve Bank of India maintained the policy repo rate at 5.25%, supporting macroeconomic stability and sustained growth. Robust GST collections, healthy bank credit expansion, improving asset quality in the banking sector, and continued public and private capital expenditure provided a strong foundation for industrial activity and long-term economic growth. India remains the world's second-largest producer of textiles and garments and the sixth-largest exporter, accounting for 4.1% of global textile and apparel trade. Indian textile exports in FY 2025-26 were approximately 3.16 lakh crore, an increase of 2.1% over the previous year — a creditable outcome given that tariffs on Indian goods entering the United States, the single largest export market, rose to 50% with effect from August 27, 2025 before being reduced to approximately 18% under the interim trade understanding of February 2026. Within this, technical textiles remain among the fastest-growing export categories and a declared priority of national industrial policy. [Source: Ministry of Textiles, Annual Report 2025-26.]

TECHNICAL TEXTILES & RUBBER INDUSTRY: GLOBAL

Technical textiles are engineered textile materials manufactured primarily for their performance and functional properties rather than for aesthetic characteristics. Growth in these markets is driven by expanding applications across automotive and mobility, healthcare, construction and infrastructure, agriculture, industrial manufacturing, defence, aerospace, packaging, filtration and protective equipment. Rising infrastructure investment, substitution of conventional materials with lightweight high-strength alternatives, rapid urbanisation, growing healthcare expenditure and increasingly stringent safety and environmental regulation are together accelerating adoption. The continuing shift towards recyclable, biodegradable and smart textiles is creating further avenues for innovation and value addition. Of the twelve recognised categories of technical textiles, your Company's product range addresses Indutech (industrial fabrics and filtration), Buildtech (architectural and flexible membranes for civil structures), Mobiltech (transport, automotive, aeronautic and space applications), Protech (protective clothing), Meditech (healthcare and medical substrates), Packtech (tarpaulins, covers and liners), Geotech (geotextiles) and Sportech. Coated and laminated fabrics, which form the core of the Company's technical textiles offering, constitute one of the larger and faster-growing sub-segments, benefiting from the substitution of metal, rigid plastic and uncoated canvas across construction, transport, agriculture and storage applications. Non-wovens, geotextiles and medical textiles are also expanding rapidly, supported by infrastructure development, electric vehicle adoption, renewable energy projects and healthcare demand.

The Company's rubber products business is anchored in offset rubber printing blankets used in sheet-fed, web, metal decorating, packaging and security printing. Global demand in this line tracks the commercial and packaging printing industry, where growth in packaging, labelling and security printing — driven by e-commerce, organised retail, food safety regulation and anti-counterfeiting requirements — has more than offset the structural decline in publication and newspaper printing. Qualification of printing blankets by press manufacturers and printers is exacting and creates meaningful switching costs, which supports both customer retention and pricing. Taken together, technical textiles and rubber products are expected to remain among the fastest-growing segments of the global textiles sector, offering sustained long-term opportunity to manufacturers with established quality credentials, international accreditations and in-house research capability.

TECHNICAL TEXTILES & RUBBER INDUSTRY: INDIA

The Government of India continues to accord high priority to the technical textiles sector, which it has identified as a sunrise segment within the wider textile industry. The long-term policy vision is to establish India as a global hub for man-made fibre and technical textiles, in support of the objective of achieving US\$100 billion in textile exports by 2030. The Production Linked Incentive Scheme for Textiles, which covers MMF apparel, MMF fabrics and technical textiles, was made materially more accessible during the year: amendments notified in October 2025 halved minimum investment thresholds, reduced the incremental turnover requirement from 25% to 10% and added seventeen new HSN codes to the eligible product basket, improving participation particularly by mid-sized enterprises. Under Round III of the Scheme, 52 applications were approved in April 2026, of which 18 were in technical textiles — the largest single category — taking cumulative Round III approvals to 96 companies with committed investment of ₹ 12,822.67 crore by June 2026.

Infrastructure and innovation form the second pillar of policy. Under the PM MITRA (Mega Integrated Textile Region and Apparel) Park Scheme, seven integrated parks are being developed with an approved outlay of ₹ 4,445 crore, with progress recorded in land acquisition, infrastructure development and project implementation. The National Technical Textiles Mission continues to drive research, skilling and market development: as of FY 2025-26 the Mission has supported 168 research and development projects with approved funding of approximately ₹ 520 crore, backed 24 start-ups and assisted 45 educational institutions, including IITs and NITs, in developing specialised technical textile courses and research infrastructure. The Mission has also facilitated the notification of Quality Control Orders covering a wide range of finished technical textile products, raising quality standards and encouraging import substitution, while Quality Control Orders on inputs and machinery — including viscose staple fibre, polymer and fibre intermediates, textile machinery and cotton bales — were progressively withdrawn between November 2025 and June 2026, easing raw material and equipment sourcing for manufacturers.

Fiscal and trade measures provide further support. The Rebate of State and Central Taxes and Levies (RoSCTL) scheme has been extended up to September 30, 2026, sustaining export cost competitiveness; industry bodies continue to seek a longer-horizon extension to enable multi-year export planning. The rationalisation of Goods and Services Tax rates with effect from September 22, 2025 reduced the rate on man-made fibre from 18% to 5% and on MMF yarn from 12% to 5%, with fabric at a uniform 5%, correcting a

long-standing inverted duty structure that had blocked working capital across the man-made fibre value chain. On the trade front, the India-United Kingdom Comprehensive Economic and Trade Agreement entered into force on July 15, 2026, providing zero-duty access across 1,143 textile tariff lines and removing United Kingdom duties of up to 12%; the first consignments under the Agreement were flagged off from the Inland Container Depot at Sanand. The India-EFTA agreement came into force on October 1, 2025 and the India-European Union agreement was concluded on January 27, 2026, with implementation expected over the following year. Collectively, these measures are expected to accelerate investment, promote innovation, reduce import dependence in speciality technical textile materials and strengthen India's position as a leading global supplier of technical textiles.

BUSINESS OVERVIEW

The Company continues to sustain its overall performance in the Financial Year 2025-26 driven by the better performance in the business. The Technical Textiles and Rubber Division business has performed well and increase in revenue, as well as profit has been observed in the Company. Your Directors have been making efforts on all fronts viz. production, marketing, finance and cost control, etc. and these efforts have been yielding good results. The outlook for the Company's products appears to be good and the Company is confident of achieving improved operational performance.

In order to achieve the greatest level of customer satisfaction and excellent business relations, continuous infrastructure upgradations are made. There is a special focus on adopting sustainable business processes that add value for the stakeholders. Our dedicated team, with rich experience in the field of procuring superior quality of products.

Your Company reported at Standalone level, the total income of the Company is ₹ 11616.85 Lakhs as against ₹ 9508.41 Lakhs in the previous year. The Profit before Tax amounted to ₹ 2941.56 Lakhs as against ₹ 2192.75 Lakhs in the previous year. The net profit after tax amounted to ₹ 2178.19 Lakhs as against ₹ 1677.70 Lakhs in the previous year.

INDUSTRY STRUCTURE AND DEVELOPMENT:

Your Company operates mainly Polymer Based Technical Textile & Rubber Division, manufactures Offset Rubber Printing Blankets and a range of Technical Coated Fabrics. This division also includes Maheeka Textech" (A Weaving Unit). This division is manufacturing fabrics for Offset Rubber Printing Blankets used in Sheet Fed, Web, Metal Deco, Packaging, and Security Printing Applications. Maheeka Textech is a high-tech weaving unit that includes warping and sizing. This unit has automatic rapier looms and air jet looms for the weaving of various types of fabrics including Canvas and Filters. Maheeka Textech also has a facility for manufacturing speciality fabrics used for Technical Textiles products.

The Company manufactures various types of Technical Coated Fabrics. The fabric would be coated with Acrylics, PU, PVC Rubber, and other different polymers. The said Technical Coated Fabric would be used for various applications such as Tarpaulins, Awnings, Covers, Defense applications, Healthcare, Medical Substrates, Transport, Automotive, Aeronautic & Space, Architectural Membranes, Flexible Membranes for Civil Structures, Blinds, Protective Clothing, Home Furnishing, Geo Textiles, Industrial Fabrics, Sports, Environmental Pollution control, etc. The Company also manufactures Textile based Digital Print Media which are substrates for use in digital banners & signage printing. The product range would include Back-lite, Front-lite, Hoardings, Banners, Bio Gas Tanks and Water Tank Liners.

For a long time, your Company has been exporting its products to many countries, The Company operates across multiple products and businesses in diverse markets and environments. The Company is having a domestic market, as well as exports to various countries across the globe. The Company has a well-equipped laboratory, quality assurance team, and equipment to produce and offer its premium product line, with speciality character and performance, to match all kinds of National or International norms and standards. The Company regularly participates in Domestic and International exhibitions enabling it to keep abreast with the latest global trends.

STRENGTH AND WEAKNESS:

STRENGTH:

Technical textiles have seen an upward trend globally in the recent years due to improving economic conditions. Technological advancements, increase in end-use applications, cost-effectiveness, durability, user-friendliness and eco-friendliness of technical textiles has led to the upsurge of its demand in the global market. Indutech, Mobiltech, Packtech, Buildtech and Hometech together represent 2/3rd of the global market in value. The Ministry of Textiles under the Government of India has taken some significant steps to promote the Textile Industry and Technical Textile Industries in the Country. Fund Scheme and PLI Schemes aims at making available funds to the domestic textile industry for technology up-gradation and setting up of new units. This scheme aims to generate annual growth in volume terms in cloth production and in value terms in exports by increasing domestic value addition and technology depth and enhancing global competitiveness.

The Government of India and various State Governments continue to strengthen the textile and technical textile sector through focused policy support and investment incentives. Key initiatives such as the National Technical Textiles Mission (NTTM), the Production Linked Incentive (PLI) Scheme for Textiles and technology upgradation programmes are aimed at promoting domestic manufacturing, innovation, value addition, exports and employment. Under the Union Budget 2026-27, the Government reaffirmed

its commitment to the PLI Scheme for MMF apparel, fabrics and technical textiles, while continuing measures to enhance the sector's global competitiveness. In April 2026, the Government also approved 52 additional projects under Round III of the PLI Scheme, including 18 projects in the technical textiles segment, reflecting sustained investment in the industry.

Although India is one of the world's largest textile producers and exporters, the technical textile industry continues to depend significantly on imports for speciality fibres, high-performance yarns and other advanced raw materials. Domestic manufacturing is primarily concentrated in products such as industrial fabrics, canvas tarpaulins, woven sacks, carpet backing, awnings, canopies, blinds, shoelaces, soft luggage, zip fasteners, stuffed toys and other engineered textile applications. The sector's continued reliance on imported speciality fibres presents an opportunity to strengthen domestic manufacturing capabilities. Ongoing policy support, increased investments in research and development under the National Technical Textiles Mission, capacity expansion and technological advancements are expected to reduce import dependence, enhance the domestic value chain and accelerate the sustainable growth of India's technical textile industry.

WEAKNESSES

Technical textiles face key hurdles including high production costs, specialized machinery import dependencies, low consumer and end-user awareness, complex recycling challenges due to polymer blends, and a general lack of unified global standardisation.

Economic and Market Weaknesses

- High cost: Advanced materials and R&D make items expensive.
- Import reliance: Heavy dependence on foreign high-tech machinery.
- Low awareness: End-users often do not know how to use them properly.
- Niche market: Small demand volumes for specialized products limit mass production economies.

Environmental and Technical Constraints

- Hard to recycle: Complex polymer blends and chemical treatments resist standard recycling.
- Disposal issues: Non-biodegradable synthetics add to long-term waste.
- Standard gaps: Lack of clear regulations and testing standards across sectors.
- Skill shortage: Workers need high training to handle advanced manufacturing processes

OPPORTUNITIES AND THREATS:

OPPORTUNITIES:

- Healthcare and Hygiene Expansion: Surging demand for advanced Medtech items like antimicrobial surgical drapes, specialized wound care, and protective medical wear.
- Infrastructure and Geotextiles: Rising investments in civil engineering, road construction, and soil stabilization create heavy needs for Geotech and Buildtech materials.
- Smart Textiles and Nanotechnology: Embedding sensors, electronics, and nano-coatings into fabrics for defense, athletic performance, and health tracking.
- Automotive and Aerospace Lightweighting: Increasing EV manufacturing and stringent safety norms demand high-performance composites, airbags, and Mobiltech components.

THREATS:

- High Innovation and R&D Costs: Substantial capital barriers to entry for developing advanced synthetic polymers and next-generation smart fabrics.
- Shortage of Skilled Labour: A lack of workforce training in advanced techniques like melt spinning increases production times and limits scalability.
- Import Dependency: Continued reliance on other nations for specialized high-tech fibers and core raw materials in emerging domestic markets.
- Environmental and Compliance Pressures: Strict rules regarding chemical coatings, non-biodegradable synthetic waste, and sustainable disposal of nanomaterials.

OUTLOOK:

With a standout performance in Q4 of FY 2025-26, and reasonably good order book position, we hope to achieve stable growth in revenue for FY 2026-27, maintain or marginally improve the margins and enhancing Return on Capital Employed (ROCE). Despite the global economic headwinds, the Company remains confident in its strategic positioning, particularly in the Technical Textiles and Rubber Division, which has continued to perform well even amid macroeconomic volatility.

Financial Year 2025-26 remained a challenging and volatile period for businesses across most industries, with only a few sectors demonstrating resilience. The global business environment was significantly impacted by persistent geopolitical tensions, including

the Russia–Ukraine conflict and the escalating conflict involving the United States and Iran, which disrupted global supply chains and energy markets. These developments, coupled with volatility in crude oil prices, inflationary pressures, elevated logistics costs and continued uncertainty in international trade, posed significant challenges to business operations and profitability. Despite near-term uncertainties, we remain optimistic about the medium term and intend to continue investing in our growth engines. We are glad to inform that our Rubber/ Technical textile business has performed well.

Demand across the textile segment is expected to remain market-specific. While the domestic market is showing signs of recovery and is projected to improve steadily, volumes in the United States may see modest growth or remain flat. The European and UK markets are expected to remain muted in the near term. However, an improvement in export prospects could materialize if India is successful in concluding Free Trade Agreements (FTAs) with key global economies. Demand from South-East Asian countries is expected to strengthen, presenting opportunities for export-led growth.

The Technical Textile business is expected to grow at a steady and secular pace, closely aligned with India's GDP growth trajectory. With the gradual normalization of operations across the textile industry from the beginning of FY 2025–26, we remain very positive about the long-term potential of the technical textiles segment. This optimism is backed by increasing domestic demand, policy support from the Government of India, and strategic initiatives such as the Production-Linked Incentive (PLI) Scheme, PM MITRA Parks, and the National Technical Textiles Mission (NTTM)—all of which aim to transform India into a global hub for high-value technical textiles.

In the near term, the performance of the domestic market will be closely tied to macroeconomic revival, consumer sentiment, and capital investment cycles. On the export front, while challenges persist, we believe that improving global demand, particularly in South-East Asia, and better trade facilitation, can help offset some of the current constraints.

While volatility in global markets remains a concern, the Company has continued to strengthen its resilience through product innovation, diversification, and operational efficiency. Barring unforeseen circumstances, we are confident of achieving improved performance in FY 2025 and building a sustainable growth trajectory for our Technical Textiles.

KEY RISKS & CONCERNS

The Technical Textile industry is always subject to facing crisis in a cyclical way. Timely action is needed to overcome this situation by taking corrective and proactive steps, then and there.

The Technical Textile business, like other businesses, is susceptible to various risks. The primary risk factor is raw material prices, mainly cotton and the biggest component of cost. Cotton prices are increasing regularly as are other input costs including power, fuel and logistics. Since cotton is an agricultural produce, it suffers from climatic and seasonal volatility. Whereas such volatility in case of a product higher in the textile value chain is generally passed through an increase in value added products in the basket provides insulation against such volatilities.

The Company monitors price fluctuations and follows inventory management and responsive procurement policy to ensure timely procurement of raw materials at competitive prices. It also engages in contracts with clients and tries to pass on variations in the prices of raw materials to them to protect margins.

The ongoing Middle east Conflict has adversely impacted the global supply chain network. Since majority of the Company's business is exports-oriented and it depends on the supply chain for exporting final products, any kind of disruptions in the supply chain, ever-rising container shipping cost, availability and delays pose severe challenges for the business. Further, inadequate and inefficient logistics in India lead to delays and high costs of logistics.

The geopolitical turmoil, global economic slowdown, high inflation and the threat of a looming recession in key markets like the US and Europe have led to a slowdown in the domestic as well as export market. Demand compression would reduce the Company's business.

The Company is susceptible to disasters and crises such as pandemics, cyclones, earthquakes, geopolitical instability, fire hazards, etc. which may cause operational disruption, shutdown or production cuts, project delays, supply chain hurdles, and increased construction costs. Compliance issues with the environmental norms and regulations and supply chain challenges continue to be issues of concern.

INTERNAL CONTROL SYSTEM & ADEQUACY:

The Company has an adequate system of internal control implemented by the Management towards achieving efficiency in operations, optimum utilization of resources and effective monitoring thereof and compliance with applicable laws. The internal control is supplemented by an extensive programme of Internal Audits. The internal control framework has been developed in line with the provisions of the Companies Act, 2013 and the Guidance Note on Audit of Internal Financial Controls issued by the Institute of Chartered Accountants of India.

The Internal Audit programme is finalized in consultation with the Internal Auditors and the Audit Committee of the Board. The Audit Committee is briefed on the findings by the Internal Auditors, every quarter, along with the remedial actions that have been recommended or have been taken by the Management to plug systemic weaknesses. The audit committee of the Board meets

periodically to review various aspects of the performance of the Company and also review the adequacy and effectiveness of the internal control system and suggests improvement for strengthening then from time to time.

The Company maintains an efficient internal control system commensurate with the size, nature and complexity of its business. The internal control system is responsible for addressing the evolving risks in the business, reliability of financial information, timely reporting of operational and financial transactions, safeguarding of assets and stringent adherence to the applicable laws and regulations. The internal auditors of the Company are responsible for regular monitoring and review of these controls. The Audit Committee periodically reviews the audit reports and ensures correction of any variance, as may be required. Key observations are communicated to the management who undertakes prompt corrective actions.

FINANCIAL AND OPERATIONAL PERFORMANCE:

The financial performance during the year under review has growth in terms of sales and profit earned by the Company. Please refer to brief description of the Company's financial highlights during the year and State of Company's Affair in the Board of Directors Report.

During FY 2025-26 , the market remained exposed to intermittent bouts of volatility due to domestic developments as well as uncertainty surrounding the evolution of global financial markets which impacted the market sentiments and liquidity conditions significantly.

The Company also provides all employees with a social security. The Company provides retirement benefits as applicable.
- iii. In addition to the basic/fixed salary, benefits, perquisites and allowances as provided above, the Company may provide MD/Jt. MD such remuneration by way of commission, calculated with reference to the Net Profits of the Company in a particular F.Y., as may be determined by the Board, subject to the overall ceilings stipulated in Section 197 of the Companies Act, 2013 and the SEBI (LODR) Regulations, 2015. The specific amount payable to the MD/Jt. MD would be based on performance as evaluated by the Nomination and Remuneration Committee and approved by the Board.

Report on the audit of Financial Statements

Opinion

We have audited the accompanying Financial Statements of **MAHALAXMI RUBTECH LIMITED** ("the Company"), which comprise of the Balance Sheet as at March 31, 2026 and the statement of profit and loss (including Other Comprehensive Income), the Statement of Changes in Equity and the Statement of Cash Flows for the year then ended and a summary of significant accounting policies and other explanatory information (hereinafter referred to as "Financial Statements").

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid Financial Statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under section 133 of the Act read with the Companies (Indian Accounting Standards) Rules, 2015, as amended, ("Ind AS") and other accounting principles generally accepted in India, of the state of affairs of the Company as at 31 March 2026, and its profit, total comprehensive income, its cash flows and the changes in equity for the year ended on that date.

Basis for Opinion

We conducted our audit of the Financial Statements in accordance with the Standards on Auditing specified under section 143(10) of the Act (SAs). Our responsibilities under those Standards are further described in the Auditor's Responsibility for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India (ICAI) together with the ethical requirements that are relevant to our audit of the Financial Statements under the provisions of the Act and the Rules made thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ICAI's Code of Ethics. We believe that the audit evidence obtained by us is sufficient and appropriate to provide a basis for our audit opinion on the Financial Statements.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the Financial Statements of the current period. These matters were addressed in the context of our audit of the Financial Statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

We have determined the matters described below to be the key audit matters to be communicated in our report.

Key Audit Matters	How our audit addressed the key audit matter
Revenue recognition Company's revenue is derived primarily from sale of goods. Revenue from sale of goods is recognised when control of the products being sold is transferred to the customer and there are no longer any unfulfilled performance obligations. The performance obligations in the contracts are fulfilled at the time of dispatch, delivery or upon formal customer acceptance depending on customer terms. Inappropriate assessment could lead to risk of revenue being recognized before transfer of control. In view of the above and since revenue is a key performance indicator of the Company, we have identified timing of revenue recognition from sale of goods as a key audit matter.	In this regard, our audit procedures included: Assessing the appropriateness of the accounting policy for revenue recognition with relevant accounting standards; Evaluating the design and implementation of the Company's key internal financial controls in relation to timing of revenue recognition and tested the operating effectiveness of such controls for selected samples Performing detailed testing by selecting samples of revenue transactions recorded during the year and around the year end date using statistical sampling. We assessed fulfilment of performance obligations during the year by verifying the underlying documents. These documents included contract specifying terms of sale, invoices, goods dispatch notes, customer acceptances and shipping documents; Testing, on a sample basis using specified risk based criteria, journal entries affecting revenue recognised during the year to identify unusual items.
Valuation of Inventories The Company is a technical textile manufacturer and the inventory primarily comprises of yarn, grey fabric, rubber, chemicals and technical textile fabric and rubber printing blankets. Inventories are valued at lower of cost and net realisable value. The Company maintains its inventory levels based on forecast demand and expected future selling prices. There is a risk of inventories being measured at values which are not representative of the lower of costs and net realisable value ("NRV") The Company exercises high degree of judgment in assessing the NRV of the inventories on account of estimation of future market and economic conditions. The carrying value of inventories is material in the context of total assets of the Company. We identified the valuation of inventories as a key audit matter.	In this regard, our audit procedures included: Assessing the appropriateness of the accounting policy for inventories with relevant accounting standards; Evaluating the design and implementation of the Company's key internal financial controls over valuation of inventories and testing the operating effectiveness of such controls for selected samples; Observing the physical verification of inventory on a sample basis. In this regard, we have considered the physical condition of inventory by way of obsolescence or wear and tear, wherever relevant and applicable, in determining the valuation of such inventory. For NRV testing, selecting inventory items, on a sample basis at reporting date and compared their carrying value to their subsequent selling prices as indicated in sales invoices subsequent to the reporting date.

Information other than the Financial Statements and Auditor's report thereon

The Company's Board of Directors is responsible for the other information. The other information obtained at the date of this auditor's report is information included in the Directors' Report including the Annexures to the Directors' report, but does not include the Financial Statements and our auditor's report thereon.

Our opinion on the Financial Statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the Financial Statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the Financial Statements or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated.

If, based on the work we have performed on the other information that we obtained prior to the date of this auditor's report, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Management's Responsibility for the Financial Statements

The Company's Board of Directors is responsible for the matters stated in section 134(5) of the Act with respect to the preparation of these financial statements that give a true and fair view of the financial position, financial performance including other comprehensive income, cash flows and changes in equity of the Company in accordance with the Ind AS and other accounting principles generally accepted in India.

This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statement that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the Financial Statements, management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

However, the audit trail feature is not enabled for certain direct changes to data when using certain access rights and at the database level for the accounting software, as described in note 48 to the financial statements. Further, during the course of our audit we did not come across any instance of audit trail feature being tampered with in respect of the accounting software. Additionally, the audit trail has been preserved by the Company as per the statutory requirements for record retention.

44. Financial Risk Management

The principal financial assets of the Company include loans, trade and other receivables, and cash and bank balances that derive directly from its operations. The principal financial liabilities of the company, include loans and borrowings, trade and other payables and the main purpose of these financial liabilities is to finance the day to day operations of the company.

The Company is exposed to market risk, credit risk and liquidity risk. The Company's senior management oversees the management of these risks and that advises on financial risks and the appropriate financial risk governance framework for the Company.

This note explains the risks which the company is exposed to and policies and framework adopted by the company to manage these risks:

Market Risk

Market risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market prices. Market prices comprise three types of risk: foreign currency risk, interest rate risk, investment risk.

(i) Foreign currency risk

The company operates internationally and business is transacted in several currencies.

The export sales of company comprise 41.60% (PY 41.00%) of the total sales of the company, Further the company also imports certain assets and material from outside India. The exchange rate between the Indian rupee and foreign currencies has changed substantially in the future. Consequently the company is exposed to foreign currency risk and the results of the company may be affected as the rupee appreciates/ depreciates against foreign currencies. Foreign exchange risk arises from the future probable transactions and recognized assets and liabilities denominated in a currency other than company's functional currency.

The company measures the risk through a forecast of highly probable foreign currency cash flows and manages its foreign currency risk by appropriately hedging the transactions. The Company uses a derivative financial instruments such as foreign exchange forward contracts to mitigate the risk of changes in exchange rates on foreign currency exposures.

Credit Risk

Credit risk refers to the risk of default on its obligation by the counterparty resulting in a financial loss. The maximum exposure to the credit risk at the reporting date is primarily from trade receivables which are typically unsecured. Credit risk on cash and bank balances is limited as the company generally invests in deposits with banks and financial institutions with high credit ratings assigned by credit rating agencies. Investments primarily include investment in liquid mutual fund units, bonds, fixed maturity plan etc. issued by institutions having proven track record. The Company's credit risk in case of all other financial instruments is negligible.

The company assesses the credit risk for the overseas customers based on external credit ratings assigned by credit rating agencies. The company also assesses the creditworthiness of the customers internally to whom goods are sold on credit terms in the normal course of business. The credit limit of each customer is defined in accordance with this assessment. Outstanding customer receivables are regularly monitored and any shipments to overseas customers are generally covered by ECGC.

The impairment analysis is performed on client to client basis for the debtors that are past due at the end of each reporting date. The company has not considered an allowance for doubtful debts in case of trade receivables that are past due but there has not been a significant change in the credit quality and the amounts are still considered recoverable.

The maximum exposure to credit risk at the reporting date is the carrying value of trade receivables as disclosed at Note 7

Write off policy

The financial assets are written off, in case there is no reasonable expectation of recovering from the financial asset.

45 Capital Management

The capital includes issued equity capital, share premium and all other equity reserves attributable to the equity holders of the company. The primary objective of the company's capital management is to maintain optimum capital structure to reduce cost of capital and to maximize the shareholder value.

The company manages its capital structure and makes adjustments in light of changes in economic conditions and the requirements of the financial covenants which otherwise would permit the banks to immediately call loans and borrowings. In order to maintain or adjust the capital structure, the company may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares.

49 Notes Forming part of Financial Statements for year ended 31st March,2026

A General Information

Mahalaxmi Rubtech Limited (the "Company") is a listed public limited company domiciled in India and was incorporated on 25th September, 1991 under the provisions of the Companies Act, 1956 applicable in India. Its registered office is located at Mahalaxmi House, YSL Avenue, Opp.Ketav Petrol Pump, Polytechnic Road, Ambawadi, Ahmedabad-380015. The Company is primarily engaged in the business of manufacturing of traditional textile and technical textile products.

B Significant accounting policies

Significant accounting policies adopted by the company are as under:

(a) Basis of Preparation of Financial Statements

(i) Statement of Compliance with Ind AS

These financial statements have been prepared in accordance with Indian Accounting Standards (Ind AS) as notified by Ministry of Corporate Affairs pursuant to Section 133 of the Companies Act, 2013 (the "Act") read with the Companies (Indian Accounting Standards) Rules, 2015 as amended and other relevant provisions of the Act.

Accounting policies have been consistently applied to all the years presented except where a newly issued accounting standard is initially adopted or a revision to an existing accounting standard requires a change in the accounting policy hitherto in use.

(ii) Basis of measurement

The financial statements have been prepared on a historical cost convention on accrual basis, except certain financial assets and liabilities measured at fair value.

(iii) Current and non current classification

All assets and liabilities have been classified as current and non-current as per the Company's normal operating cycle and other criteria set out in Schedule III to the Act.

(b) Use of estimates

The preparation of financial statements in conformity with Ind AS requires the management to make estimate and assumptions that affect the reported amount of assets and liabilities as at the Balance Sheet date, reported amount of revenue and expenses for the year and disclosures of contingent liabilities as at the Balance Sheet date. The estimates and assumptions used in the accompanying financial statements are based upon the management's evaluation of the relevant facts and circumstances as at the date of the financial statements. Actual results could differ from these estimates. Estimates and underlying assumptions are reviewed on a periodic basis. Revisions to accounting estimates, if any, are recognized in the year in which the estimates are revised and in any future years affected.

(c) Property, plant and equipment

The Company had applied for the one time transition exemption of considering the carrying cost on the transition date i.e. 1st April, 2016 as the deemed cost under IND AS. Hence regarded thereafter as historical cost.

Property, plant and equipment are stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognized as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognized when replaced. All other repairs and maintenance are charged to Statement of Profit and Loss during the year in which they are incurred.

Advances paid towards the acquisition of property, plant and equipment outstanding at each balance sheet date is classified as capital advances under other non-current assets and the cost of assets not put to use before such date are disclosed under 'Capital work-in-progress'.

Depreciation methods, estimated useful lives

The Company depreciates property, plant and equipment over their estimated useful lives using the straight line method. The estimated useful lives of assets are taken as prescribed useful lives under Schedule II to the Companies Act, 2013. The management believes that such estimated useful lives are realistic and reflect fair approximation of the period over which the assets are likely to be used.

Depreciation on addition to property plant and equipment is provided on pro-rata basis from the date of acquisition. Depreciation on sale/deduction from property plant and equipment is provided up to the date preceding the date of sale, deduction as the case may be. Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in Statement of Profit and Loss under 'Other Income' or 'Other Expenses'.

(d) Investment properties

Investment properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at cost less accumulated depreciation and accumulated impairment loss, if any.

(e) Intangible Assets

Intangible assets are stated at acquisition cost, net of accumulated amortization.

(f) Investments in Associates

Investments in Associates are recognised at fair value.

(g) Borrowing cost

Borrowing costs directly attributable to the acquisition, construction or production of an asset that necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of the asset. All other borrowing costs are expensed in the period in which they occur. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds. Borrowing cost also includes exchange differences to the extent regarded as an adjustment to the borrowing costs.

(h) Foreign Currency Transactions**(a) Functional and presentation currency**

Items included in the financial statements are measured using the currency of the primary economic environment in which the entity operates ('the functional currency'). The financial statements are presented in Indian rupee (INR), which is the Company's functional and presentation currency.

(b) Transactions and balances

On initial recognition, all foreign currency transactions are recorded by applying to the foreign currency amount the exchange rate between the functional currency and the foreign currency at the date of the transaction. Gains/Losses arising out of fluctuation in foreign exchange rate between the transaction date and settlement date are recognised in the Statement of Profit and Loss.

All monetary assets and liabilities in foreign currencies are restated at the year end at the exchange rate prevailing at the year end and the exchange differences are recognised in the Statement of Profit and Loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions.

(i) Financial Instruments.
Fair value measurement

The Company has valued financial assets and Financial Liabilities, at fair value. Impact of fair value changes as on date of transition, is recognised in opening reserves and changes there after are recognised in Statement of Profit and Loss Account or Other Comprehensive Income, as the case may be.

The Company classifies its investments in mutual fund units as Fair Value Through Profit or Loss (FVTPL). Mutual fund units are initially recognized at fair value. Subsequently, they are measured at fair value, and all gains and losses arising from changes in fair value are recognized immediately in the Statement of Profit and Loss. The fair value of mutual fund investments is determined using the published Net Asset Value (NAV) declared by the respective mutual fund houses.

Financial Assets

The company classifies its financial assets as those to be measured subsequently at fair value (either through other comprehensive income or through Profit or loss) and those to be measured at amortised cost.

Financial liabilities
Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable to transaction costs.

(j) Revenue Recognition

The company derives revenues primarily from sale of manufactured goods, traded goods, job work and related services.

Revenue is recognised when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the entity and specific criteria have been met for each of the companys activities as described below:

Revenue towards satisfaction of a performance obligation is measured at the amount of transaction price (net of variable consideration) allocated to that performance obligation. The transaction price of goods sold and services rendered is net of variable consideration on account of various discounts and schemes offered by the company as part of the contract.

Sale of products:

Revenue from sale of products is recognised when significant risks and rewards in respect of ownership of products are transferred to customers based on the terms of sale. Revenue from sales is based on the price specified in the sales contracts, net of all discounts, returns and goods & service tax at the time of sale.

Interest Income

Interest Income is recognized using effective interest rate method

(k) Taxes

Tax expense for the year, comprising current tax and deferred tax, are included in the determination of the net profit or loss for the year.

(a) Current income tax

Current tax assets and liabilities are measured at the amount expected to be recovered or paid to the taxation authorities in accordance with the relevant prevailing tax laws. Tax expenses relating to the items in profit & loss

account shall be treated as current tax as part of profit and loss and those relating to items in other comprehensive income shall be recognised as part of OCI.

(b) Deferred tax

Deferred income tax is recognised for all the temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in financial statements. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the end of the year and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

At each balance sheet, the company re-assesses unrecognised deferred tax assets, if any, and the same is recognised to the extent it has become probable that future taxable profit will allow the deferred tax asset to be recovered. Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority.

(l) Assets classified as held for sale

The Company classifies non-current assets (or disposal group) as held for sale if their carrying amounts will be recovered principally through a sale rather than through continuing use.

Non-current assets (or disposal group) held for sale are measured at the lower of their carrying amount and the fair value less costs to sell. Assets and liabilities (or disposal group) classified as held for sale are presented separately in the balance sheet.

Property, plant and equipment and intangible assets once classified as held for sale are not depreciated or amortized.

(m) Leases

Leases in which a significant portion of the risks and rewards of ownership are not transferred to the Company as a lessee are shown as other non current assets. Payments made under operating leases (net of any incentives received from the lesser) are charged to Statement of Profit and Loss on a straight-line basis over the period of the lease.

(n) Inventories

Inventories are valued at the lower of cost and net realisable value.

Costs incurred in bringing each product to its present location and condition are accounted for as follows:

Raw materials, finished goods, semi finished goods, trading goods and stores and spare parts are valued at lower of cost and net realizable value. Cost includes purchase price, (excluding taxes those subsequently recoverable by the enterprise from the concerned revenue authorities), freight inwards and other expenditure incurred in bringing such inventories to their present location and condition. In determining the cost, FIFO method is used.

(o) Impairment of assets

The carrying value of assets / cash generating units at the Balance Sheet date are reviewed for impairment, if any indication of impairment exists. If the carrying amount of the assets exceed the estimated recoverable amount, an impairment is recognised for such excess amount. The impairment loss is recognised for such excess amount.

(p) Provisions and contingent liabilities

Provisions are recognized when there is a present obligation as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and there is a reliable estimate of the amount of the obligation. Provisions are measured at the best estimate of the expenditure required to settle the present obligation at the Balance sheet date. If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognized as a finance cost.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle or a reliable estimate of the amount cannot be made.

(q) Cash and cash equivalents

Cash and cash equivalent in the balance sheet comprise cash at banks, cash on hand and short-term deposits net of bank overdraft with an original maturity of three months or less, which are subject to an insignificant risk of changes in value.

For the purposes of the cash flow statement, cash and cash equivalents include cash on hand, cash in banks and short-term deposits net of bank overdraft.

(r) Financial instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

(I) Financial assets
(i) Initial recognition and measurement

At initial recognition, financial asset is measured at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at fair value through profit or loss are expensed in profit or loss.

(ii) Subsequent measurement

For purposes of subsequent measurement, financial assets are classified in following categories:

- a) at amortized cost; or
- b) at fair value through other comprehensive income; or
- c) at fair value through profit or loss.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

(iii) Impairment of financial assets

The company assesses on a forward looking basis the expected credit losses associated with its assets carried at amortised cost and FVTOCI debt instruments. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

(iv) Derecognition of financial assets

A financial asset is derecognized only when

- a) the rights to receive cash flows from the financial asset is transferred or
- b) retains the contractual rights to receive the cash flows of the financial asset, but assumes a contractual obligation to pay the cash flows to one or more recipients.

Where the financial asset is transferred then in that case financial asset is derecognized only if substantially all risks and rewards of ownership of the financial asset is transferred. Where the entity has not transferred substantially all risks and rewards of ownership of the financial asset, the financial asset is not derecognized.

(II) Financial liabilities
(i) Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss and at amortized cost, as appropriate.

(ii) Subsequent measurement

The measurement of financial liabilities depends on their classification, as described below:

Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss. Separated embedded derivatives are also classified as held for trading unless they are designated as effective hedging instruments. Gains or losses on liabilities held for trading are recognized in the Statement of Profit and Loss.

Loans and borrowings

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortized cost. Gains and losses are recognized in Statement of Profit and Loss when the liabilities are derecognized.

(iii) Derecognition

A financial liability is derecognized when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognized in the Statement of Profit and Loss as finance costs.

(s) Employee Benefits**(I) Short-term obligations**

Liabilities for wages and salaries, including non-monetary benefits that are expected to be settled wholly within 12 months after the end of the year in which the employees render the related service are recognized in respect of employees' services up to the end of the year and are measured at the amounts expected to be paid when the liabilities are settled.

(II) Other long-term employee benefit obligations**(i) Defined contribution plan**

Provident Fund: Contribution towards provident fund is made to the regulatory authorities, where the Company has no further obligations, apart from the contributions made on a monthly basis which are charged to the Statement of Profit and Loss.

Employee's State Insurance Scheme: Contribution towards employees' state insurance scheme is made to the regulatory authorities, where the Company has no further obligations apart from the contributions made on a monthly basis which are charged to the Statement of Profit and Loss.

(ii) Defined benefit plans

Gratuity: The Company provides for gratuity, a defined benefit plan (the 'Gratuity Plan') covering eligible employees in accordance with the Payment of Gratuity Act, 1972. The Gratuity Plan provides a lump sum payment to vested employees at retirement, death, incapacitation or termination of employment, of an amount based on the respective employee's salary. The Company's liability is actuarially at the end of each year. Actuarial losses/gains are recognized in the other comprehensive income in the year in which they arise.

(t) Earnings Per Share

Basic earnings per share is calculated by dividing the net profit or loss for the year attributable to equity shareholders by the weighted average number of equity shares outstanding during the year. Earnings considered in ascertaining the Company's earnings per share is the net profit or loss for the year after deducting preference dividends and any attributable tax thereto for the year, if any. The weighted average number of equity shares outstanding during the year and for all the years presented is adjusted for events, such as bonus shares, other than the conversion of potential equity shares, that have changed the number of equity shares outstanding, without a corresponding change in resources.

For the purpose of calculating diluted earnings per share, the net profit or loss for the year attributable to equity shareholders and the weighted average number of shares outstanding during the year is adjusted for the effects of all dilutive potential equity shares.

(u) Research & Development

Expenditure on research and development is recognised as an expense when it is incurred. Expenditure which results in increase in property, plant and equipment are capitalised and depreciated in accordance with the policies stated for property, plant & equipment.

(v) Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the company will comply with all the attached conditions. All government grants are initially recognised by way of setting up as deferred income. Government grants relating to income are recognised in the profit & loss account. Government grants relating to purchase of property, plant & equipment are subsequently recognised in profit & loss on a systematic basis over the expected life of the related depreciable assets. Grants recognised in Profit & Loss as above are presented within other income.

(w) Inter divisional transactions

Inter divisional transactions are eliminated as contra items. Any unrealised profits on unsold stocks on account of inter divisional transactions is eliminated while valuing the inventory.

(x) Significant accounting judgments, estimates and assumptions

The preparation of financial statements requires management to make judgments, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in future years.

Estimates and assumptions

The key assumptions concerning the future and other key sources of estimation uncertainty at the year end date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below. The Company based its assumptions and estimates on parameters available when the financial statements were prepared. Existing circumstances and assumptions about future developments, however, may change due to market changes or circumstances arising that are beyond the control of the Company. Such changes are reflected in the assumptions when they occur.

(i) Taxes

Significant assumptions and judgements are involved in determining the provision for tax based on tax enactments, relevant judicial pronouncements including an estimation of the likely outcome of any open tax assessments/ litigations. Deferred income tax assets are recognised to the extent that it is probable that future taxable income will be available, based on estimates thereof.

(ii) Defined benefit plans (gratuity benefits and leave encashment)

The cost of the defined benefit plans such as gratuity and leave encashment are determined using actuarial valuations. An actuarial valuation involves making various assumptions that may differ from actual developments in the future. These include the determination of the discount rate, future salary increases and mortality rates. Due to the complexities involved in the valuation and its long-term nature, a defined benefit obligation is highly sensitive to changes in these assumptions. All assumptions are reviewed at each year end.
