He had contributed to India's initiative for collaboration and partnership with various countries to launch the International Solar Alliance (ISA) platform in the year 2015 when he was the Director in the Climate change division of the Ministry of Environment, Forest and Climate Change in Government of India.

In the international negotiations in the conference of parties held under the United Nations Conference on Climate Change (UNFCCC) he had represented India's negotiating team. He was a member of the standing committee on Finance of the UNFCCC in 2016.
