Dear Sir,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we hereby inform that a fire incident occurred during the intervening night of 23rd/24th May, 2026 at the Company's unit located at Nahar Complex, Village Jalalpur, Post Office Dappar, Ambala Chandigarh Highway, Lalru Dist. Mohali, Punjab.

The incident occurred in the godown area designated for the storage of raw cotton bales, which serve as raw material for the manufacturing process. The reason of the fire is yet to be ascertained. The fire was promptly brought under control with the coordinated efforts of the local Fire Department, the Company's internal emergency response team and in-house firefighting systems. No loss of life or personal injury has been reported.

The affected godown and the stock stored therein are adequately insured and the concerned insurance company has been duly intimated. The insurance survey will be initiated shortly. The Company is currently in the process of assessing the extent of loss and damage caused by the incident.
