UPON hearing the counsel the Court made the following
O R D E R

1. On 23.07.2026, this Court has allowed the petitioner to effect service of this Special Leave Petitions on the

unserved respondents through paper publication. Learned Counsel for the petitioner submits that the petitioner has taken steps and moved the Registry for compliance of the order, however, since the names of the newspapers were not specified in this Court's order, the Registry was unable to hand over a copy of the notice to the petitioner for publication.

2. Considering the above, we direct that service of notice on the unserved respondents, in terms of our order dated 23.07.2026, be effected by publication in: Dainik Bhaskar (Jaipur Edition) and Times of India (Jaipur Edition). Steps for service through publication be made as per rules.

3. It is informed that the following respondents have expired: respondent Nos.3, 5, 10, and 12 in SLP (C) No.10175 of 2018, respondent Nos.1, 5, 9, 11, 12, 17, and 18 in SLP (C) No.10176 of 2018 and respondent No.3 in SLP (C) No.10177 of 2018.

4. The paper publication to be issued by the petitioner for service of notice on the unserved respondents shall also mention the names of the above-mentioned deceased respondents, as an intimation to their legal representatives (LRs) that if they desire to participate in the proceedings before this Court in these Special Leave Petitions, they may move an application for impleadment, which shall be considered on its own merits.

5. Let the publication be made and proof of publication

be filed within six weeks from today.
