The Company has received an Order bearing Reference No. ZD090626165636U dated June 18th 2026, whereby an aggregate penalty of ₹30,65,591.26 has been imposed, comprising CGST penalty of ₹15,32,795.63 and SGST penalty of ₹15,32,795.63, in connection with the alleged suppression of turnover for the tax period from April 2019 to March 2020
