The review report of the other auditor on the financial statements of the subsidiary prepared in accordance with the US GAAP for the quarter ended June 30, 2026, expressed an unmodified conclusion on those financial statements. Adjustments to the said financial information of the subsidiary for the differences in accounting principles adopted by the Company in accordance with Ind AS have been reviewed by us as stated in our report on the Special Purpose Statement of Unaudited Standalone Ind AS Financial Results of the said subsidiary for the quarter ended June 30, 2026.
