ORDER

1. The instant Transfer Application has been filed seeking the following reliefs:

“a. Allow the present application and list the company petition C.P. NO. 131/ND/2023, along with all pending applications, for final disposal on the date fixed before the bench comprised of Shri. Manni Sankariah Shanmuga Sundaram, Hon'ble Member (Judicial) and Shri Atul Chaturvedi, Hon'ble Member (Technical), which has already heard the present matter and reserved the order in the connected petition, C.P. NO. 70/ND/2023,

b. Pass such further order(s) as may be passed and/or direction (s) be given as this Hon'ble Tribunal may deem fit and proper.”

2. This Transfer Application is for listing CP No. 131/ND/2023 along with all pending applications before the Special Bench comprising Shri. Manni Sankariah Shanmuga Sundaram, Hon'ble Member (Judicial) and Shri Atul Chaturvedi, Hon'ble Member (Technical). Ld. Sr. Counsel for the Applicant submits that a similar petition bearing CP No. 70/ND/2023 had been heard by the aforementioned Special Bench. He submits that the CP No. 131/ND/2023 had also been heard by the Special Bench on a few occasions and therefore, this matter be heard and decided by the Special Bench.
3. It is further submitted that CP No. 70/ND/2023 has been heard by a Special Bench till 07.04.2026 and thereafter it was listed for hearing on 19.05.2026 but due to paucity of time, the case was adjourned to 14.07.2026. The petition bearing no. CP No. 70/ND/2023 is before a Regular Bench, but as the Special Bench has heard that matter at some length, both these petitions bearing no. CP No. 131/ND/2023 & CP No. 70/ND/2023 be listed before the Special Bench. Ld. Counsel for the Respondent submits that he has no objection if both the petitions are listed before the aforementioned Special Bench, but he denies the unwarranted allegations in the application.

4. At this juncture, Ld. Sr. Counsel Mr. P. Nagesh for the Applicant submits that no allegations have been levelled and in any case this application is for the transfer of the case simpliciter.
5. Ld. Counsel for the Petitioner and Ld. Counsel for the Respondent submit that, besides them, there are no other parties in CP No. 131/ND/2023 & CP No. 70/ND/2023.
6. In view of the above and with the consent of the counsel for the parties, I deem it appropriate to list CP No. 131/ND/2023 & CP No. 70/ND/2023 before the Special Bench comprising Shri. Manni Sankariah Shanmuga Sundaram, Hon'ble Member (Judicial) and Shri Atul Chaturvedi, Hon'ble Member (Technical).
7. **The TA (Co. Act)- 13(PB)/2026 is allowed and stands disposed of accordingly.**
