1. To receive, consider and adopt:

- a. the Audited Standalone Financial Statements of the Company consisting of the Balance Sheet as at March 31, 2026, the Statement of Profit and Loss, Cash Flow Statement and Statement of Changes in Equity for the year ended on that date and the Explanatory Notes annexed to, and forming part of, any of the said documents together with the reports of the Board of Directors and the Auditors report thereon; to consider and if thought fit, to pass, the following resolution as an **Ordinary Resolution**:

"RESOLVED THAT the audited Consolidated financial statements of the Company consisting of the Balance Sheet as at March 31, 2026, the Statement of Profit and Loss, Cash Flow Statement and Statement of Changes in Equity for the year ended on that date and the Explanatory Notes annexed to, and forming part of, any of the said documents together with the Auditors report, as circulated to the Members, be and are hereby considered and adopted."

2. To re-appoint Mr. Devendra Sharma as a Director, liable to retire by rotation

To consider and if thought fit, to pass the following resolution as a Ordinary Resolution:

"RESOLVED THAT in accordance with the provisions of Section 152 and other applicable provisions of the Companies Act, 2013, Mr. Devendra Sharma (DIN: 00921174), who retires by rotation and being eligible offers himself for re-appointment, be and is hereby re-appointed as a Director of the Company (designated as Managing Director), liable to retire by rotation."



Special Business:

3. Reappointment of Mrs. Aruna Doshi (DIN: 00949220) as the 'Whole-time Director' of the Company

To consider and if thought fit, to pass the following resolution as a Special Resolution:

"RESOLVED THAT pursuant to the provisions of Sections 196, 197, 198, 203 read with Schedule V and other applicable provisions of the Companies Act, 2013 (hereinafter referred to as "the Act") and Rules framed thereunder and applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (hereinafter referred to as "SEBI Listing Regulations"), including any statutory modification(s) or re-enactment(s) thereof, and subject to such approvals as may be necessary, the consent of the Members be and is hereby accorded for the re-appointment of Mrs. Aruna Doshi (DIN: 00949220), who has attained the age of 71 years as the 'Whole-time Director' of the Company for a further period of 3 (Three) years with effect from April 01, 2027, on the terms and conditions including terms of remuneration as specified in the Agreement dated August 14, 2026 executed between the Company and Mrs. Aruna Doshi.

1. In accordance with the provisions of the Act, read with the Rules made thereunder and General Circular No. 3/2025 dated 22nd September 2025, other Circulars issued by the Ministry of Corporate Affairs ("MCA") from time to time, and Circular No. SEBI/HO/CFD/CFDPoD-2/P/ CIR/2024/133 dated October 3, 2024 issued by the Securities and Exchange Board of India ("SEBI") ("the Circulars"), companies are allowed to hold Annual General Meeting ("AGM") through Video Conference ("VC") till further order, without the physical presence of the Members at a common venue. 3. In accordance with the Secretarial Standard-2 on General Meetings issued by The Institute of Company Secretaries of India (ICSI) read with Clarification/Guidance on applicability of Secretarial Standards-1 and 2 dated April 15, 2020 issued by the ICSI, the proceedings of the AGM shall be deemed to be conducted at the Registered Office of the Company i.e. 59, Moti Magri Scheme, Udaipur -313001, Rajasthan which shall be the venue of the AGM. Since the AGM will be held through VC, the Route Map for the Venue of the Meeting is not annexed in this Notice.
4. Generally, a member entitled to attend and vote at the AGM is entitled to appoint a proxy to attend and vote on his/her behalf and the proxy need not be a member of the Company. Since this AGM is being held pursuant to the MCA Circulars through VC, physical attendance of members has been dispensed with. Accordingly, the facility for appointment of proxies by the members under Section 105 of the Act will not be available for the AGM and hence the Proxy Form and Attendance Slip are not annexed to this Notice.
5. All documents referred to in the AGM Notice will be available electronically for inspection by the members, from the date of circulation of this Notice upto the date of AGM, i.e. Wednesday, September 30, 2026. 6. The Members can join the AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available to at least 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee, Stakeholders Relationship Committee and Auditors etc. who are allowed to attend the AGM without restriction on account of first come first served basis.

e-voting, shall be able to exercise their right to vote through e-voting at the AGM. The Members who have cast their vote by remote e-voting prior to the AGM may also join the AGM through VC but shall not be entitled to cast their vote again.

10. Members who hold shares in dematerialised form and want to provide/change/correct the bank account details should send the same immediately to their concerned Depository Participant(s) and not to the Company. Item No. 3

To consider and approve the Re-appointment of Smt. Aruna Doshi (DIN: 00949220) as Whole Time Director:

Mrs. Aruna Doshi is associated with the Company since 2018 and on the recommendation of the Nomination & Remuneration Committee was appointed as Whole Time Director by the Board of Directors of the Company at their meeting held on May 26, 2021 and by the members of the Company at their AGM held on September 30, 2021. Her re-appointment for a further period of three years was approved by the Board on 02 September effective from April 01, 2024 upto March 31, 2027 and by the Members at their meeting held on September 29, 2023.

The Board of Directors at their meeting held on August 14, 2026 approved re-appointment of Mrs. Aruna Doshi for a further period of three years effective from April 01, 2027 subject to the approval of the Members at this Annual General Meeting.

Ms. Doshi has attained the age of 71 years. In terms of Section 196(3) of the Companies Act, 2013, no company shall continue the employment of any person as a whole-time director who has attained the age of seventy years unless such appointment is approved by the members by way of a **special resolution**, in which case the explanatory statement annexed to the notice for such motion must indicate the justification for appointing such person.

Justification for the re-appointment: Considering her rich and diverse experience in strategic and corporate planning, risk management, leadership, and corporate governance, and her significant and continuing contribution to strengthening the Company's policy framework and operational efficiency over the years, the Board of Directors is of the view that her continued association as Whole Time Director is in the best interest of the Company. Accordingly, the Board recommends her re-appointment for approval of the Members by way of a Special Resolution.

In view of her extensive experience and valuable contribution towards improving the Company's operational performance, and upon the recommendation of the Nomination and Remuneration Committee ('NRC') and the Board of Directors, it is proposed to the members that Mrs. Aruna Doshi be re-appointed as Whole Time Director of Rajdarshan Industries Limited for a further term of three (3) years.

Smt. Aruna Doshi satisfies all the conditions set out in Part-I of Schedule V to the Act, as also the conditions set out under sub-section (3) of Section 196 of the Act, for being eligible for her re-appointment. She is not debarred from being re-appointed pursuant to any order of SEBI or any other authority, and is not disqualified from being appointed as a Director in terms of Section 164 of the Act.

The re-appointment of Mrs. Aruna Doshi and the remuneration payable is subject to approval by the Company's shareholders, as per the relevant provisions of the Companies Act, 2013, and SEBI (Listing Obligations and Disclosure Requirements) Regulations.

The material terms of re-appointment and remuneration as contained in the agreement are given below:-

1. **Tenure of re-appointment:** Three (3) years commencing from April 01, 2027
2. The period of office of Mrs. Aruna Doshi shall be liable to determination by retirement of directors by rotation.

- (iii) **Perquisites & Allowance:** In addition to salary and bonus, the following perquisites shall be paid, which are as follows:
 - **Medical/Personal Accident Insurance:** Premium not to exceed Rs.50000/- per annum.
 - **Reimbursement of Medical Expenses:** Equal to one month Salary
 - **Company's Contribution towards Provident Fund Superannuation Fund:** Company's Contribution towards Provident Fund and Superannuation Fund will be as per the rules of the Company.
 - **Gratuity:** Gratuity will be payable as per Rules of the company.

 - Provision for Telephone at residence (including payment of local call and long distance call)

She possesses strong management, leadership and strategic decision-making skills, and her continued association with the Company is considered valuable and aligned with its organizational requirements and future growth objectives.

- (vi) **Comparative remuneration profile with respect to industry, size of the company, profile of the position and person**
The proposed remuneration of Smt. Aruna Doshi is commensurate with her role, responsibilities, experience and contribution to the Company and is in line with the remuneration levels prevailing in the industry for similar positions. The proposed remuneration is also within the limits prescribed under the applicable provisions of the Companies Act, 2013, including Schedule V, and is considered appropriate having regard to the size, operations and financial position of the Company.
- (vii) **Pecuniary relationship directly or indirectly with the company or relationship with the managerial personnel, if any:**
Apart from the remuneration proposed to be paid to her, Smt. Aruna Doshi holds 12,46,123 equity shares in the Company. Further, Mr. Madhav Doshi, Non-Executive Director of the Company, is the son of Smt. Aruna Doshi. Except as stated above, there is no other pecuniary relationship of Smt. Aruna Doshi with the Company or its managerial personnel.

III. Other Information

- i) **Reasons of loss or inadequate profits**
The Company is primarily engaged in the trading of quartz raw material, and its performance is closely linked to global demand-supply dynamics and pricing trends in this commodity. During the year under review, the Company's trading operations were adversely affected by a challenging global trade environment, including elevated freight and logistics costs, geopolitical tensions, rising international interest rates, and tighter tariff structures in key markets. Continued volatility in foreign exchange rates against the US Dollar also impacted order realizations and margins on export/import trade transactions.
These factors collectively resulted in a decline in revenue from operations to Rs. 97.24 Lakhs from Rs. 209.93 Lakhs in the previous year, and the Company reported a net loss after tax of Rs. 17.31 Lakhs (Standalone) for the year, as against a net profit of Rs. 23.45 Lakhs in the previous year.
- ii) **Steps taken or proposed to be taken for improvement**
The Company is actively working to diversify its supplier and customer base to reduce dependence on any single geography or source, thereby mitigating supply-side and pricing



risks. Management is also focused on improving procurement efficiency, negotiating better terms with suppliers and logistics partners, and controlling overhead costs. Efforts are underway to strengthen relationships with existing buyers and identify new markets to rebuild trading volumes.

iii) Expected increase in productivity and profits in measurable terms etc

The Company expects that stabilization of global trade conditions, improved availability of quartz raw material at competitive prices, and the cost-optimization measures being implemented should support a gradual improvement in trading volumes and margins going forward. Given the inherent uncertainty in global commodity trade and currency movements, the Company is not in a position to provide specific measurable projections at this stage, but remains focused on improving profitability in the ensuing financial year(s).

Item No. 4

The Company, in the ordinary course of its business, proposes to enter into and/or continue various related party transactions with its subsidiaries, associate companies and group companies. He is actively involved in mentoring the leadership team, guiding them in various aspects of operations, business development and long-term planning. His continued association as Managing Director is highly desirable and considered to be in the best interest of the Company, as he brings with him extensive experience, proven leadership skills, and strategic vision. 2. Performance for the Financial Year 2025-26:

The company's performance during Financial Year 2025-26 on a standalone and consolidated basis were as follows -

On standalone basis

During the Financial year 2025-2026 at Standalone level revenue from operations stood at Rs. 97.24 Lakhs against Rs.209.93 Lakhs in the previous year. Your company recorded decline in revenue from operations by 53.68% over the previous year. The Operating Profit before tax stood at Rs. 4.20 Lakhs against profit of Rs. 17.90 Lakhs reported in the previous year. The company incurred a loss after tax 17.31 Lakh for the current year as against Profit of Rs. 23.45 Lakhs in the previous year.



On Consolidated Basis

The consolidated revenue from operations stood at Rs. 97.24 Lakhs against Rs. 209.93 Lakhs in the previous year recorded decline in revenue from operations 53.68%. The Operating profit before tax stood at Rs. 3.86 Lakhs against Profit of Rs. 17.94 Lakhs reported in the previous year. The company incurred a loss after tax 17.31 Lakh for the current year as against Profit of Rs. 23.49 Lakhs in the previous year.

3. Share Capital

The paid-up equity share capital of the company as at March 31, 2026 stood at Rs. 3,10,83,000/– (Rupees Three Crore Ten Lakh Eighty Three Thousand Only) divided into 31,08,300 (Thirty One Lakh eight Thousand three hundred) equity shares of Rs. 10/– (Rupees Ten) each.

During the year under review, the Company has neither issued any shares with differential voting rights nor granted any stock options or sweat equity or warrants.

As on March 31, 2026, none of the Directors of the Company hold instruments convertible into equity shares of the Company.

4. Dividend and Reserves

Company has not recommended any dividend during the year under review, nor transferred any amount to General Reserve.

5. Change in the Nature of Business

There was no change in nature of business of the company during the year under review.

6. Management Discussion and Analysis Report

The Management Discussion and Analysis forms an integral part of this Report and covers, amongst other matters, the performance of the Company during the financial year under review as well as the future prospects.

The Company has received notice u/s 160 of the Companies Act, 2013 from a shareholder proposing the candidature of Mrs. Aruna Doshi for directorship.

b. **Resignations**

Further, SEBI vide its Circular dated January 30, 2026 has extended the said facility for a further period of one year from February 5, 2026 to February 4, 2027. Members who have not availed the earlier opportunity are requested to avail the extended timeline and submit their requests along with requisite documents to the Company's Registrar and Share Transfer Agent.

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

INDUSTRY STRUCTURE AND DEVELOPMENTS

The Company's business primarily comprises trading in Quartz Grit, Powder and related consumables, along with other raw material trading activities, supported by an investment portfolio. India continues to be among the leading global producers and exporters of quartz, with Rajasthan remaining the largest quartz-producing state in the country. Demand for quartz-based products continues to be driven by the construction, ceramics, foundry and glass industries, and, increasingly, by electronics and solar applications that require high-purity quartz.

FY 2025-26 was a challenging year for the Company's trading operations, with revenue from operations at Rs. 57.38 lakh as against Rs. 157.28 lakh in the previous year, reflecting lower trading volumes during the year. The Company continues to closely track demand trends across its key end-user segments and remains focused on rebuilding volumes in the year ahead.

Looking forward, the Company remains committed to exploring new avenues of growth, including diversification of product offerings and entry into select markets, while remaining mindful of evolving global trade dynamics affecting the wider quartz industry. With a sound financial base and a clear strategic roadmap, the Company will continue to focus on rebuilding trading volumes and creating long-term value for its stakeholders.

DISCUSSION ON FINANCIAL PERFORMANCE

This aspect is dealt with in detail in the Directors' Report.

THREATS AND OPPORTUNITIES

FY 2025-26 was a year of subdued trading activity for the Company, with lower volumes in its raw material trading segment as compared to the previous year. The Company's ability to leverage its supply chain relationships and long-standing client base remains a key strength as it works towards rebuilding volumes in the coming year.

The Quartz segment of the broader industry continued to see growing domestic demand, with rising adoption of quartz-based products in housing, commercial and interior applications. During the year, the imposition of steep US safeguard tariffs (up to 50%) on engineered quartz surface products from India emerged as a significant headwind for the export-oriented, value-added segment of the Indian quartz industry, particularly manufacturers of finished quartz slabs and surfaces concentrated in Gujarat, Rajasthan and Telangana. While the Company's own business is centred on the domestic Quartz Grit, Powder and raw material trading segments rather than finished export-oriented products, a slowdown in the export-linked segment of the value chain could have an indirect moderating effect on overall demand within the Rajasthan quartz-processing ecosystem, and the Company continues to monitor this development closely.

The Company's investment portfolio, while providing a stable base of other income through interest and dividends, remains exposed to market-linked fair value fluctuations, as reflected in the unrealised diminution recognised through Other Comprehensive Income during the year. The Company continues to review its investment strategy with a view to balancing risk and return.

Looking ahead, the Company remains focused on rebuilding trading volumes, exploring value-added product offerings, and evaluating new markets. With a debt-free balance sheet and an agile approach, the Company is confident of capitalizing on opportunities such as continued domestic construction and infrastructure activity and the growing use of high-purity quartz in electronics and solar applications, while remaining watchful of near-term headwinds affecting the broader industry.



INTERNAL CONTROL SYSTEMS

The Company strongly believes that robust Internal Control Systems form the backbone of good Corporate Governance, ensuring that managerial freedom is exercised within a framework of well-defined checks and balances.

The Company has in place a sound and adequate internal control system designed to safeguard its assets, ensure their optimal utilization, and maintain the accuracy and reliability of financial reporting. These systems are further strengthened by periodic internal audits carried out by an independent Chartered Accountant, which provide an objective assessment of the Company's internal processes and compliance framework.

The Audit Committee and the Board of Directors review the adequacy and effectiveness of the internal control systems at regular intervals. The Audit Committee, in particular, plays a pivotal role in monitoring internal control mechanisms, risk management practices, and financial disclosures, thereby providing assurance to the Board of Directors and stakeholders on the integrity of the Company's operations.

HUMAN RESOURCES

Effective Human Resource Management is integral to enabling employees to contribute meaningfully towards the Company's growth and the achievement of its organizational goals. During the year under review, there were no major developments on the human resources front. The Company continues to operate as a close-knit team, managed by its Directors along with a small group of dedicated employees who efficiently handle the day-to-day operations.

Looking ahead, the Company remains confident that its focused approach to Human Resource Management will continue to nurture a cohesive and productive workforce, thereby supporting organizational objectives and sustaining a competitive edge in the industry.

As stipulated by the Code of Independent Directors under the Companies Act, 2013 and in compliance with Regulation 25 (3) of the Listing Regulations and Schedule IV of the Act, the Independent Directors met separately on May 03, 2025 during the Financial Year 2025-26.

At the said meeting, the Independent Directors:

- i. Reviewed the performance of Non-Independent Directors and the Board as a whole;
- ii. Reviewed the performance of the Chairman of the Company, taking into account the views of executive directors and non-executive directors;
- iii. Assessed the quality, quantity and timeliness of flow of information between the Company management and the Board that is necessary for the Board to effectively and reasonably perform their duties.

2.6 Evaluation of the Board's Performance

The Board had adopted a formal mechanism for evaluating its performance and as well as that of its Committees and individual Directors, including the Chairman of the Board. The exercise was carried out through a structured evaluation process covering various aspects of the Board's functioning such as composition of the Board & Committees, experience & competencies, performance of specific duties & obligations, governance issues etc. All evaluations were carried out through structured questionnaires designed specifically for evaluation of the Board/ Committees/ Individual Directors.

Separate exercise was carried out to evaluate the performance of individual Directors including the Board Chairman who were evaluated on parameters such as attendance, contribution at the meetings and otherwise, independent judgment, safeguarding of minority shareholders interest, etc.

The performance evaluation criteria for Independent Directors along with the evaluation framework is determined by the Nomination and Remuneration Committee, basis on which the performance of the Independent Directors is evaluated.

3. Committees of the Board

The Board of Directors have constituted Board Committees to deal with specific areas and activities which concern the Company and requires a closer review. The Board Committees are formed with approval of the Board and function within their respective Charters. These Committees play a pivotal role in the overall Management of day-to-day affairs and governance of the Company.

The committees meet at regular intervals and take necessary steps to perform its duties entrusted by the Board. Each Committee is mandated to operate within a well-defined Charter which is re-visited by the Board periodically. The minutes of the meetings of all Committees are placed before the Board for review and noting.

The Company currently has three Board Level Committees:

- 3.1) Audit Committee,
- 3.2) Nomination and Remuneration Committee,
- 3.3) Stakeholders' Relationship Committee, and

Details of the role and composition of these Committees, including the number of meetings held during the financial year and attendance at meetings, are provided below:



3.1 Audit Committee

a. Term of Reference:

The terms of reference of Audit Committee are completely aligned with the terms laid down in the Companies Act, 2013 and amended Regulation 18 read with Schedule II Part C of the Listing Regulations.

The brief description of the terms of reference of the Audit Committee are as follows:

- i) Overseeing the Company's financial reporting process and disclosure of financial information to ensure that the financial statements are correct, sufficient and credible;
- ii) Review with the management, performance of statutory and internal auditors and review of adequacy of the internal control systems;
- iii) Reviewing and examining with management the quarterly and annual financial results before submission to the Board;
- iv) Recommending the appointment, remuneration and terms of appointment of Statutory Auditors / Internal Auditor of the Company;
- v) Reviewing the adequacy of internal audit function and discussing with Internal Audit or any significant finding and reviewing the progress of corrective actions on such issues;
- vi) Reviewing, approving or subsequently modifying any Related Party Transactions in accordance with the Related Party Transaction Policy of the Company;
- vii) Scrutiny of inter-corporate loans and investments made by the Company;
- viii) evaluating internal financial controls and risk management systems;
- ix) Review the functioning of the Whistle-blower Mechanism; and reviewing the information required as per SEBI Listing Regulation.
- x) Review compliance with the provisions of SEBI (Prohibition of Insider Trading) Regulations, 2015 with reference to events which were regarded as UPSI (Unpublished Price Sensitive Information), whether such UPSI were shared in the manner expected, instances of leaks, if any, instance of breaches of the Code, efficiency of sensitization process, etc. at least once in a financial year and shall verify that the systems for internal control are adequate and are operating effectively.

In fulfilling the above role, the Audit Committee has powers to investigate any activity within its terms of reference, to seek information from employees and to obtain out side legal and professional advice.

b. Composition

Audit Committee of the Board of Directors ("the Audit Committee") is entrusted with the responsibility to supervise the Company's financial reporting process and internal controls. The composition, quorum, powers, role and scope are in accordance with Section 177 of the Act and the provisions of Regulation 18 of the Listing Regulations. All members of the Audit Committee are financially literate and bring in expertise in the fields of Finance, Taxation. It functions in accordance with its charter that defines its authority, responsibility and reporting function.

The Audit Committee comprised of 3(Three) members. Mr. Roshan Lal Nagar, an Independent, non-executive Director, is the chairman of the Audit Committee. Ms. Swati Yadav, Independent, nonexecutive director and Mrs. Aruna Doshi, executive director are members of Audit Committee.

The company secretary act as the secretary to the committee.



c. Meetings and Attendance Record

During the year under review, the Audit Committee met Four times on May 29, 2025, August 14, 2025, November 13, 2025 and February 13, 2026. The requisite quorum was present at all the Meetings.

6.8. Share Transfer System

NOTES forming part of the financial statements for the year ended March 31, 2026

NOTE 1 COMPANY OVERVIEW

Rajdarshan Industries Limited (the Company) is a public limited Company incorporated in 1980 under Companies Act 1956 and listed on Bombay Stock Exchange (BSE) and National Stock Exchange (NSE). The Company is engaged in trading of quarts and minerals.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

2.1 Basis of preparation

The accounts have been prepared in accordance with the provisions of Companies Act 2013 and Indian Accounting Standards (Ind AS) and Disclosures thereon comply with requirements of Ind AS, stipulations contained in Schedule- III (revised) as applicable under Section 133 of the Companies Act, 2013 read with, Companies (Indian Accounting Standards) Rules 2015 as amended from time to time, MSMED Act, 2006, other pronouncement of ICAI, provisions of the Companies Act and Rules and guidelines issued by SEBI as applicable.

“The Ministry of Corporate Affairs (MCA) has notified the Companies (Accounting Standards) Amendment Rules, 2016 vide its notification dated 30 March 2016. The said notification read with Rule 3(2) of the Companies Accounting Standards) Rules, 2006 is applicable to accounting period commencing on or after the date of notification i.e. 1 April 2016”

All the assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in Schedule III to the Companies Act, 2013. Based on the nature of products and the time between the acquisition of assets for processing and their realization in cash and cash equivalent, the Company has ascertained its operating cycle to be 12 months for the purpose of current – non-current classification of assets and liabilities.

2.2 System of accounting

- 1) The Company follows the mercantile system of accounting and recognises income and expenditure on an accrual basis except in case of significant uncertainties.
- 2) Financial Statements are prepared under the Historical cost convention. These costs are not adjusted to reflect the impact of changing value in the purchasing power of money.
- 3) Estimates and Assumptions used in the preparation of the financial statements and disclosures are based upon management's evaluation of the relevant facts and circumstances as of the date of the financial statements, which may differ from the actual results at a subsequent date.

2.3 Use of Estimates

The Ind AS enjoins management to make certain estimates and assumptions that affect the amounts reported in the financial statements and notes thereto. Differences between actual results and estimates are recognized in the period in which the results are known/materialize.

2.4 Property, Plants and Equipments, Depreciation/Amortization

A. Property, Plants and Equipments

- i) The Property, Plants and Equipments are held for use in production, supply of goods or services or for administrative purposes. They are stated at their original cost net of tax/duty, credits availed, if any, including incidental expenditure related to acquisition and installation less accumulated depreciation. Cost represents all expenses directly



attributable to bringing the asset to its working condition capable of operating in the manner intended and includes borrowing cost capitalized in accordance with the Company's Accounting Policy.

B. Depreciation

Depreciation is provided on straight line method other than on freehold land and properties under construction less their residual values over their useful lives specified in Schedule II to the Companies Act 2013. The estimated useful life and residual values are also reviewed at each financial year end and the effect of any change in the estimates of useful life/residual value is accounted on prospective basis. There is no deviation in useful life as specified in Schedule II to the Companies Act 2013.

Depreciation on fixed assets has been calculated on pro-rata basis with reference to the month in which the assets are put to use.

2.5 Investment property

Properties, including those under construction, held to earn rentals and/or capital appreciation are classified as investment property and measured and reported at cost, including transaction costs.

2.6 Financial instruments

Financial assets and liabilities are recognised when the Group becomes a party to the contractual provisions of the instrument. Financial assets and liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value measured on initial recognition of financial asset or financial liability.

Cash and cash equivalents

The Group considers all highly liquid financial instruments, which are readily convertible into known amounts of cash that are subject to an insignificant risk of change in value and having original maturities of three months or less from the date of purchase, to be cash equivalents. Cash and cash equivalents consist of balances with banks which are unrestricted for withdrawal and usage.

Financial assets at amortized cost

Financial assets are subsequently measured at amortized cost if these financial assets are held within a business whose objective is to hold these assets in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets at fair value through other comprehensive income

Financial assets are measured at fair value through other comprehensive income if these financial assets are held within a business whose objective is achieved by both collecting contractual cash flows on specified dates that are solely payments of principal and interest on the principal amount outstanding and selling financial assets.

Financial assets at fair value through profit or loss

Financial assets are measured at fair value through profit or loss unless they are measured at amortized cost or at fair value through other comprehensive income on initial recognition. The transaction costs directly attributable to the acquisition of financial assets and liabilities at fair value through profit or loss are immediately recognized in statement of profit and loss.

Financial liabilities

Financial liabilities are recognized when the Company becomes a party to the contractual provisions of the instrument. Financial liabilities are initially measured at the amortized cost unless at initial recognition, they are classified as fair value through profit and loss.

Financial liabilities are subsequently measured at amortized cost using the EIR method. Financial liabilities carried at fair value through profit or loss are measured at fair value with all changes in fair value recognized in the Statement of Profit and Loss.

Equity instruments



An equity instrument is a contract that evidences residual interest in the assets of the company after deducting all of its liabilities. Equity instruments recognised by the Group are recognised at the proceeds received net of direct issue cost.

2.7 Cash and Bank Balances

Cash and bank balances also include fixed deposits, margin money deposits, earmarked balances with banks and other bank balances which are unrestricted for withdrawal and usage. Short term and liquid investments being subject to more than insignificant risk of change in value, are not included as part of cash and cash equivalents.

2.8 Revenue Recognition

a) Sales

- i) Sales of goods are recognized on dispatch and in accordance with the terms and conditions of the sale. Sale includes indirect taxes. Domestic sales are accounted for on dispatch from the point of sale corresponding to transfer of significant risks and rewards of ownership to the buyer.
- ii) Contract & Machinery Hire Charges are recognized on accrual basis.

b) Other Income

The Company recognizes income on accrual basis. However, where the ultimate collection of the same lacks reasonable certainty, revenue recognition is postponed to the extent of uncertainty.

2.9 Impairment of Assets

At the end of each accounting year the carrying amount of property, plant and equipment intangible assets and financial assets is reviewed for impairment. Impairment, if any, is recognized where the carrying amount exceeds the recoverable amounts being the higher of net realizable price and value in use. An impairment loss is charged to Statement of Profit and loss in the year in which an asset is identified as impaired. The impairment loss recognized in prior accounting periods is reversed if there has been a change in the estimate of recoverable amount.

2.10 Taxes on Income

Income tax expense for the year comprises of current tax and deferred tax. Current tax provision has been determined on the basis of relief, deductions etc. available under the Income Tax Act 1961 and Deferred tax is provided using balance sheet approach on temporary differences at the reporting date as difference between the tax base and the carrying amount of assets and liabilities. Deferred tax is recognized subject to the probability that taxable profit will be available against which the temporary differences can be reversed.

2.11 Foreign Currency Transactions

- 1) Foreign currency transactions are recorded at the exchange rate prevailing on the date of the transaction.
- 2) Monetary items denominated in foreign currencies (such as cash, receivables, payables etc.) outstanding at the year end, are translated at exchange rates applicable on year end date.
- 3) Non-monetary items denominated in foreign currency, (such as plant and equipment) are valued at the exchange rate prevailing on the date of transaction and carried at cost.
- 4) Any gains or losses arising due to exchange differences arising on translation or settlement are accounted for in the Statement of Profit and Loss.

2.12 Provision, Contingent Liabilities and Contingent Assets

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. Provisions are measured at the best estimate of the expenditure required to settle the present obligation at the Balance Sheet date.

Contingent liabilities are disclosed when there is a present obligation arising from past events, the



existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made.

2.13 Employee Benefits

(a) Short term Employee benefits:

All employee benefits falling due wholly within two months of rendering the services are classified as short-term employee benefits. The benefits like salaries, wages, and short term compensated absences etc. and the expected cost of bonus; ex-gratia is recognized in the period in which the employee renders the related service.

(b) Post employment benefits:

(i) Defined Contribution Plan

The Company has Defined Contribution plan for post employment benefit namely Provident Fund, which is recognised by the income tax authorities and administered through appropriate authorities.

The Company contributes to a Government administered Provident Fund and has no further obligation beyond making its contribution.

(ii) Defined Benefit Plans

(c) Leave encashment

Based on the leave rules of the company, employees are not permitted to accumulate leave.

(d) Termination benefits are recognized as an expense as and when incurred.

2.14 Earnings Per Share

The earnings considered in ascertaining the Company's Earnings per share ('EPS') comprise the Net Income. The number of shares used in computing the Basic EPS is the weighted average number of shares outstanding during the year. The diluted EPS is calculated on the same basis as Basic EPS.

2.15 Discontinued Operations

Assets and Liabilities of discontinued operations are assessed at each Balance Sheet date. Impacts of any impairments and write backs are dealt with in the Statement of Profit and Loss.

Impacts of discontinued operations are distinguished from the ongoing operations of the Company, so that their impact on the Statement of Profit and Loss for the year can be perceived.

Opinion

NOTE 1 COMPANY OVERVIEW

Rajdarshan Industries Limited (the Company) is a public limited Company and listed on Bombay Stock Exchange (BSE) and National Stock Exchange (NSE). The Company is engaged in trading of quarts and minerals.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

2.1 Basis of preparation

The accounts have been prepared in accordance with the provisions of Companies Act 2013 and Indian Accounting Standards (Ind AS) and Disclosures thereon comply with requirements of Ind AS, stipulations contained in Schedule- III (revised) as applicable under Section 133 of the Companies Act, 2013 read with, Companies (Indian Accounting Standards) Rules 2015 as amended from time to time, MSMED Act, 2006, other pronouncement of ICAI, provisions of the Companies Act and Rules and guidelines issued by SEBI as applicable.

“The Ministry of Corporate Affairs (MCA) has notified the Companies (Accounting Standards) Amendment Rules, 2016 vide its notification dated 30 March 2016. The said notification read with Rule 3(2) of the Companies Accounting Standards) Rules, 2006 is applicable to accounting period commencing on or after the date of notification i.e. 1 April 2016”

All the assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in Schedule III to the Companies Act, 2013. Based on the nature of products and the time between the acquisition of assets for processing and their realization in cash and cash equivalent, the Company has ascertained its operating cycle to be 12 months for the purpose of current – non-current classification of assets and liabilities.

2.2 System of accounting

- 1) The Company follows the mercantile system of accounting and recognises income and expenditure on an accrual basis except in case of significant uncertainties.
- 2) Financial Statements are prepared under the Historical cost convention. These costs are not adjusted to reflect the impact of changing value in the purchasing power of money.
- 3) Estimates and Assumptions used in the preparation of the financial statements and disclosures are based upon management's evaluation of the relevant facts and circumstances as of the date of the financial statements, which may differ from the actual results at a subsequent date.

2.3 Use of Estimates

The Ind AS enjoins management to make certain estimates and assumptions that affect the amounts reported in the financial statements and notes thereto. Differences between actual results and estimates are recognized in the period in which the results are known/materialize.

2.4 Property, Plants and Equipments, Depreciation/Amortization

A. Property, Plants and Equipments

- i) The Property, Plants and Equipments are held for use in production, supply of goods or services or for administrative purposes. They are stated at their original cost net of tax/duty, credits availed, if any, including incidental expenditure related to acquisition and installation less accumulated depreciation. Cost represents all expenses directly attributable to bringing the asset to its working condition capable of operating in the manner intended and includes borrowing cost capitalized in accordance with the Company's Accounting Policy.

B. Depreciation

Depreciation is provided on straight line method other than on freehold land and properties under construction less their residual values over their useful lives specified in Schedule II to the Companies Act 2013. The estimated useful life and residual values are also reviewed at

each financial year end and the effect of any change in the estimates of useful life/residual value is accounted on prospective basis. There is no deviation in useful life as specified in Schedule II to the Companies Act 2013.

Depreciation on fixed assets has been calculated on pro-rata basis with reference to the month in which the assets are put to use.

2.5 Investment property

Properties, including those under construction, held to earn rentals and/or capital appreciation are classified as investment property and measured and reported at cost, including transaction costs.

2.6 Financial instruments

Financial assets and liabilities are recognised when the Group becomes a party to the contractual provisions of the instrument. Financial assets and liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value measured on initial recognition of financial asset or financial liability.

Cash and cash equivalents

The Group considers all highly liquid financial instruments, which are readily convertible into known amounts of cash that are subject to an insignificant risk of change in value and having original maturities of three months or less from the date of purchase, to be cash equivalents. Cash and cash equivalents consist of balances with banks which are unrestricted for withdrawal and usage.

Financial assets at amortized cost

Financial assets are subsequently measured at amortized cost if these financial assets are held within a business whose objective is to hold these assets in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets at fair value through other comprehensive income

Financial assets are measured at fair value through other comprehensive income if these financial assets are held within a business whose objective is achieved by both collecting contractual cash flows on specified dates that are solely payments of principal and interest on the principal amount outstanding and selling financial assets.

Financial assets at fair value through profit or loss

Financial assets are measured at fair value through profit or loss unless they are measured at amortised cost or at fair value through other comprehensive income on initial recognition. The transaction costs directly attributable to the acquisition of financial assets and liabilities at fair value through profit or loss are immediately recognised in statement of profit and loss.

Financial liabilities

Financial liabilities are recognised when the Company becomes a party to the contractual provisions of the instrument. Financial liabilities are initially measured at the amortised cost unless at initial recognition, they are classified as fair value through profit and loss.

Financial liabilities are subsequently measured at amortised cost using the EIR method. Financial liabilities carried at fair value through profit or loss are measured at fair value with all changes in fair value recognised in the Statement of Profit and Loss.

Equity instruments

An equity instrument is a contract that evidences residual interest in the assets of the company after deducting all of its liabilities. Equity instruments recognised by the Group are recognised at the proceeds received net of direct issue cost.

2.7 Cash and Bank Balances

Cash and bank balances also include fixed deposits, margin money deposits, earmarked balances with banks and other bank balances which are unrestricted for withdrawal and usage. Short term and liquid investments being subject to more than insignificant risk of change in value, are not included as part of cash and cash equivalents.

2.8 Revenue Recognition

a) Sales

- i) Sales of goods are recognized on dispatch and in accordance with the terms and conditions of the sale. Sale includes indirect taxes. Domestic sales are accounted for on dispatch from the point of sale corresponding to transfer of significant risks and rewards of ownership to the buyer.
- ii) Contract & Machinery Hire Charges are recognized on accrual basis.

b) Other Income

The Company recognizes income on accrual basis. However, where the ultimate collection of the same lacks reasonable certainty, revenue recognition is postponed to the extent of uncertainty.

2.9 Impairment of Assets

At the end of each accounting year the carrying amount of property, plant and equipment intangible assets and financial assets is reviewed for impairment. Impairment, if any, is recognized where the carrying amount exceeds the recoverable amounts being the higher of net realizable price and value in use. An impairment loss is charged to Statement of Profit and loss in the year in which an asset is identified as impaired. The impairment loss recognized in prior accounting periods is reversed if there has been a change in the estimate of recoverable amount.

2.10 Taxes on Income

Income tax expense for the year comprises of current tax and deferred tax. Current tax provision has been determined on the basis of relief, deductions etc. available under the Income Tax Act 1961 and Deferred tax is provided using balance sheet approach on temporary differences at the reporting date as difference between the tax base and the carrying amount of assets and liabilities. Deferred tax is recognized subject to the probability that taxable profit will be available against which the temporary differences can be reversed.

2.11 Foreign Currency Transactions

- 1) Foreign currency transactions are recorded at the exchange rate prevailing on the date of the transaction.

- 2) Monetary items denominated in foreign currencies (such as cash, receivables, payables etc.) outstanding at the year end, are translated at exchange rates applicable on year end date.
- 3) Non-monetary items denominated in foreign currency, (such as plant and equipment) are valued at the exchange rate prevailing on the date of transaction and carried at cost.
- 4) Any gains or losses arising due to exchange differences arising on translation or settlement are accounted for in the Statement of Profit and Loss.

2.12 Provision, Contingent Liabilities and Contingent Assets

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. Provisions are measured at the best estimate of the expenditure required to settle the present obligation at the Balance Sheet date.

Contingent liabilities are disclosed when there is a present obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made.

2.13 Employee Benefits

(a) Short term Employee benefits:

All employee benefits falling due wholly within two months of rendering the services are classified as short-term employee benefits. The benefits like salaries, wages, and short term compensated absences etc. and the expected cost of bonus; ex-gratia is recognized in the period in which the employee renders the related service.

(b) Post employment benefits:

(i) Defined Contribution Plan

The Company has Defined Contribution plan for post employment benefit namely Provident Fund, which is recognised by the income tax authorities and administered through appropriate authorities.

The Company contributes to a Government administered Provident Fund and has no further obligation beyond making its contribution.

(ii) Defined Benefit Plans

(c) Leave encashment

Based on the leave rules of the company, employees are not permitted to accumulate leave.

(d) Termination benefits are recognized as an expense as and when incurred.

2.14 Earnings Per Share

The earnings considered in ascertaining the Company's Earnings per share ('EPS') comprise the Net Income. The number of shares used in computing the Basic EPS is the weighted average number of shares outstanding during the year. The diluted EPS is calculated on the same basis as Basic EPS.

2.15 Discontinued Operations

Assets and Liabilities of discontinued operations are assessed at each Balance Sheet date. Impacts of any impairments and write backs are dealt with in the Statement of Profit and Loss.

Impacts of discontinued operations are distinguished from the ongoing operations of the Company, so that their impact on the Statement of Profit and Loss for the year can be perceived.
