We also confirm that there are **no other circumstances connected with our resignation which, in our professional judgment, need to be brought to the notice of the Board of Directors or the members of the Company**.

We shall comply with the applicable requirements under the **Companies Act, 2013** and shall file **Form ADT-3** with the Registrar of Companies within the prescribed time. A copy of the said filing shall be provided to the Company for its records, as applicable.

We further clarify that there is **no dispute or disagreement between our firm and the management of the Company**, nor do we have any concern regarding suppression of information by the management in connection with the conduct of the audit or the performance of our professional duties.
