Sub.: Intimation under Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations")

Pursuant to Regulation 30 read with Para B of Part A of Schedule III of the Listing Regulations, we, Aditya Infotech Limited ("**Company**") hereby intimate that the Company has been informed by Avathon, Inc. (an entity based in Austin, Texas) ("**Avathon**") and SparkCognition India Private Limited (an entity based in Bengaluru) ("**SparkCognition**") through their counsel that they have submitted a Request for Arbitration dated 28 May 2026 before the International Chamber of Commerce (ICC) for initiating arbitration proceedings against the Company.

The aforesaid dispute arises out of an agreement entered into between the Company and Avathon / SparkCognition, pursuant to which the Company proposed to purchase and resell certain products of Avathon / SparkCognition.

As this is a cross-border dispute in the International Chamber of Commerce, this disclosure is made with a slight delay upon undertaking the necessary coordination with our legal advisors.

The detailed disclosure with respect to the above notice as required under the SEBI Circular HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026 is enclosed herewith as Annexure A.
