Ms. P. Borthakur, learned counsel for the applicant is present.

The instant appeal application has been preferred by the applicants praying for stay of the operation of the impugned judgment and award dated 30.03.2026, passed by the learned MACT No.2, Kamrup (M) in MAC Case No. 1684/2023.

It is submitted by the learned counsel for the applicants that they have filed an appeal against the impugned judgment and award dated 30.03.2026 and the said appeal has already been admitted by this Court. She further submits that the applicants shall suffer irreparable loss and injury if the impugned order is not suspended during the pendency of the main appeal.

The application is allowed and the impugned judgment and award dated 30.03.2026, passed by the learned MACT No.2, Kamrup (M) in MAC Case No. 1684/2023, shall remain suspended during the pendency of the MAC appeal No. 271/2026 subject to the condition that the applicants shall deposit 50% of the awarded amount to the registry of this Court within 6 weeks from today.
