Service was complete on respondent No.3 in SLP(C) NO.14048/2026, common respondent No.3 in SLP(C) Nos.14049/2026 & 14050/2026 and respondent No.3 in SLP(C) No. 14053/2026 in April, 2026 but none has entered appearance.

Common respondent Nos.4, 5 & 6 in SLP(C) Nos.14047/2026 & 14052/2026 have filed counter affidavit but after the opportunity to file counter affidavit was already declined. Registry to make a specific mention of this fact in the office report while placing the matter before the Hon'ble Court.
