Sub: Disclosure under Regulation 30 of the SEBI (LODR) Regulations, 2015 – Further Update on Resumption of Manufacturing Operations at Kadium Unit

This is in continuation of the Company's earlier disclosures dated 30.04.2026, 02.05.2026, 30.05.2026, 04.06.2026 and 15.07.2026 regarding the disruption and subsequent partial resumption of manufacturing operations at the Company's Kadium Unit. We are pleased to inform that there has been a further improvement in the operational situation at the Kadium Unit.

A second paper machine having a production capacity of 55 MT per day has now resumed operations effective July 23, 2026. Consequently, the aggregate operational production capacity at the Kadium Unit has increased from approximately 70% to about 93% of the Unit's normal production capacity.

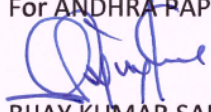
The Company continues to take necessary operational measures for progressive stabilisation and normalisation of manufacturing activities. Efforts are ongoing to restore full operations at the Kadium Unit at the earliest.

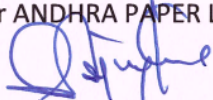
