We are pleased to inform you that we have received a final Judgement and Order from Hon'ble Court of the Principal District & Sessions Judge, Ahmedabad, being the designated Special Court under the Prevention of Money Laundering Act, 2002 ("PMLA"), pertaining to proceedings under Section 3 and punishable under Section 4 of the PMLA Act, 2002 vide order pronounced on 6th May, 2026-Wednesday and received by company on 7th May 2026 on Thursday.

The Company has now been discharged in PMLA Case No. 2/2024. Earlier the company was discharged by Hon'ble High court of Gujarat in PMLA Case nos. 5 of 2021, 21 of 2018 and CBI-ACB case No. 3/2020.
