Subject: Disclosure of the details of allotment in the Issue (as defined hereinafter) by Wheels India Limited (the "Company") in accordance with the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements), 2015, as amended (the "SEBI Listing Regulations").

Re: Qualified institutions placement of equity shares of face value of ₹ 10 each (the "Equity Shares") by the Company under the provisions of Chapter VI of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the "SEBI ICDR Regulations"), and Sections 42 and 62 of the Companies Act, 2013 (including the rules made thereunder), as amended (the "Issue").

In continuation of our earlier letter dated September 24, 2026 and September 25, 2026 on the captioned subject, we wish to inform you that, in respect of the Issue which opened on September 24, 2026 and closed on September 25, 2026 the Fund raise Committee had at its meeting held today, i.e., September 25, 2026, approved the issue and allotment of 11,97,318 Equity Shares of face value ₹ 10 each to eligible qualified institutional buyers at the issue price of Rs. 2088.00 per Equity Share, i.e. at a premium of ₹ 2078.00 per Equity Share, [(which included a discount of Rs. 109.10 ([4.97]% of the floor price) aggregating to Rs. 249,99,99,984 (Rs. Two hundred forty nine crores ninety nine lakhs ninety nine thousand nine hundred eighty four only pursuant to the Issue.

Pursuant to the allotment of Equity Shares in the Issue, the paid-up equity share capital of the Company stands increased from Rs. 256650430 consisting of 25665043 Equity Shares to Rs.268623610 consisting of 26862361 Equity Shares having face value of Rs.10. The shareholding pattern of the Company, before and after the Issue, will be submitted along with the listing application in the format specified in Regulation 31 of the SEBI Listing Regulations.
