UPON hearing the counsel the Court made the following
O R D E R

1. By virtue of the order of this Court dated 07.05.2026 in Civil Appeal No. 7114/2026, we had appointed Hon'ble Justice Bhushan Ramkrishna Gavai, Former Chief Justice of India, to act as an arbitrator between the parties in the matter.
2. By a letter dated 23.05.2026, Hon'ble Justice Bhushan Ramkrishna Gavai has informed this Court that due to certain unavoidable circumstances, it will be not possible to continue with the mandate of the present arbitration proceedings. A request has also been made to be relieved from the subject proceedings. Today, the matter has come up for substitution of arbitrator.

The rest of the terms will be governed by the aforesaid order of 07.05.2026.
