In this regard, we wish to update you that the Company has filed an appeal before the **Securities Appellate Tribunal (SAT), Mumbai**, challenging the Show Cause-cum-Interim Order issued by BSE Limited, pursuant to which trading in the equity shares of the Company has been suspended.

- to seek an appropriate judicial review of the Show Cause-cum-Interim Order;
