ORDINARY BUSINESS

Item No. 1: To receive, consider and adopt the Audited Standalone Financial Statements of the Company for the financial year ended March 31st, 2026, together with Report of Board of Directors and Auditors' Report thereon.

In this regard, to consider and If thought fit, to pass with or without modification(s), the following resolution as an Ordinary Resolution:

“**RESOLVED THAT** the Audited Standalone Financial Statements including the Balance Sheet of the Company as at March 31st, 2026, the Statement of Profit and Loss, the Statement of Changes in Equity and the Cash Flow Statement for the financial year ended on that date together with all the notes annexed and the Directors' and Auditors' Reports thereon, placed before the meeting, be and are hereby considered and adopted.”

1. Pursuant to Circular No. 03/2025 dated September 22, 2025, issued by the Ministry of Corporate Affairs ('MCA') read with the other relevant circulars issued on the subject (collectively referred to as 'MCA Circular') has allowed conducting Annual General Meeting ('AGM') through Video Conferencing ('VC') or Other Audio Visual Means ('OAVM') without the physical presence of Members at a common venue. In compliance with the said circulars, the AGM of the Company is being held through VC/OAVM. Members can attend and participate in AGM through VC/OAVM only and thus attendance slip is not attached to this Notice. The deemed venue for the AGM shall be the Registered Office of the Company. Since the AGM will be held through VC/ OAVM, the route map of the venue of the Meeting is not annexed hereto.
2. Notice of the AGM along with the Annual Report for FY 2025-26 is being sent by electronic mode to those Members whose e-mail addresses are registered with the Company/National Securities Depository Limited ('NSDL') and the Central Depository Services (India) Limited ('CDSL'). The Notice of AGM along with the Annual Report is also available on the website of the Company at <http://www.mohitpaper.in> and website of Stock Exchange i.e. BSE Limited at www.bseindia.com and on the website of MUFG Intime India Private Limited (MUFG), Registrar and Share Transfer Agents ('RTA') at <https://in.mpms.mufg.com>. As per Regulation 36(1)(b) of the SEBI Listing Regulations, a letter providing the weblink of the Annual Report for FY 2025-26 and a static Quick Response Code (QR Code), will be sent to those shareholder(s) who have not registered their email address with the Company/ RTA of the Company.

The attendance of the Members attending the 34th AGM through VC/OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Companies Act, 2013 ('Act').

3. In compliance with the provisions of Section 108 of the Act, read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, Regulation 44 of the SEBI Listing Regulations and in terms of SEBI vide circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020 in relation to e-Voting facility provided by listed entities, the Members are provided with the facility to cast their vote electronically, through the e-Voting services provided by MUFG, on all the resolutions set forth in this Notice. The instructions for e-Voting are given below. Members who have cast their votes by remote e-voting prior to the AGM may participate in the AGM but shall not be entitled to cast their votes again.
4. However, pursuant to SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dt. December 9, 2020, on e-Voting facility provided by Listed Companies, e-Voting process has been enabled to all the individual demat account holders, by way of single login credential, through their demat accounts / websites of Depository Participant(s) ('DP') in order to increase the efficiency of the voting process.
5. The voting rights of Members shall be in proportion to their shares in the paid-up equity share capital of the Company as on the cut-off date i.e., Tuesday, September 22, 2026.

6. The remote e-voting facility will be available during the following voting period:

Commencement of remote e-voting: 9:00 a.m. IST on Saturday, September 26, 2026.

End of remote e-voting: 5:00 p.m. IST on Monday, September 28, 2026.

The remote e-voting shall not be allowed beyond the aforesaid date and time, and the remote e-voting module shall be forthwith disabled upon expiry of the aforesaid period.

7. The Register of Members and Share Transfer Books will remain closed from Wednesday September 23, 2026, to Tuesday, September 29, 2026 (both days inclusive) in terms of the provision of Section 91 the Act for the purpose of this AGM.
8. The Board of Directors has appointed Mr. Ankit Jain, Partner of Ankit J & Associates, Practicing Company Secretary (ACS No. 31103 and COP No. 26724) as the Scrutinizer to scrutinize the voting during the AGM and remote e-voting process in a fair and transparent manner. Subject to receipt of requisite number of votes, the Resolutions shall be deemed to be passed on the date of the AGM, i.e. Tuesday, September 29, 2026.
9. The Scrutinizer, after the conclusion of e-voting at the AGM, scrutinize the votes cast at the Meeting and votes cast through remote e-voting, shall make a consolidated Scrutinizer's Report and submit the same to the Chairman or a person authorized by him in writing.
10. The result of e-voting shall be declared within two working days of the conclusion of the AGM and the same, along with the consolidated Scrutinizer's Report, shall be placed on the website of the Company: <http://www.mohitpaper.in> and on the website of MUFG at: <https://in.mpms.mufg.com>. The result shall simultaneously be communicated to the stock exchanges.
11. Members seeking any information on the Company, its financial statements for the Financial Year ended March 31, 2026, or any matter to be placed at the AGM may visit the Company's website at <http://www.mohitpaper.in> or send their queries through email on investorsmohitpaper@gmail.com to the Company in advance before the date of the meeting to enable the Management to keep full information ready on the date of AGM.
12. In accordance with the MCA Circulars, the Register of Directors and Key Managerial Personnel and their shareholding maintained under Section 170 of the Act and Register of Contracts or arrangements in which directors are interested maintained under Section 189 of the Act and relevant documents referred to in this Notice of AGM along with the Annexures will be available for inspection on the date of AGM in electronic mode and shall remain open and be accessible to any Member up to the date of AGM. Members desiring inspection of statutory registers and other relevant documents may send their request in writing to the Company at: investorsmohitpaper@gmail.com
13. As per provisions of the Act, a member entitled to attend and vote at the AGM is entitled to appoint a proxy to attend and vote on a poll instead of himself and the proxy need not be a Member of the Company. Since this AGM is being held through VC / OAVM pursuant to the MCA Circulars,

physical attendance of Members has been dispensed with. Accordingly, the facility for appointment of proxies by the Members will not be available for the AGM, hence the proxy forms are not attached to the Notice. However, the Body Corporates are entitled to appoint authorised representatives to attend the AGM through VC/OAVM and participate thereat and cast their votes through electronic voting ("e-voting").

14. Body Corporates/ Institutional Shareholders whose authorised representatives are intending to attend the Meeting through VC/OAVM are requested to send to the Company at investorsmohitpaper@gmail.com, a certified copy of the Board Resolution/ authorization letter authorizing their representative to attend and vote on their behalf at the AGM through e-voting and also to scrutinizer at email id ankit.l164@gmail.com with a copy marked to delhi@in.mpms.mufig.com.
15. Pursuant to the Facility of joining the AGM through VC / OAVM will be made available to at least 1,000 members on a first come first served basis as per the MCA Circular. However, the participation of members (holding 2% or more shares), promoters, and Institutional Investors, Directors, Key Managerial Personnel, Chairpersons of Audit Committee, Stakeholders Relationship Committee, Nomination and Remuneration Committee, Enterprise Risk Management Committee and other Committees and Auditors are not restricted on first come first serve basis.
16. Institutional investors, who are members of the Company, are encouraged to attend and vote at the AGM of the Company.

17. IMPORTANT INSTRUCTION FOR SHAREHOLDERS HOLDING SHARES IN PHYSICAL FORM

- I. SEBI, vide its circular no. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2022/8 dated January 25, 2022, has mandated the listed company to issue the securities in dematerialised form only while processing investor service requests viz. issue of duplicate securities certificate; renewal/ exchange of securities certificate; endorsement; sub-division/splitting of securities certificate; consolidation of securities certificates/folios; transmission and transposition. As per SEBI circular no. HO/38/13/(3)2026-MIRSDPOD/ 1/3763/2026 dated January 30, 2026, the requirement of issuance of a Letter of Confirmation ("LOC") by the Company/ RTA has been dispensed with for the aforesaid investor service requests with effect from April 2, 2026. Accordingly, securities will be credited directly to the shareholder's demat account upon submission of latest Client Master List with duly filled demat conversion request form to the RTA. In view of the same and to eliminate the risks associated with physical shares and to avail various benefits of dematerialisation, members are advised to dematerialise the shares held by them in physical form. Members can contact the Company or RTA, for assistance in this regard.
- II. Members are requested to update their email address, choice of nomination and KYC records by submitting duly filled and signed relevant form along with the relevant proofs listed in the forms, to MUFG Intime India Private Limited, Registrar and Share Transfer Agent.

SEBI, vide Circular No. HO/38/13/11(2)2026-MIRSDPOD/I/3750/2026 dated January 30, 2026, has opened a special window to facilitate re-lodgement of transfer and dematerialisation of physical securities. The window will remain open for a period of one year, i.e., from February 5, 2026 to February 4, 2027.

This special facility will be available for transfer and dematerialisation of physical shares that were sold or purchased prior to April 1, 2019. Additionally, the facility extends to transfer requests that were submitted earlier but were rejected, returned, or not attended to due to deficiencies in documents, process issues, or for any other reason.

18. Members holding shares in multiple folios in physical mode are requested to apply for consolidation of their holdings in one folio to the Company or MUFG/RTA of the Company along with relevant Share Certificates. A Letter of Confirmation would be issued after making requisite changes which the member has to submit with Depository Participant for Demat.

19. SEBI has introduced Online Dispute Resolution ("ODR") portal for dispute resolution in addition to the existing SEBI Complaints Redress System ("SCORES") platform, which can be utilised by the investors and the Company for dispute resolution. 20. INSTRUCTIONS FOR E-VOTING AT THE AGM ARE AS UNDER:

I. The facility for voting through electronic voting system will also be made available at the Meeting ('InstaMeet') and members attending the Meeting who have not cast their vote(s) by remote e-voting will be able to vote at the Meeting through e-voting system available during the AGM.

II. E-voting during the AGM is integrated with the VC / OAVM platform. The Members may click on the voting icon displayed on the screen to cast their votes.

III. A Member can opt for only single mode of voting i.e., through Remote e-voting or voting at the AGM. If a Member cast votes by both modes, then voting done through Remote e-voting shall prevail and vote at the AGM shall be treated as invalid.

IV. The Company has engaged the services of MUFG Intime India Private Limited as the agency to provide e-voting facility. The manner of voting remotely by members holding shares in

dematerialized mode, physical mode and for members who have not registered their email addresses is provided in the instructions given below.

- V. 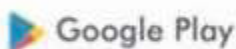

COMPANY OVERVIEW

Established in 1992 and listed on BSE Ltd., the Company continues to advance its mission of manufacturing quality paper products while placing strong emphasis on sustainability, operational efficiency, and value creation for all stakeholders.

As part of its continuing capital expenditure plan, the Company has successfully commissioned an evaporator and caustic soda recovery plant. This investment is anticipated to improve operational efficiency by cutting down chemical usage, optimizing energy consumption, and reducing production costs, thereby supporting healthier margins in the years ahead.

The Company operates on an agro-based manufacturing model, relying on renewable inputs such as bagasse and other agricultural residues, along with imported waste paper as a supplementary raw material. This model aligns with our sustainability goals while enabling us to deliver strong product quality and durability. Products are supplied in reels, sheets, and other formats based on customer requirements, serving both domestic and export clientele.

During FY 2025-26, the Company sustained a high rate of capacity utilization. While challenges such as fluctuating input costs and limited scale relative to larger competitors persisted, the Company stayed focused on driving long-term cost efficiencies and upgrading its technology base. Being agro-based in nature, our raw material costs remain exposed to seasonal and market-linked price variations, which continue to affect overall cost dynamics.

The Company's product portfolio spans a wide range of paper types, including white and coloured writing and printing paper, MG poster paper, kraft paper, and various customized grades tailored to meet changing market requirements.

Going forward, the Company remains dedicated to its core priorities of sustainable growth, operational excellence, and shareholder value creation. It intends to deepen its market footprint, pursue new product avenues, and adopt cleaner technologies to boost competitiveness while minimizing environmental impact. Backed by these efforts, the Company is well-positioned to emerge as a future-ready enterprise, delivering steady performance and enduring value to all its stakeholders.

RESULTS OF OPERATIONS AND STATE OF COMPANY'S AFFAIRS

The Company's management remains steadfast in its resolve to drive growth and fulfil the Company's long-term strategic goals. With paper manufacturing as its core business focus, the Company continues to work towards improving operational efficiency, reinforcing its market standing, and maximizing returns for shareholders.

As of FY 2025-26, the Company's installed production capacity is 202.27 metric tons per day (MT/day), and this capacity is being utilized to the fullest extent. Earlier, in FY 2023-24, the Board of Directors had sanctioned the installation of a 150 TDS Boiler and Evaporator (BE) along with a caustic soda recovery plant, aimed at further boosting production capabilities within the existing capacity framework. This initiative was primarily undertaken to strengthen steam generation, power efficiency, and caustic soda recovery all of which play a vital role in the paper manufacturing process.

The installation of the BE unit and caustic soda plant is expected to boost operational efficiency through better energy utilization and chemical recovery, allowing the Company to make optimal use of its existing production capacity. These investments are intended to further reinforce cost competitiveness and long-term operational sustainability.

The Company has achieved considerable progress on this front, with the BE and caustic soda plant having been successfully commissioned during FY 2023-24. This represents an important milestone, enabling the Company to fully harness its installed capacity and drive improvements in overall production efficiency.

Looking forward, the Company remains committed to building on these operational gains to improve profitability, contain costs, and continue generating value for its shareholders. The successful execution of these projects underscores the Company's commitment to becoming a more efficient and resilient organization, well-positioned to capture future growth opportunities.

Key Developments During the Financial Year 2025-2026

- **Business Segment:** The Company continued to operate within its core business segment of paper manufacturing, with no diversification or changes to the nature of its business during the year.
- **Status of the Company:** There were no significant changes to the status or operations of the Company.
- **Financial Year:** The Company's financial year remained unchanged, and all operations were conducted within the regular fiscal cycle.
- **Corporate Restructuring:** There were no acquisitions, mergers, expansions, modernization efforts, or diversification activities undertaken during the year.
- **Material Events:** No material events occurred during the year under review that significantly impacted the operations, financial position, or strategic direction of the Company.

Highlights of Financial Performance for the Financial Year 2025-2026

During the FY' 2025-26, the revenue of the Company increased to Rs. 20,017.59 lakhs as compared to Rs. 18,020.62 lakhs in the previous year reflecting an improvement driven by strategic initiatives. Additionally, the other income of the Company decreased to Rs. 78.08 lakhs from Rs. 654.52 lakhs in the previous year.

In FY' 2025-26, the Company continued to face challenges with the raw material cost volatility, rising input and a reduction in paper prices.

Further, the total income for FY' 2025-26 stands at Rs. 20,095.68 lakhs, compared to Rs. 18,675.15 lakhs for FY' 2024-25 and a company booked a total profit of Rs. 656.42 lakhs in FY' 2025-26 as compared to a profit of Rs. 650.87 lakhs in FY' 2024-25.

Reserves

For the FY' 2025-26, the Company has transferred a sum of Rs. 656.43 lakhs to General Reserves, reflecting its continued commitment to strengthening financial stability. The total free reserves and surplus (Other Equity) as of March 31st, 2026, stands at Rs. 4,359.66 Lakhs, compared to Rs. 3,703.23 lakhs as on March 31st, 2025, reflecting the Company's consistent growth in reserves.

Cash and Equivalents

As of March 31st, 2026, the Company's cash and cash equivalents have reached Rs. 17.43 lakhs, compared to Rs. 28.75 lakhs as of March 31st, 2025, indicating an improvement. This is in line with the Company's strategic focus on efficient working capital management, ensuring that receivables, inventories, and other working capital parameters are managed effectively through continuous monitoring.

Net Worth and Earnings Per Share (EPS)

As of March 31st, 2026, the Company's net worth stands at Rs. 5,759.66 lakhs, compared to Rs. 5,103.23 lakhs as of March 31st, 2025, reflecting the Company's ongoing financial health and sustained value creation.

The Earnings Per Share (EPS) for the financial year ended March 31st, 2026, is recorded at Rs. 4.74, compared to Rs. 4.65 for the financial year ended March 31st, 2025, showing growth in profitability per share.

Dividend

The Board of Directors, after carefully evaluating the relevant factors, including the Company's financial position, liquidity, and long-term growth prospects, has decided that it would be prudent not to recommend any dividend for the FY' 2025-26. This decision reflects the Company's focus on reinvesting resources to support future growth and ensure financial stability.

MATERIAL CHANGES AND COMMITMENTS, IF ANY, AFFECTING THE FINANCIAL POSITION OF THE COMPANY

There have been no material changes or commitments affecting the financial position of the Company from the end of the financial year, March 31st, 2026, to the date of this report, which would have a significant impact on the Company's financial standing.

There is no change in the nature of business of your Company during the year under review.

Overview

At Mohit Paper Mills Limited (the "Company"), sound corporate governance continues to underpin our approach to long-term, sustainable growth. In today's increasingly complex business environment, the role of management extends well beyond driving operational efficiency, it is about steering the organization with transparency, integrity, and accountability at every level. Our leadership remains focused on generating value that goes beyond financial metrics alone, striving instead to create meaningful, lasting impact for all those connected to the Company: our employees, customers, shareholders, and the communities in which we operate.

We believe that robust governance and ethical conduct are not merely regulatory obligations but the very foundation on which durable business success is built. A workplace culture that encourages innovation, embraces sustainable practices, and holds itself accountable is one that is best positioned to thrive amid constant market change. It is this alignment between stakeholder interests and corporate strategy that continues to strengthen our governance framework year after year.

Within the Indian paper industry, the Company has established itself as a well-recognized manufacturer of writing, printing, and tissue paper. What distinguishes our operations is their agro-based foundation. We rely extensively on bagasse and other agricultural residues as raw material, a practice that reflects our long-standing commitment to sustainability and efficient resource utilization.

Technological advancement remains central to how we maintain our competitive edge. Our Chemical Recovery Plant continues to play a vital role in our resource-efficiency strategy, recovering caustic soda while generating soda ash as a valuable by-product. Environmental responsibility is equally embedded in our operations through our Effluent Treatment Plant (ETP), which upholds rigorous standards in pollution control and water management. Furthering our pursuit of operational self-sufficiency, our Captive Power Plant continues to meet the Company's entire energy requirement, reducing dependence on external power sources and enhancing overall efficiency.

The purpose of this report is to offer a holistic view of how the Company's management is responding to a shifting external environment and an evolving paper industry landscape. It covers our strategic priorities, operational and financial outcomes, and key developments across human resources and industrial relations for FY 2025-26. The report further examines the risks and opportunities before us, along with an evaluation of the strength and effectiveness of our internal control systems.

This report is intended to be read in conjunction with the Company's Financial Statements, related schedules, notes, and other disclosures forming part of the Annual Accounts for FY 2025-26. All financial statements have been prepared in accordance with Indian Accounting Standards (Ind AS) and in compliance with the provisions of the Companies Act, 2013, as well as applicable regulations prescribed by the Securities and Exchange Board of India (SEBI).

Industry Structure and Developments

Global Paper and Pulp Industry: An Enduring Pillar of the World Economy

The global pulp and paper industry remains a substantial and resilient sector, with market size estimated at USD 351.7 billion in 2025, projected to grow to USD 357.6 billion in 2026. Asia Pacific continues to dominate the industry, accounting for roughly 56.4% of global market share in 2025, underscoring the region's central role in both production and consumption.

The industry continues to be broadly categorized into four core segments:

Core Segment of the Global Pulp & Paper Industry



Figure 1: Core segments of the global pulp and paper industry

Of these, packaging paper and board remains the standout performer, the global paper and paperboard packaging market alone is estimated to expand from USD 417.31 billion in 2025 to USD 436.63 billion in 2026. This continued momentum is being driven by the ongoing substitution of rigid plastics with fiber-based packaging formats, expanding e-commerce adoption, and sustainability-linked regulatory pressures.

The graphic paper segment- comprising newsprint and both coated and uncoated wood-based papers- continues to face structural headwinds from digitalization, particularly in mature Western markets, even as Asian markets, including India, continue to show comparatively resilient demand for packaging and tissue grades. This divergence continues to create meaningful opportunities for Indian and other emerging-market producers as Western graphic paper capacity contracts.

The Indian Paper Industry

India remains one of the fastest-growing paper markets in the world. The Indian paper industry accounts for roughly 5% of global paper production, with an estimated industry turnover exceeding INR 1,00,000 crore and a contribution of over INR 5,000 crore. The sector also continues to be a significant employment generator, providing direct employment to approximately 500,000 people and indirect employment to a further 1.5 million.

The industry's raw material profile has continued to evolve in recent years, with recycled fibre now accounting for the predominant share of total production, as illustrated below:

Raw Material Profile of the Indian Paper Industry

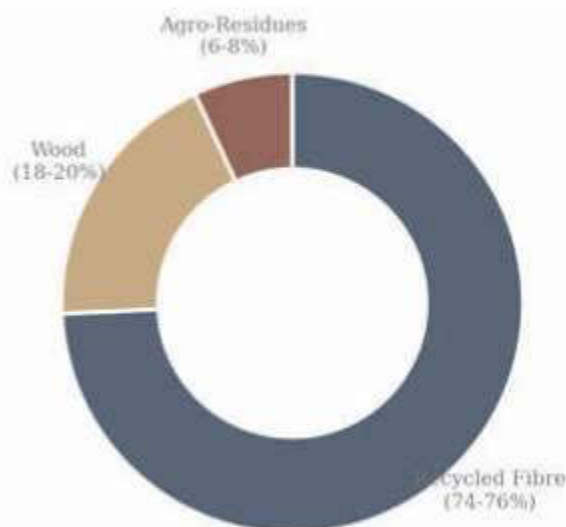


Figure 2: Raw material profile of the Indian paper industry

At the same time, domestic waste-paper collection remains constrained at close to 50%, well below the recovery rates of 90% seen in more developed economies, requiring the industry to import close to 10 million tonnes of waste-paper annually to bridge the gap. This continues to reinforce the importance of agro-based and agroforestry raw materials including bagasse, sarkanda, wheat straw, and rice straw both as a fibre-security measure and as an alternative to crop burning, sustaining the industry's deep-rooted ties with the farming community.

Market Trends and Growth Drivers

Demand for eco-friendly, fibre-based packaging continues to strengthen globally, supported by paper's lower carbon footprint, biodegradability, and compatibility with circular economy principles relative to conventional plastics. Rapid urbanization across Asia-Pacific, the continued expansion of e-commerce and organized retail, and tightening environmental regulation are together sustaining demand for recycled and sustainably sourced paper products. In developing economies, both consumers and manufacturers are increasingly gravitating toward paper-based alternatives, reflecting a broader and accelerating shift toward environmentally responsible packaging and consumption choices.

Major Areas of Concern**Trend Towards Digitalization**

The printing market continues to evolve as publishers migrate toward electronic formats in substitution of traditional print volumes. E-books, online newspapers, and digital magazines now predominate, while directories, catalogues, and brochures increasingly have electronic counterparts. The growth of digital transactions is reducing reliance upon physical currency and cheques, and advertising expenditure continues to shift toward online platforms and social media. Taken together, these developments are exerting downward pressure on demand for printed materials such as magazines, catalogues, and books, with consequential implications for the growth of the pulp and paper market.

Environmental Impact of the Paper Industry

Being resource-intensive by nature, the paper industry frequently attracts scrutiny from environmental advocates concerned with its ecological footprint. The European Environmental Paper Network ("EENP") has emphasised that the industry must contribute to a sustainable future by adhering to seven core principles, namely: reducing global paper consumption and promoting equitable access; maximising recycled fibre content; ensuring social responsibility; sourcing raw materials sustainably; minimising greenhouse gas emissions; adopting clean production processes; and maintaining transparency and accountability.

China, the world's largest consumer of paper and board — with annual consumption exceeding 120 million tonnes — is also the foremost importer of recovered paper and a major producer of recycled paper. The Chinese Environmental Paper Network ("CEPN") has, however, raised material concerns, including water pollution attributable to untreated mill effluents, unsustainable fibre-sourcing practices, deforestation linked to imported pulp, inadequate recovery of waste paper, and excessive paper wastage. Addressing these concerns remains material to the industry's sustainable development and environmental stewardship.

In order to support a sustainable future, and without derogating from its existing environmental commitments, the industry, including the Company, must continue to accord priority to the following:

2. Increase recycled content, so as to maximise the use of recycled paper, thereby reducing dependence on virgin fibre and minimising waste.
3. Ensure social responsibility, by upholding ethical labour practices and supporting local communities across the supply chain.
4. Source fibre sustainably, by avoiding deforestation and committing to certified, sustainable forestry practices.
5. Reduce greenhouse gas emissions, through the adoption of cleaner energy and energy-efficient technologies.
6. Adopt clean production processes, through the use of advanced technologies to control water and air pollution and harmful emissions.
7. Promote transparency, by maintaining openness in respect of environmental performance and supply chain practices, so as to build and preserve stakeholder trust.

Additional Considerations

- **Water Management:** Optimize water use and recycling to reduce consumption and pollution.
- **Waste Reduction:** Strengthen recycling initiatives and minimize waste throughout production and the product lifecycle.

Current status of the domestic paper industry

The Indian paper industry continues to present significant growth potential, underpinned by a rising domestic market, supportive government policy, rapid urbanisation, and a skilled labour force. The industry nonetheless continues to face material challenges, including elevated raw material costs, low paper recovery rates, and stringent environmental regulation. A balanced and strategic approach — centred upon innovation, sustainability, and resource efficiency — remains essential in order to harness the available opportunities while addressing these constraints. Through the proactive management of environmental and operational challenges, the industry is well placed to strengthen its long-term sustainability and to contribute to a greener future.

Future Outlook

The future of the paper industry will be shaped by several key trends. As digitalization continues, the demand for traditional print media such as newspapers and magazines is expected to decline, prompting a shift toward higher-value specialty papers, particularly in packaging and premium printing. Innovation will also play a major role, with the development of advanced paper materials offering enhanced strength, flexibility, and water resistance. Sustainability will remain a central focus, driving improvements in recycling, cleaner production processes, and responsible forest management. Additionally, the booming e-commerce sector and evolving consumer preferences are expected to significantly increase the demand for paper-based packaging solutions.

Sustainability Initiatives

The company is actively advancing sustainability through a range of focused initiatives. Key efforts include optimizing water and energy use with advanced technologies, promoting recycling by designing recyclable products, and exploring alternative fibers to diversify raw material sources. Energy optimization remains a priority, with investments in energy-efficient and renewable technologies. Collaboration with research institutions, industry peers, and continuous market research supports innovation and ensures alignment with evolving consumer preferences and sustainability goals.

Technological disruption also presents a material risk, necessitating continuous investment in automation, digitalisation, and process optimisation.

Environmental regulation and climate-related challenges further necessitate the adoption of sustainable practices and clean technologies, so as to minimise impact and to maintain compliance. Additionally, the Company operates within a dynamic and highly regulated environment, thereby exposing it to financial, legal, compliance, cybersecurity, and information-technology related risks.

In order to address the foregoing, the Company follows a robust risk management framework designed to minimise potential disruption while enhancing its capacity to adapt to, and to capitalise upon, emerging market opportunities. Ongoing policy engagement, proactive mitigation strategies, and collaboration with stakeholders constitute the cornerstone of this approach.

Human Resources & Industrial Relations

Your Company acknowledges that employees are key stakeholders in its growth journey. It has built a skilled, motivated, and engaged workforce through focused leadership development and continuous training initiatives. As of March 31st, 2026, the Company employed 430 permanent staff members. Industrial relations remained stable and positive throughout the year, fostering a collaborative and performance-driven work culture.

Outlook

The Company remains optimistic about its future growth. Strategic capital investments have been made to scale up production in anticipation of rising demand. Alongside this, efforts are ongoing to strengthen the human resource base to support increased operational volumes. Month-on-month improvements in capacity utilization reflect operational efficiency, while active collaboration with partners is helping to develop new value-added products for the evolving market.

Internal Control Systems

The Company has implemented a robust internal control framework, suited to its scale and operational complexity. An independent internal audit function, managed by an external Chartered Accountant firm, ensures comprehensive operational coverage and oversight. This framework is designed to safeguard assets, uphold compliance, and maintain the accuracy and reliability of financial reporting, in alignment with industry best practices.

Discussion on Financial Performance with respect to Operational Performance

During the FY' 2025-26, the revenue of the Company increased to Rs. 20,017.59 lakhs as compared to Rs. 18,020.62 lakhs in the previous year reflecting an improvement driven by strategic initiatives. Additionally, the other income of the Company decreased to Rs. 78.08 lakhs from Rs. 654.52 lakhs in the previous year.

In FY' 2025-26, the Company continued to face challenges with the raw material cost volatility, rising input and a reduction in paper prices.

Further, the total income for FY' 2025-26 stands at Rs. 20,095.68 lakhs, compared to Rs. 18,675.15 lakhs for FY' 2024-25 and a company booked a total profit of Rs. 656.42 lakhs in FY' 2025-26 as compared to a profit of Rs. 650.87 lakhs in FY' 2024-25.

REPORT ON CORPORATE GOVERNANCE

1. Company's Philosophy on Corporate Governance

The essence of Corporate Governance at Mohit Paper Mills Limited ("the Company") lies in transparency, ethical management, and accountability. The Independent Directors were also evaluated as per the criteria laid out in the "Policy on Performance Evaluation of Independent Directors," which the Board may revise from time to time to ensure continued relevance and effectiveness.

The outcome of the evaluation was reviewed by the Board and the NRC, and the feedback was used to identify areas of improvement and enhance the overall effectiveness of the Board and its governance practices.

viii. Term of Board membership and new appointment:

The Nomination and Remuneration Committee (NRC) is responsible for determining the appropriate mix of skills, qualifications, expertise, and experience required for the effective functioning of the Board, both collectively and individually. Board members are expected to possess high standards of integrity, sound judgment, leadership qualities, and relevant experience in sectors or functional areas aligned with the Company's business, enabling them to make meaningful contributions to the Company's growth and governance.

As per the Company's existing policy, the prescribed retirement age for the Managing Director is seventy (70) years.

For new appointments, the NRC identifies and assesses individuals based on their integrity, qualifications, professional experience, and domain expertise. The Committee then recommends suitable candidates for appointment as Directors, Key Managerial Personnel (KMP), or at the Senior Management level, subject to approval by the Board and, where applicable, by the shareholders in the general meeting.

The NRC has the discretion to evaluate whether a candidate's profile meets the requirements of the respective position, and whether their qualifications and experience are sufficient and appropriate, taking into account the nature of the role and the strategic needs of the Company.

ix. Meeting of Independent Director(s)

In accordance with the provisions of Clause VII of Schedule IV of the Companies Act, 2013 and

Regulation 25(3) and 25(4) of the SEBI Listing Regulations, a separate meeting of the Independent Directors of the Company was held on February 12th, 2026, without the presence of Non-Independent Directors and members of the management.

At this meeting, the Independent Directors, inter alia, discussed and reviewed the following matters:

1. Evaluation of the performance of Non-Independent Directors and the Board as a whole;
2. Evaluation of the performance of the Chairman of the Company, taking into account the views of Executive and Non-Executive Directors;
3. Evaluation of the quality, content, and timeliness of the flow of information between the management and the Board that is necessary for the Board to effectively discharge its responsibilities.

All Independent Directors were present at the meeting. In addition to the above, the Independent Directors also deliberated on key matters including the overall performance and strategy of the Company, risk management practices, governance and compliance frameworks, leadership strengths and succession planning, and the effectiveness of the executive leadership, including the Chairman. This meeting provided an open forum for the Independent Directors to share their views and contribute towards strengthening the governance practices of the Company.

x. Familiarization program for Independent Directors

At the time of appointment, every Independent Director is issued a formal letter of appointment setting out, inter alia, their role, responsibilities, functions, and duties as a Director of the Company. The Director is also briefed in detail on the statutory and regulatory obligations under the Act, SEBI Listing Regulations, and other applicable laws and governance frameworks.

To ensure a smooth integration and deeper understanding of the Company's operations, the Chairman & Managing Director holds one-on-one sessions with newly appointed Directors. The Directors are also provided with essential documents, reports, internal policies, and other reference materials to familiarize them with the Company's business processes, internal control systems, and organizational structure.

Periodic presentations are made at the meetings of the Board and its Committees to apprise the Directors of the Company's business performance, strategic initiatives, industry developments, regulatory updates, and risk management framework. Independent Directors are encouraged to freely interact with senior management, including functional heads, to gain insights into the business and operations.

Additionally, interactive sessions are organized from time to time, offering Independent Directors an opportunity to engage with the senior leadership team and key personnel across various functions. All significant corporate announcements, press releases, and regulatory communications are shared with the Independent Directors to keep them informed of the ongoing developments.

The objective of the familiarization programme is to provide Independent Directors with a comprehensive understanding of the business environment, industry-specific challenges, key regulatory developments, and strategic priorities of the Company, thereby enabling them to contribute meaningfully to the Board's deliberations.

The Company has received necessary declaration from each Independent Director under Section 149 of the Act, that he meets the criteria of independence laid down in Section 149(6) of the Act along with rules framed thereunder and Regulation 16(b) & 25 of the SEBI Listing Regulations and other rules and regulation, if applicable and they are not aware of any circumstance or situation, which exist or may be reasonably anticipated, that could impair or impact their ability to discharge their duties with an objective Independent judgment and without any external influence.

- Review quarterly financial statements with management prior to Board approval.
- Monitor utilization of funds raised through public, rights, preferential issues, and related reports from monitoring agencies, recommending corrective actions where necessary.
- Monitor auditors' independence, performance, and the effectiveness of audit processes.
- Approve or modify related party transactions and scrutinize inter-corporate loans and investments.

- Evaluate valuation of undertakings or assets as necessary.
- Review the adequacy of internal financial controls and risk management systems.
- Evaluate the performance of statutory and internal auditors and adequacy of internal control systems.
- Review the internal audit function's adequacy, structure, staffing, reporting lines, and frequency.
- Discuss significant findings from internal audits and follow-up actions.
- Review investigations into suspected frauds or material internal control failures and report such matters to the Board.

The Committee serves as a key link between the Internal Auditor, Statutory Auditor, and the Board of Directors, ensuring robust oversight of the Company's financial reporting and internal control framework. It reviews financial statements and related matters before they are presented to the Board for approval.

We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India ("ICAI") together with the ethical requirements that are relevant to our audit of the Ind AS financial statements under the provisions of the Act and the Rules made thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ICAI's Code of Ethics. We believe that the audit evidence obtained by us is sufficient and appropriate to provide a basis for our audit opinion on the Ind AS financial statements.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the Ind AS financial statements of the current period. These matters were addressed in the context of our audit of the Ind AS financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. We have determined the matters described below to be the key audit matters to be communicated in our report.

The other information comprises the information included in the Management Discussion and Analysis, Board's Report including Annexures to Board's Report, Corporate Governance and Shareholder's Information, but does not include the Ind AS financial statements and our auditor's report thereon.

Our opinion on the Ind AS financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the Ind AS financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the Ind AS financial statements or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

The Company's Board of Directors is responsible for the matters stated in section 134(5) of the Act with respect to the preparation of these Ind AS financial statements that give a true and fair view of the financial position, financial performance, including other comprehensive income, changes in equity and cash flows of the Company in accordance with the accounting principles generally accepted in India including the Indian Accounting Standards (Ind AS) specified under section 133 of the Act read with companies (Indian Accounting Standards) Rules, 2015, as amended.

This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the Ind AS financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

We consider quantitative materiality and qualitative factors in (i) planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatements in the Ind AS financial statements.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the Ind AS financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

 - iv. Proviso to Rule 3(1) of the Companies (Accounts) Rules, 2014 for maintaining books of accounts using accounting software which has a feature of recording audit trail (edit log) facility is applicable to the Company with effect from April 1 2023. Based on our examination which included test checks, the company has used accounting software for

maintaining its books of account which has a feature of recording audit trail (edit log) facility and the same has operated throughout the year for all relevant transactions recorded in the software. Further, during the course of our audit we did not come across any instance of audit trail feature being tampered with.

Mohit Paper Mills Limited (the 'Company' or 'MPML') is a public company incorporated under the provisions of the Companies Act 1956 with a CIN: L21093DL1992PLC116600, domiciled in India, with its registered office situated at 15A/13, Upper Ground Floor, East Patel Nagar, New Delhi – 110008, India. The equity shares are listed on the Bombay Stock Exchange ('BSE') in India.

The company's business primarily consists of manufacturing Writing & Printing Paper and Tissue Paper mainly in the domestic market. Soda Ash is recovered as by-product. The manufacturing facilities are situated in Bijnor, Uttar Pradesh.

2. Significant accounting policies**a. Basis of preparation of Financial Statements****(i) Statement of compliance**

These financial statements of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) prescribed under the Section 133 of the Companies Act, 2013 read with rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 (as amended from time to time) and presentation requirements of Division II of Schedule III of the Companies Act, 2013 (Ind AS Compliant Schedule III), as applicable to the financial statement.

Accordingly, the Company has prepared these Standalone Financial Statements which comprise the Balance Sheet as at 31 March 2026, the Statement of Profit and Loss, the Statement of Cash Flows and the Statement of Changes in Equity for the year ended as on that date, and accounting policies and other explanatory information (together hereinafter referred to as "Standalone Financial Statements" or "financial statements").

(ii) Basis of measurement:

The financial statements have been prepared on a historical cost basis, except for certain financial instruments which are measured at fair values or amortized cost depending upon classification. Historical cost is generally based on the fair value of the consideration given in exchange of goods or services.

(iii) Functional and presentation currency

The functional currency of the Company is the Indian Rupee ('INR'). These financial statements are presented in Indian rupees. All amounts have been rounded-off to the nearest lakhs, up to two places of decimal, unless otherwise indicated.

(iv) Use of estimates and judgments

The preparation of financial statements in conformity with Generally Accepted Accounting Principles (GAAP) requires management to make judgments, estimates and assumptions that impact the application of accounting policies and the reported amounts of assets, liabilities, income and expenses and the disclosure of contingent liabilities on the date of the financial statements. Actual results could differ from those estimates. Estimates and underlying assumptions are reviewed on an ongoing basis. Any revision to accounting

estimates is recognized prospectively in current and future periods. In particular, information about significant areas of estimation uncertainty & critical judgments in applying accounting policies that have the most significant effects on the amounts recognized in the financial statements is included in the following areas:

- Useful life of Property, plant and equipment - refer Note No. 2 c
- Valuation of Inventory - refer Note No. 2 f
- Estimation of Defined benefit obligation - refer Note No. 2 h
- Estimation of current tax expenses - refer Note No. 2 i
- Accounting for government grants - refer Note No. 2 o
- Provisions and Accruals - refer Note No. 2 r

Contingencies - refer Note No. 2 r

(v) Measurement of Fair value

The Company measures financial instruments at fair value as per Ind AS 113 at each balance sheet date. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either:

- In the principal market for the asset or liability, or
- In the absence of a principal market, in the most advantageous market for the asset or liability.

The principal or the most advantageous market must be accessible by the Company. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest. The fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximizing the use of relevant observable inputs and minimizing the use of unobservable inputs. All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorized within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1 - Quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly (i.e., as prices) or indirectly (i.e., derived from prices).

Level 3 - Inputs for the assets or liabilities that are not based on observable market data (unobservable inputs).

For assets and liabilities that are recognized in the financial statement on a recurring basis, the company determines whether transfers have occurred between levels in the hierarchy by

reassessing categorization (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

b. Recent accounting pronouncements

The Ministry of Corporate Affairs has vide notification dated 23 March 2024 notified Companies (Indian Accounting Standard) Amendment Rules, 2024 which amends certain accounting standards, and are effective 1 April 2024. These amendments are not expected to have a material impact on the Company in the current or future reporting periods and on foreseeable future transactions.

Schedule III Amendment applicable from April 1, 2021: On March 24, 2021, the Ministry of Corporate Affairs ("MCA") through a notification amended Schedule III of the Companies Act, 2013. The Company has prepared the financial statements in accordance with the said schedule

c. Property, plant and equipment ('PPE')

I Recognition and measurement

Items of property, plant and equipment are measured at cost, which includes capitalized borrowing costs, less accumulated depreciation and accumulated impairment losses, if any.

Cost of an item of property, plant and equipment comprises its purchase price, including import duties and non-refundable purchase taxes, after deducting trade discounts and rebates, any directly attributable cost of bringing the item to its working condition for its intended use and estimated costs of dismantling and removing the item and restoring the site on which it is located.

If significant parts of an item of property, plant and equipment have different useful lives, then they are accounted for as separate items (major components) of property, plant and equipment. Any gain or loss on disposal of an item of property, plant and equipment is recognized in profit or loss.

II Subsequent Expenditure

Subsequent expenditure is capitalized only if it is probable that the future economic benefits associated with the expenditure will flow to the Company.

III. Depreciation

Depreciation is calculated on carrying value recognized as per previous GAAP of items of property, plant and equipment and Intangible less their estimated residual values over their estimated useful lives using the written-down method and is generally recognized in the statement of profit and loss. Freehold land is not depreciated.

Depreciation method, useful lives and residual values are reviewed at each financial year-end and adjusted if appropriate. Based on technical evaluation and consequent advice, the management believes that its estimates of useful lives best represent the period over which management expects to use these assets. Depreciation has been provided on written down value method over their estimated useful lives.

Depreciation on additions/ (disposals) is provided on a pro-rata basis i.e. from/ (upto) the date on which asset is ready for use (disposed off) if any

iv. Derecognition

A property, plant and equipment are derecognized on disposal or when no future economic benefits are expected from its use and disposal. Losses arising from retirement and gains or losses arising from disposal of a tangible asset are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognized in the Statement of Profit and Loss.

d. Intangible assets

Intangible assets are initially measured at cost. These items of other intangible assets are subsequently measured at cost less accumulated amortization and accumulated impairment losses, if any. Cost of an item of Intangible asset comprises its purchase price, including import duties and non-refundable purchase taxes, after deducting trade discounts and rebates, any directly attributable cost of bringing the item to its working condition for its intended use.

Subsequent expenditure

Subsequent expenditure is capitalized only when it increases the future economic benefits embodied in the specific asset to which it relates. All other expenditure is recognized in Statement of Profit and Loss as incurred.

Amortization

Amortization is calculated to write off the cost of intangible assets over their estimated useful lives using the straight-line method, and is included in depreciation and amortization expense in Statement of Profit and Loss. The estimated useful life of Computer software is 3 years. Amortization method, useful life and residual values are reviewed at the end of each financial year and adjusted if appropriate.

De-recognition

Intangible assets are derecognized on disposal or when no future economic benefits are expected from its use and disposal.

e. Reclassification to investment property

When the use of a property changes from owner-occupied to investment property, the property is reclassified as investment property or vice versa at its carrying amount on the date of reclassification, if any. The company does not have any investment property as on the date of reporting.

f. Inventories

All inventories are initially recorded at cost. Cost represents all cost of purchase, cost of conversion and other costs incurred in bringing the inventories to their present location and condition. Cost for the purpose of valuation is determined by using the weighted average cost, net of taxes and duties eligible for credit and discounts.

Raw materials, stores, consumables and spare parts

Raw materials, stores, consumables and spare parts held for use in the production of finished products are not written down below cost except in cases where material prices have declined and it is estimated that the cost of the finished products will exceed their net realizable value.

Work-in-process

All work-in-process are valued at cost which includes cost of inputs, net of taxes and duties eligible for credit and overheads up to the stage of completion.

Finished goods

Finished goods are measured at lower of cost which includes cost of inputs (net of taxes and duties eligible for credits) & overheads and the net realizable value.

By-Products

By Products are measured at lower of cost which includes cost of inputs (net of taxes and duties eligible for credits) & overheads and the net realizable value.

g. Impairment**i. Impairment of non-financial assets**

A property, plant and equipment is derecognized on disposal or when no future economic benefits are expected from its use and disposal. Losses arising from retirement and gains or losses arising from disposal of a tangible asset are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognized in the Statement of Profit and Loss.

The carrying amounts of the Company's non-financial assets, other than inventories and deferred tax assets are reviewed at each reporting date to determine whether there is any indication of impairment. If any such indication exists, then the asset's recoverable amount is estimated. The recoverable amount of an asset or cash-generating unit is the greater of its value in use and its fair value less costs to sell. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset or the cash-generating unit.

For the purpose of impairment testing, assets are grouped together into the smallest group of assets that generates cash inflows from continuing use that are largely independent of the cash inflows of other assets or groups of assets (the "cash-generating unit").

An impairment loss is recognized in the statement of profit and loss if the estimated recoverable amount of an asset or its cash-generating unit is lower than its carrying amount. Impairment losses, other than those recognized on goodwill, that have been recognized in prior periods are assessed at each reporting date for any indications that the loss has decreased or no longer exists. An impairment loss is reversed if there has been a change in the estimates used to determine the recoverable amount. An impairment loss is reversed only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortization, if no impairment loss had been recognized.

ii. Impairment of financial instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

Financial Assets**Initial Recognition and Measurement**

All financial assets are recognized initially at fair value plus, in the case of financial assets not

recorded at fair value through profit and loss, transaction costs that are attributable to the acquisition of the financial assets. Financial assets are classified, at initial recognition, as financial assets measured at fair value or as financial assets measured at amortized cost.

Subsequent Measurement

For purpose of subsequent measurement financial assets are classified in two broad categories:

- Financial Assets at fair value
- Financial assets at amortized cost

Where assets that measured at fair value, gains and losses are either recognized entirely in the statement of profit and loss or recognized in other comprehensive income.

A financial asset that meets the following two conditions is measured at amortized cost:

- Business Model Test: The objective of the company's business model is to hold the financial asset to collect the contractual cash flows.
- Cash flow characteristics test: The contractual terms of the financial asset give rise on specified dates to cash flows that are solely payment of principal and interest on the principal amount outstanding.

A financial asset that meets the following two conditions is measured at fair value through OCI:

- Business Model Test: The financial asset is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets.
- Cash flow characteristics test: The contractual terms of the financial asset give rise on specified dates to cash flows that are solely payment of principal and interest on the principal amount outstanding.

All other financial asset is measured at fair value through profit and loss.

All equity investments are measured at fair value in the balance sheet, with value changes recognized in the statement of profit and loss, except for those equity investments for which the entity has elected irrevocable option to present value changes in OCI.

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognized (i.e., removed from the Company's balance sheet) when:

- The rights to receive cash flows from the asset have expired, or
- The Company has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a 'pass-through' arrangement; and either (a) the Company has transferred substantially all the risks and rewards of the asset, or (b) the Company has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Company has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if and to what extent it has retained the risks and rewards of ownership. When it has neither transferred nor retained substantially all the risks and rewards of the asset, nor transferred control of the asset, the Company continues to recognize the transferred asset to the extent of the Company's continuing involvement. In that case, the

Company also recognizes an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Company has retained.

Impairment of financial assets

In accordance with Ind AS 109, the Company applies expected credit loss (ECL) model for measurement and recognition of impairment loss on the trade receivables or any contractual right to receive cash or another financial asset that result from transactions that are within the scope of Ind AS 115.

For this purpose, the Company follows 'simplified approach' for recognition of impairment loss allowance on the trade receivable balances. The application of simplified approach does not require the Company to track changes in credit risk. Rather, it recognizes impairment loss allowance based on lifetime ECLs at each reporting date, right from its initial recognition.

As a practical expedient, the Company uses a provision matrix to determine impairment loss allowance on portfolio of its trade receivables. The provision matrix is based on its historically observed default rates over the expected life of the trade receivables and is adjusted for forward-looking estimates. At every reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analyzed.

Financial Liabilities:

All financial liabilities are initially recognized at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

Financial liabilities are classified as measured at amortized cost or FVPL. A financial liability is classified as FVPL if it is classified as held for trading, or it is derivative or is designated as such on initial recognition. Financial liabilities at FVPL are measured at fair value and net gain or losses, including any interest expense, are recognized in statement of profit and loss. Other financial liabilities are subsequently measured at amortized cost using the effective interest method. Interest expense and foreign exchange gains and losses are recognized in statement of profit and loss.

The Company's financial liabilities include trade and other payables, loans and borrowings including bank overdrafts and derivative financial instruments.

Offsetting of financial instruments

Financial assets and financial liabilities are offset, and the net amount is reported in the financial statements if there is a currently enforceable legal right to offset the recognized amounts and there is an intention to settle on a net basis, to realize the assets and settle the liabilities simultaneously.

Measurement of expected credit losses

Expected credit losses are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all cash short falls (i.e. the difference between the cash flows due to the Company in accordance with the contract and the cash flows that the company expects to receive).

Presentation of allowance for expected credit losses in the balance sheet and loss allowances for financial assets measured at amortized cost are deducted from the gross carrying amount of the assets.

Write-off

The gross carrying amount of a financial asset is written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the Company determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off. However, financial assets that are written off could still be subject to enforcement activities in order to comply with the Company's procedures for recovery of amounts due.

h. Employee benefits**I Short-term employee benefits**

Short-term employee benefit obligations are measured on an undiscounted basis and are expensed as the related service is provided. A liability is recognized for the amount expected to be paid e.g. under short-term cash bonus / Ex-gratia, if the Company has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee, and the amount of obligation can be estimated reliably.

II. Defined contribution plan

A defined contribution plan is a post-employment benefit plan under which an entity pays fixed contributions into a separate entity and will have no legal or constructive obligation to pay further amounts. Obligations for contributions to defined contribution plans are recognized as an employee benefit expense in profit or loss in the periods during which the related services are rendered by employees and payments due from the company.

III. Defined benefit plan

The Company pays specified monthly contribution to provident fund (PF) and employee's state insurance (ESI). Contributions to these schemes are expensed in the Statement of Profit & Loss. These contributions are made to the fund administered and managed by the Government of India. The Company has no further obligations under these plans beyond its monthly contributions.

Gratuity

Liabilities in respect of defined benefit plan in the form of Gratuity and Long-term compensated absences are determined based on projected unit credit method as at the balance sheet date and are unfunded.

Group Gratuity cum Life Assurance Scheme with the Life Insurance Corporation of India has been taken in such a way that the gratuity benefits will be payable under an irrevocable trust. The trustees appointed for the purpose of administering the Scheme ensure gratuity benefits is with the LIC. The company shall pay on demand by and to the LIC such contributions as are required to secure Gratuity benefits to the employees.

The employee's gratuity fund scheme is managed by the Life Insurance Corporation of India is a defined benefit plan. The present value of obligation is determined based on Projected Unit Credit Method, which recognizes each period of services as giving rise to additional unit if there is employee benefit entitlement and measures each unit separately to build up the final obligation in terms of the demand raised by them.

Re-measurements of the net defined benefit liability if any, is recognized in OCI.

I. Taxes on Income

Income tax comprises current and deferred tax. It is recognized in the statement of profit or loss except to the extent that it relates to an item recognized directly in equity or in other comprehensive income.

I. Current tax

Current tax comprises the expected tax payable or receivable on the taxable income or loss for the year and any adjustment to the tax payable or receivable in respect of previous years. The amount of current tax reflects the best estimate of the tax amount expected to be paid or received after considering the uncertainty, if any, related to income taxes. It is measured using tax rates (and tax laws) enacted or substantively enacted by the reporting date.

Current tax assets and current tax liabilities including MAT are offset only if there is a legally enforceable right to set off the recognized amounts, and it is intended to realize the asset and settle the liability on a net basis simultaneously.

II. Deferred tax

Deferred tax is recognized in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the corresponding amounts used for taxation purposes. Deferred tax is also recognized in respect of carried forward tax losses and tax credits.

Deferred tax assets are recognized to the extent that it is probable that future taxable profits will be available against which they can be used. An existence of unused tax losses is strong evidence that future taxable profit may not be available. Therefore, in case of a history of recent losses, the Company shall recognize deferred tax asset only to the extent that it has sufficient taxable temporary differences or there is convincing other evidence that sufficient taxable profit will be available against which such deferred tax asset can be realized.

Deferred tax assets – unrecognized or recognized, are reviewed at each reporting date and are recognized / reduced to the extent that it is probable / no longer probable respectively that the related tax benefit will be realized.

Deferred tax is measured at the tax rates that are expected to apply to the period when the asset is realized or the liability is settled, based on the laws that have been enacted or substantively enacted by the reporting date.

The measurement of deferred tax reflects the tax consequences that would flow from the manner in which the Group expects, at the reporting date, to recover or settle the carrying amount of its assets and liabilities.

Deferred tax assets and liabilities are taken into account if there is a legally enforceable right to offset total deferred tax liabilities and deferred tax assets, and they relate to income taxes levied by the same tax authority on the same taxable entity, or on different tax entities if allowable, but they intend to settle deferred tax liabilities and assets and are correspondingly reflected as deferred tax assets and liabilities which will/may be realized simultaneously.

III. Minimum Alternative tax ("MAT")

Minimum Alternative tax ("MAT") under the provisions of Income-tax Act, 1961 is recognized as current tax in profit or loss. The credit available under the Act in respect of

MAT paid is adjusted from deferred tax liability only when and to the extent there is convincing evidence that the company will pay normal income tax during the period for which the MAT credit can be carried forward for set-off against the normal tax liability. MAT credit recognized adjusted from deferred tax liability is reviewed at each balance sheet date and written down to the extent the aforesaid convincing evidence no longer exists.

j. Cash and cash equivalents

Cash and cash equivalent in the balance sheet comprise cash at banks and on hand and short-term deposits with an original maturity of three months or less, which are subject to an insignificant risk of changes in value. For the purpose of the statement of cash flows, cash and cash equivalents consist of cash and short-term deposits, as defined above, net of outstanding bank overdrafts as they are considered an integral part of the Company's cash management.

Cash flow statement

Cash flows are reported using the indirect method, whereby profit for the period is adjusted for the effects of transactions of a non-cash nature, any deferrals or accruals of past or future operating cash receipts or payments and item of income or expenses associated with investing or financing cash flows. The cash flows from operating, investing and financing activities of the Company are segregated.

k. Earnings per share

Basic earnings/ (loss) per share are calculated by dividing the net profit/ (loss) for the year attributable to equity shareholders by the weighted average number of equity shares outstanding during the year. The weighted average number of equity shares outstanding during the period is adjusted for events of bonus issue and share split. For the purpose of calculating diluted earnings/ (loss) per share, the net profit or loss for the period attributable to equity shareholders and the weighted average number of shares outstanding during the year are adjusted for the effects of all dilutive potential equity shares.

l. Foreign currency transactions

i. Initial recognition

Transactions in foreign currencies are translated into the functional currency of the Company at the exchange rates at the dates of the transactions.

ii. Measurement at the reporting date

Monetary assets and liabilities denominated in foreign currencies are translated into the functional currency at the exchange rate at the reporting date. Non-monetary assets and liabilities that are measured at fair value in a foreign currency are translated into the functional currency at the exchange rate when the fair value was determined. Non-monetary assets and liabilities that are measured based on historical cost in a foreign currency are translated at the exchange rate at the date of the transaction. Exchange differences on restatement/settlement of all monetary items are recognized in profit or loss.

m. Financial Instruments

Financial assets and financial liabilities are recognized when the Company becomes a party to the contractual provisions of the relevant instrument and are initially measured at initial cost and for investments held for trading or held for sale at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities measured at fair value through profit or loss) are

added to or deducted from the fair value on initial recognition of financial assets or financial liabilities if required. Purchase or sale of financial assets that require delivery of assets within a time frame established by regulation or convention in the market place (regular way trades) are recognized on the trade date, i.e., the date when the Company commits to purchase or sell the asset.

Financial Assets

Recognition and Measurement

All Financial assets include Investments, Trade Receivables, Advances, Security Deposits, Cash and Cash equivalents. Such assets are initially recognized at transaction price when the Company becomes party to contractual obligations. The transaction price includes transaction costs unless the asset is being fair valued through the Statement of Profit and Loss.

Classification

Management determines the classification of an asset at initial recognition depending on the purpose for which the assets were acquired. The subsequent measurement of financial assets depends on such classification.

Financial assets are classified as those measured at

- (i) amortised cost, where the financial assets are held solely for collection of cash flows arising from payments of principal and / or interest.
- (ii) At cost price where the investments are to be held for long term with no immediate intention for sale and continue to be recognized at cost.
- (iii) fair value through other comprehensive income (FVTOCI), where the financial assets are held not only for collection of cash flows arising from payments of principal and interest but also from the sale of such assets or are held for trading or for sale. Company does not have any assets for sale. Such assets are subsequently measured at fair value, with unrealised gains and losses arising from changes in the fair value being recognized in other comprehensive income.

Fair value through profit or loss (FVPL), where the assets are managed in accordance with an approved investment strategy that triggers purchase and sale decisions based on the fair value of such assets. Company does not have any assets which are managed as investment strategy. Such assets are subsequently measured at fair value, with unrealized gains and losses arising from changes in the fair value being recognized in the Statement of Profit and Loss in the period in which they arise.

Trade Receivables, Advances, Security Deposits, Cash and Cash equivalents etc. are classified for measurement at amortised cost. In respect of particular investments in equity instruments that would otherwise be measured at fair value through profit or loss, an irrevocable election at initial recognition is made to present subsequent changes in fair value through other comprehensive income.

Impairment

The Company assesses at each reporting date whether a financial asset (or a group of financial assets) such as investments, trade receivables, advances and security deposits held at amortised cost and financial assets that are measured at fair value through other comprehensive income are tested for impairment based on evidence or information that is available without undue cost or effort. Expected credit losses are assessed and loss allowances recognized if the credit quality

of the financial asset has deteriorated significantly since initial recognition.

Reclassification

When and only when the business model is changed, the Company shall reclassify all affected financial assets prospectively from the reclassification date as subsequently measured at amortised cost, fair value through other comprehensive income, fair value through profit or loss without restating the previously recognized gains, losses or interest and in terms of the reclassification principles laid down in the Ind AS relating to Financial Instruments.

De-recognition

Financial assets are derecognized when the right to receive cash flows from the assets has expired, or has been transferred, and the Company has transferred substantially all of the risks and rewards of ownership. Concomitantly, if the asset is one that is measured at:

- (a) amortised cost, the gain or loss is recognized in the Statement of Profit and Loss;
fair value through other comprehensive income, the cumulative fair value adjustments previously taken to reserves are reclassified to the Statement of Profit and Loss unless the asset represents an equity investment which is taken at initial cost and continues to be so taken and for other investments in which case the cumulative fair value adjustments previously taken to reserves is reclassified within equity.

n. Revenue

Revenue is measured at the fair value of the consideration received or receivable after netting trade discounts, taxes volume discounts and sales returns. Revenue from sale of goods is recognized when significant risks and rewards have been transferred to buyer.

Liquidated damages and penalties recovered from suppliers / contractors, in relation to property, plant and equipment are credited to statement of profit and loss unless the delay has resulted in extra cost of assets, in which case the same are adjusted towards the carrying cost of the respective asset.

Interest Income

Interest income primarily comprises of interest from term deposits. Interest income is accrued on time basis, by reference to the principal outstanding and at the effective interest rate applicable (provided that it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably).

Other Income

Other income is recognized when no significant uncertainty as to its determination or realization exists.

o. Government grants

Government grants are recognized initially at fair value when there is reasonable assurance that they will be received and the Company will comply with the conditions associated with grant. They are then recognized in profit or loss as other income on a systematic basis over the periods in which the company recognizes as expenses the related costs for which the grant is intended to compensate. Government grants related to depreciable capital assets is recognized in profit or loss over the useful life of the asset and in the proportions in which depreciation expense on those assets is recognized.

p. Borrowing cost

Borrowing costs are interest and other costs incurred in connection with the borrowing of fund.

Borrowing costs directly attributable to acquisition or construction of an asset which necessarily take a substantial period of time to get ready for their intended use are capitalized as part of the cost of that asset. Other borrowing costs are recognized as an expense in the period in which they are incurred.

q. Operating segments

An operating segment is a component of the Company that engages in business activities from which it may earn revenues and incur expenses, including revenues and expenses that relate to transactions with any of the Company's other components, and for which discrete financial information is available. All operating segments' operating results are reviewed regularly by the Company's Chief Operating Decision Maker (CODM) to make decisions about resources to be allocated to the segments and assess their performance.

The Company is primarily engaged in the business of manufacture and sales of paper, mainly in the domestic market.

The Board of directors of the Company, who have been identified as being the chief operating decision maker (CODM), evaluated the company's performance and allocated resources based on the analysis of various performance indicators of the Company as a single unit. Accordingly, there is no reportable segment or any entity wide disclosure which are applicable to the company.

r. Provisions, Contingent Liabilities and Contingent Assets

A provision is recognized if, as a result of a past event, the Company has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. If the effect of the time value of money is material, provisions are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. Where discounting is used, the increase in the provision due to the passage of time is recognized as a finance cost.

Contingent Liabilities

A contingent liability exists when there is a possible obligation, or a present obligation that may, but probably will not require an outflow of resources, or a present obligation whose amount cannot be estimated reliably. Contingent liabilities do not warrant provisions, but are disclosed unless the possibility of outflow of resources is remote.

Contingent assets usually arise from unplanned or other unexpected events that give rise to the possibility of an inflow of economic benefits to the entity. Contingent assets are recognized when the realisation of income is virtually certain, then the related asset is not a contingent asset and its recognition is appropriate.

A contingent asset is disclosed where an inflow of economic benefits is probable.

s. Commitments

Commitments include the amount of purchase order (net of advances) issued to parties for completion of assets. Provisions, contingent liabilities, contingent assets and commitments are reviewed at each reporting date.

t. Ind AS 116 – Leases

The Company does not have any finance leases. There are no instances in which the company is a lessor.

Hence there is no impact on adoption of Ind AS 116.

The Company's audit committee oversees how management monitors compliance with the company's risk management policies and procedures, and reviews the adequacy of the risk management framework in relation to the risks faced by the company. The audit committee is assisted in its oversight role by internal audit. Internal audit undertakes both regular and ad hoc reviews of risk management controls and procedures, the results of which are reported to the audit committee.

ii) Credit Risk

Credit risk is the risk of financial loss to the company if a customer or counterparty to a financial instrument fails to meet its contractual obligations, and arises principally from the company's receivables from customers and loans. The carrying amounts of financial assets represent the maximum credit risk exposure.

iii) Trade receivables

The Company has established a credit policy under which each new customer is analyzed individually for creditworthiness before the payment and delivery terms and conditions are offered. The Company's review includes external ratings, if they are available, financial statements, credit agency information, industry information and business intelligence. The Company evaluates the customer credentials carefully from trade sources before appointment of any distributor and only financially sound parties are appointed as distributors. The Company secures adequate deposits from its distributor and hence risk of bad debt is limited. The credit outstanding is sought to be limited to the sum of advances/deposits and credit limit determined by the company.

The Company based on internal assessment which is driven by the historical experience/ current facts available in relation to default and delays in collection thereof, the credit risk for trade receivables is considered low. The Company estimates its allowance for trade receivable using lifetime expected credit loss. Individual receivables which are known to be uncollectible are written off by reducing the carrying

amount of trade receivable and the amount of the loss is recognized in the Statement of Profit and Loss within other expenses.

Concentration of significant credit risk

The ageing of outstanding balance of receivables having more than 10% concentration of credit is within 30 days, and the transactions with them are at arm's length. There is no risk of credit concentration as far as transactions with them are concerned.

Management manages the liquidity risk by monitoring cash flow forecasts on a periodic basis and maturity profiles of financial assets and liabilities. This monitoring takes into account the accessibility of cash and cash equivalents and additional undrawn financing facilities.

b. Defined contribution plan

The Company's provident fund scheme and employee's state insurance (ESI) fund scheme are defined contribution plans. The Company has recorded expenses of 31.42 lakhs (31.03.2025: 24.69 lakhs) under provident fund scheme and 8.38 lakhs (31.03.2025: 8.56 lakhs) under ESI scheme. These have been included in note 25 employees' benefits expenses, in the Statement of Profit and Loss.

c. Defined plan
Gratuity (funded)

The employees' gratuity fund scheme managed by Life Insurance Corporation of India is a defined benefit plan. The present value of obligation is determined based on actuarial valuation using the Projected Unit Credit Method, which recognizes each period of service as giving rise to additional unit of employee benefit entitlement and measures each unit separately to build up the final obligation. The Company made annual contributions to the LIC of India.

The above defined benefit plan exposes the Company to following risks:

Interest rate risk:

The defined benefit obligation calculated uses a discount rate based on government bonds. If bond yields fall, the defined benefit obligation will tend to increase.

Salary inflation risk:

Higher than expected increase in salary will increase the defined benefit obligation.

Demographic risk:

This is the risk of variability of results due to unsystematic nature of decrements that include mortality, withdrawal, disability and retirement. The effect of these decrements on the defined benefit obligation is

not straight forward and depends upon the combination of salary increase, discount rate and vesting criteria. It is important not to overstate withdrawals because in the financial analysis the retirement benefit of a short career employee typically costs less per year as compared to a long service employee.

The Company actively monitors how the duration and the expected yield of the investments are matching the expected cash outflows arising from the employee benefit obligations. The Company has not changed the processes used to manage its risks from previous periods. The funds are managed by specialized team of Life Insurance Corporation of India.

Funding

Gratuity is a funded benefit plan for qualifying employees. 35% of the plan assets are managed by LIC and balance managed by the management. The assets managed are highly liquid in nature and the Company does not expect any significant liquidity risks.
