ORDER

(Hybrid Mode)

06.07.2026: Heard both sides briefly. The three Real Estate Companies belong to the same group of which two are exposed to CIRP.

2. Mr. Abhijeet Sinha, the Learned Senior Counsel appearing for 'Ideal Real Estate Private Limited' and 'Ideal Unique Realtors Pvt. Ltd' both Real Estate Companies which are admitted to CIRP makes a statement that the Bank is about to sell the debt to certain ARCs and that is likely to put the hope on the efforts of the Real Estate Company to settle the matter.

3. Mr. Gopal Jain, Learned Senior Counsel appearing for the Respondent makes a statement on instructions that there is no proposal to sell or assign the debt to any ARC and the earlier two proposals of the Corporate Debtor have been rejected.
