O R D E R

1. Delay in filing/refiling is condoned.
2. Permission to file Miscellaneous Applications/Contempt Petition(s) is granted.

3. Applications for substitution are allowed after condoning the delay and setting aside the abatement. Cause title be amended accordingly.

Contempt Petition(C) Diary No.75518/2025 (It.46.45)

4. At this stage, we are informed that despite judgment dated 10.07.2024 passed in C.A. Nos.3674-3675/2023, the enhanced compensation has not been paid to the successful landowners.

5. In the interest of justice, we grant three months' more time to NOIDA to do the needful, failing which there will be punitive action against the responsible officers/authorities.

6. The Contempt Petition(s) is, accordingly, disposed of.

Rest of the matters

7. These Miscellaneous Applications have been moved by landowners whom the High Court had granted compensation at the rate of Rs.340 per sq. yd. Moreover, these applicants are those who did not approach this Court for further enhancement originally.

8. However, the similarly placed landowners, whose lands were also acquired in the same village through the same acquisition process, approached this Court through a batch of appeals, which were allowed *vide* judgment dated

10.07.2024 and compensation was enhanced from Rs.340 per sq. yd. to Rs.403 per sq. yd.

9. Pursuant thereto, the instant applicants have also filed these Miscellaneous Applications on 06.09.2024, seeking parity in the matter of grant of higher compensation.

10. Shri Ravinder Kumar, learned Senior Counsel for NOIDA, has vehemently opposed these prayers, as according to him, neither the Miscellaneous Applications are maintainable nor the applicants, who had earlier accepted the rate of Rs.340 per sq. yd., can be permitted to turn around and seek a higher compensation at this belated stage.

11. Upon consideration of the rival submissions, we are satisfied that the applicants are entitled to seek parity with the similarly placed landowners, primarily on the anvil of Article 14 of the Constitution of India and claim the same rate of compensation. However, the principles of equity can be balanced by directing that the applicants shall not be entitled to any interest for the delayed period.

12. Consequently, the Miscellaneous Applications are allowed and the applicants are also held entitled to compensation at the rate of Rs.403 per sq. yd.; however, the statutory interest on such enhanced compensation shall be admissible to them only from the date they approached this Court by way of the appropriate applications.

13. NOIDA is directed to calculate and pay the enhanced

compensation to the applicants within a period of three months.
