Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that RCCPL Private Limited (RCCPL), a wholly owned material subsidiary of the Company, has received a Show Cause Notice from the Additional Commissioner, Central Goods & Services Tax and Central Excise, Jabalpur, in connection with availment of excess/ ineligible Input Tax Credit for the financial year 2022-23.

The said intimation was received by the Company on 18th September, 2026 at around 11.34 p.m. (IST).

1	Brief details of litigation/ dispute viz. name(s) of the opposing party, court/ tribunal/agency where litigation is filed, brief details of dispute/litigation;	A Show Cause Notice (SCN) has been received by RCCPL Private Limited (RCCPL), a wholly owned material subsidiary of the Company, from the Additional Commissioner, Central Goods & Services Tax (CGST) and Central Excise, Jabalpur, proposing recovery of alleged excess/ ineligible availment of Input Tax Credit amounting to ₹15,02,51,383/-, along with applicable interest and penalty for the financial year 2022-23 in contravention of Section 16(4) of the CGST Act, 2017 read with Section 20 of the IGST Act, 2017. The SCN pertains to non-reflection of Bills of Entry in GSTR-2B during the respective tax periods in which the credit was availed, which were subsequently reflected in GSTR-2B after expiry of the statutory time limit prescribed under Section 16(4) of the CGST Act, 2017.
2	Expected financial implications, if any, due to compensation, penalty etc.;	The Company believes that the SCN has no merits, and the Company shall make its submissions before the Adjudicating Authority within the given timelines. There is no impact on the financial, operations or other activities of RCCPL at this stage arising from the SCN.
