1. We heard Mr. Jayant K. Mehta, the learned senior counsel appearing for the appellant and Mr. Amit Anand Tiwari, the learned senior counsel appearing for the respondent.

The principal question that falls for our consideration in the present appeals is whether the proceeding(s) instituted in the year 2013 and statutorily transferred as existing proceedings under Section 434(1)(c) of the Companies Act, 2013, can be treated as a fresh application instituted only upon filing of Form-5 after transfer, so as to attract the monetary threshold introduced later in point of time after the original institution of the proceeding.
3. The Matter requires consideration.
4. We permit the learned counsel appearing for the appellant to implead Union of India as party respondent no.2 in all the matters.
5. Cause title be amended accordingly.
6. Issue notice.
7. Dasti service, in addition, is permitted.
8. List the matter(s) on 24.9.2026 for final disposal.
