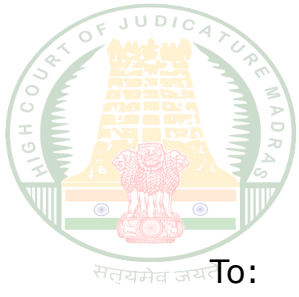
JUDGMENT
