A W A R D

1. Heard Mr. Deepak Yadav, learned counsel appearing for the petitioners and Mr. Rajesh Kumar Gupta, learned counsel for respondent No.3-New India Insurance Company Limited instructed by Mr. Gopal Juneja, Regional Manager, New India Insurance Company Limited. The parties have arrived at a settlement during the course of hearing.

2. It is agreed that respondent No.3-Insurance Company shall pay a consolidated amount of Rs.10,00,000/- (Rupees ten lakhs) over and above the amount awarded by the High Court to the petitioners in full and final settlement of all their claims. The petitioners agree that on receipt of the consolidated amount of Rs.10,00,000/- (Rupees ten lakhs) over and above the amount awarded by High Court, the petitioners will have no further claim against the Insurance Company.

2. The additional compensation of Rs.10,00,000/- (Rupees ten lakhs) shall be paid to the petitioners. The petitioners shall furnish the account details to respondent No.3. On due verification, the amount of Rs.10,00,000/- (Rupees ten lakhs) shall be transferred to the petitioners within a period of 30 days.

4. The Special Leave Petition is disposed of in the above terms.

5. We place on record our appreciation for Mr. Rajesh Kumar Gupta, learned counsel and Mr. Gopal Juneja, Regional Manager for the positive and spontaneous response they have shown in settling the matter.
