A W A R D

agreed to accept additional Rs.20,00,000/- towards global compensation (without any interest payable thereon) from the respondent(s)-Insurance Company.

2. The respondent(s)-Insurance Company is agreeable to deposit the said amount within a period of six weeks from today.

3. On such deposit being made, a sum of Rs.15,00,000/- shall be deposited in any interest bearing fixed deposit account in any nationalised bank or post office account for an initial period of five years.

4. The petitioner shall be entitled to withdraw periodical interest on the said amount.

5. The balance amount shall be released to the petitioner after due verification.

6. We appreciate and place on record the cooperation extended by the learned counsel for the petitioner as well as the learned counsel for the respondent(s)-Insurance Company and the officers of the Insurance Company.

7. Recording the aforesaid settlement, the Special Leave Petition is disposed of.

8. The aforesaid settlement shall be read as a part and parcel of this order.

9. Registry is directed to draw up an award accordingly.
