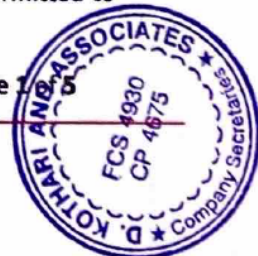

1. I, Dhanraj Kothari, Proprietor of D.
