Subject: Reply to the clarification sought by the Exchange on significant movement in the price of the equity shares of Tahmar Enterprises Limited Reference: Clarification sought by the Exchange on 16th September 2026.

Dear Sir(s),

This is with reference to the clarification sought by the Exchange on 16th September 2026 with regard to the significant movement in the price of the equity shares of Tahmar Enterprises Limited ("the Company"), and in terms of Regulation 30(11) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations").

In this regard, the Company wishes to state as follows:

1. The Company has been making all necessary disclosures of events and information required under Regulation 30 and the other applicable provisions of the Listing Regulations from time to time, and the same are available on the website of the Exchange and on the Company's website. All such disclosures made by the Company are in the public domain.
2. The Company has, by its intimation dated 16th September 2026 filed under Regulation 30 of the Listing Regulations, disclosed to the Exchange the grant of the licence for manufacture of Indian Made Foreign Liquor (IMFL) at its distillery at Gadhinglaj, District Kolhapur. The Company has further, by its intimation dated 9th September 2026 filed under Regulation 29 of the Listing Regulations, informed the Exchange that a meeting of its Board of Directors is scheduled to be held on 21st September 2026, inter alia to consider and evaluate the expressions of interest received in respect of the Company's distillery undertaking. The said meeting is yet to be held. No decision has been taken by the Board, and no binding agreement, memorandum of understanding or other commitment in respect of the distillery undertaking or otherwise has been entered into by the Company. The outcome of the said meeting, and any event or information arising therefrom requiring disclosure under the Listing Regulations, shall be disclosed to the Exchange within the prescribed time.
