**UPON hearing the counsel the Court made the following
O R D E R**

1. Heard in part.
2. The State of Gujarat is required to file an affidavit by 4:00 p.m. tomorrow, i.e., 23rd September, 2026, placing on record documents relating to taking over of possession of the disputed/acquired land from the landowners including the notice under Section 12(2) of the Land Acquisition Act, 1894, purported to have been re-served on the landowners on 2nd January, 2007, reference whereof is found in paragraph 17 of the impugned judgment.

3. The State must also indicate the extent of land out of the disputed/acquired land that was made over to the Company and the relevant date together with supporting documents.
4. The State shall also indicate whether any remaining part of the disputed/acquired land was offered to the Company for taking possession and whether the Company refused to accept such possession.
5. The landowners shall also file an affidavit by 4:00 p.m. tomorrow placing on record the civil application praying for injunction filed in January, 2007, reference whereof is made in paragraph 21 of the judgment and order dated 27th April, 2015 of the Division Bench of the High Court. They shall also place on record the interim order of *status quo* which was first passed by the High Court on their writ petition, i.e., Special Civil Application No.21046/2005.
6. Copies of such affidavits must be made over to the learned Advocate-on-Record for the Company not beyond 2 hours after the same are filed.
7. Relist the special leave petitions on 24th September, 2026 at 3:30 PM.
