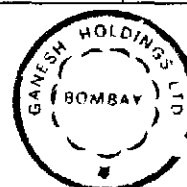

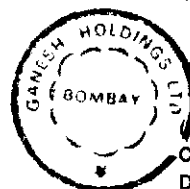

Limited Review Report

1.
