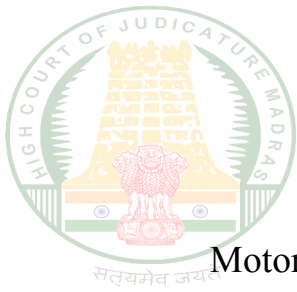

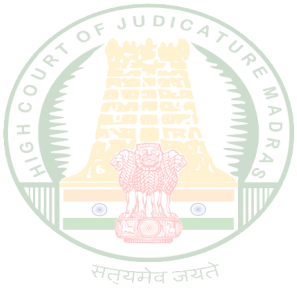
Motor Accidents Claims Tribunal / Special District Judge (MACT) of Madurai and take the appeal into file.

2. Accordingly, this Civil Miscellaneous Petition is dismissed for default and the Civil Miscellaneous Appeal is rejected at the SR stage itself.

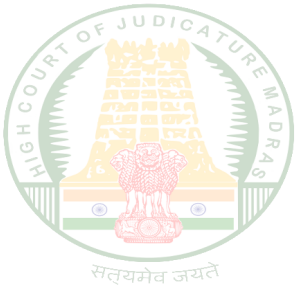
