Chennai, 02nd July 2026: Arihant Foundations & Housing Limited (NSE: ARIHANT | BSE: 531381), a Chennai-based real estate developer, today announced the outright acquisition of a prime land parcel measuring over half an acre on Mount Road (Anna Salai), in the heart of the city's central business district and adjacent to the Hyatt Regency Chennai. The Company plans to develop a boutique Grade A commercial office project on the site, with an estimated Gross Development Value of ₹300 crore.

The Company considers the acquisition a strategic addition to its commercial portfolio in central Chennai.
