UPON hearing the counsel the Court made the following
O R D E R

1. Special Leave Petition (C) D. No. 38095 of 2017 is listed along with the lead matter i.e. Civil Appeal No. 62 of 2018.
2. Delay in filing the Special Leave Petition is condoned. Leave granted.
3. Issue Notice.
4. When the Special Leave Petition (C) D. No. 38095 of 2017 came up for admission on 12.01.2018, this Court merely directed it to be

posted along with Civil Appeal No. 62 of 2018. Apparently, notice was not issued. Therefore, the Special Leave Petition is listed today before us along with the Civil Appeal No. 62 of 2018, and there is no representation of the respondents, naturally as notice has not been issued. Though, the first respondent in the Civil Appeal and the Special Leave Petition are one and the same, being Food Corporation of India represented by Mr. Abhay Kumar, respondent no.2 in the Special Leave Petition, namely Projects and Equipment Corporation of India Limited remains unrepresented as notice was not served.

5. The judgment in the Special Leave Petition is different from the judgment in the Civil Appeal. Under these circumstances, we have no option but to direct the petitioner to undertake dasti notice on respondent no.2. Additionally, a copy of the Special Leave Petition will also be served on the Central Agency to represent Projects and Equipment Corporation of India Limited, a Public Sector Undertaking under the Ministry of Commerce and Industry.
