O R D E R

We have heard the learned counsel appearing for the parties.

Learned counsel appearing for the parties submit that in view of the subsequent developments, the issue can be resolved between the petitioner and the respondent No.1, either by directing the Ameen of the District Court to carry out a measurement and

demarcation of the respective plots with the assistance of a Revenue Officer and in the presence of the parties.

In view of the joint submission, the impugned order stands set aside, and the Special Leave Petition stands disposed of, by directing the Ameen of the District Court to undertake such exercise of measuring, and demarcating the respective plots of the petitioner and respondent No.1 in their presence, with the assistance of the Revenue Officer.

The needful will have to be done within a period of eight weeks from the date of receipt of a copy of this order. On the basis of the said exercise to be undertaken by the Ameen, the Trial Court shall pass appropriate orders.

The Special Leave Petition stands disposed of, accordingly.
