UPON hearing the counsel the Court made the following
O R D E R

1. We heard Mr. Shyam Divan, the learned Amicus, and all other

learned counsel appearing in this litigation.

2. We would like to know the current status insofar as the criminal case pending in Court No.20, Designated Judge, MPID Court for Greater Bombay City Civil and Sessions Court, Mumbai is concerned.

3. We are informed that charge-sheets have been filed.

4. We are further informed that some of the accused are still absconding. If charge-sheets have been filed, then it is expected of the court concerned to now proceed further with the framing of charge.

5. Registry is directed to call for a fresh report from the court concerned as regards the current status.

6. Mr. N.Venkataraman, the learned ASG has appeared today on behalf of the Enforcement Directorate as directed. The Enforcement Directorate has filed its report of the investigation.

7. Registry shall furnish one copy of the entire report filed by the Enforcement Directorate to Mr. Divan, the learned Amicus at the earliest.

8. Mr. S. Niranjan Reddy, the learned senior counsel appearing for the SEBI submitted that report at his end has also been filed with the Registry of the Court and copy of which has been furnished to the learned Amicus.

9. We also heard Mr. Nakul Dewan, the learned senior counsel

appearing for two applicants namely “(1) Aanya Properties (2) Limited And (2) Access Investments India”. These two applicants have preferred I.A. Nos. 102331/2026 and praying for the following reliefs:-

a) Direct SEBI/SMC to conduct an immediate and time-bound valuation of the Mirah Group's 38.20% interest in LIPL and subsequently put the MGI for sale;

b) Alternatively, direct SEBI/SMC to reconsider and accept the Applicants' previous offer of Rs. 15 Crores dated 01.05.2024 to purchase the MGI to facilitate the disassociation of LIPL from the Corporate Debtor and allow the project to continue untainted;

10. We heard the learned Amicus insofar as the I.A. referred to above is concerned and the reliefs prayed for therein, including Mr. Reddy, the learned senior Counsel appearing for the SEBI. According to Mr. Reddy, SEBI needs to undertake an inquiry on legal and factual verification of the nature and extent of encumbrances, transferability of equity shares, and assessment of their realizable value.

11. Once we get the report of SEBI, we shall further proceed to pass orders insofar as this I.A. is concerned.

12. Let the report come on record by next date of hearing.

13. One copy of the report that the SEBI may file shall be

furnished to Mr. Nakul Dewan well in advance.

14. We also heard Mr. Anshin Desai, the learned senior counsel appearing for the applicants of I.A. No.35672 of 2023. In the said I.A., the following reliefs have been prayed for:-

“(1) Allow the present application and direct that the properties which belong to the Applicant and mentioned at Sl. No. 37 be deleted from the Tender Document dated 29.10.2021 I.e. Tender Document (Annexure A-1 2);

(II) Direct the appropriate authority of the Maharashtra Police be to investigate the manner in which the Power of Attorney Holder, Nimbalakar and M/s Royal Twinkle Star Pvt. Ltd. and M/s Citrus Check-Inn's have portrayed themselves to have right, title and Interest in the land which belongs to the Applicant”

15. We request Mr. Divan, the learned Amicus to look into this I.A. and assist us on the averments made in this application and the reliefs prayed for on the next date of hearing.

16. We also heard Mr. Gopal Jain, the learned senior counsel appearing for the applicant in I.A. No.204652. Mr. Jain invited our attention to one order passed by this Court dated 8.8.2024. Insofar as this I.A. is concerned, the learned Amicus on the next date of

hearing shall let us know where this amount has to be deposited.

17. I.A.No. 100718/2026

Application for impleadment is allowed. Axis Bank is impleaded as party opponent in the I.A.No.100938/2026.

Issue notice to Axis Bank.

Dasti service in addition is permitted.

18. I.A. No.45872/2019

We heard Mr. Shyam Divan, the learned Amicus, and Mr. Aditya Dewan, the learned counsel appearing for the applicants. In this I.A. the following relief(s) has been prayed for:-

"(A) This Hon'ble Court be pleased to modify the Order dated May 10, 2018 passed by this Hon'ble Court, and direct that Laurel Hotel Pvt. Ltd.'s name be removed and/or deleted from the list of 88 companies that were brought within the ambit of this Petition by the Order as it is not an associate / sister concern of the Companies as has been established by the ROC Report"

Upon verification the learned Amicus would submit that the relief as prayed for in the I.A. may be granted and Laurel Hotel Pvt. Ltd. be deleted from the list of 88 companies which were impleaded on 10.5.2018.

We accordingly grant prayer 'A' of this said I.A.

19. I.A. No. 322834/2025

We heard Mr. Amar Dave, the learned senior counsel appearing on behalf of the applicants, the learned Amicus and Mr. Niranjana Reddy, the learned senior counsel appearing for the SEBI.

In I.A. No. 322834/2025 the following reliefs have been prayed for:-

"A. Pass appropriate directions allowing the Applicant herein to acquire the 35% Stake in KML Estates as mentioned in Para-7 of the present application at last recorded auction reserve price of Rs. 15.00 Crore

B. Direct appropriate authority to Issue a sale certificate in the name of applicant upon payment the full consideration amount; OR

The learned Amicus submitted that both the reliefs as prayed for may be granted. The same are accordingly granted.

The clients of Mr. Dave undertake to deposit the amount of Rs.15 crore with the SEBI within a period of 04 months from today. Once the amount is deposited the sale certificate shall be issued.

20. I.A. NO. 204507 of 2026

Heard the learned senior counsel appearing for the applicants. The following relief has been prayed for in the application for

directions:-

"A Pass direction with respect to the return of the Passport to the Applicant for the purpose of the renewal of the same."

We call for the report of the Investigating Officer as regards the relief(s) prayed for in the I.A., i.e., return of the passport to the applicant for the purpose of the renewal of the same.

Mr. Aniruddha Deshmukh, the learned counsel accepts and waives service of notice for and on behalf of the EOW.
