**EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013
READ WITH REGULATION 23 OF THE SEBI (LISTING OBLIGATIONS AND DISCLOSURE
REQUIREMENTS) REGULATIONS, 2015**

ITEM NO. 3

As per Section 149(10) of the Companies Act, 2013 (Companies Act, 2013), an Independent Director shall hold office for a term of upto five consecutive years on the board of a company, but shall be eligible for reappointment on passing a special resolution by the company for further term of upto five consecutive years on the board of a company.

Mrs. Rachana Agarwal (DIN: 08081299) was appointed as an Independent Director of the Company and holds office for her present term in accordance with the provisions of Sections 149, 152 and other applicable provisions of the Companies Act, 2013 read with the Rules made thereunder and Regulation 17 and other applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Based on the recommendation of the Nomination and Remuneration Committee and the Board of Directors made in their respective meetings held on July 30, 2026, it is proposed to re-appoint Mrs. Rachana Agarwal as a Non-executive Independent Director of the Company, not liable to retire by rotation, for a second term of five consecutive years commencing from August 26, 2026 up to August 25, 2031, subject to approval of the Members.

Mrs. Rachana Agarwal is associated with the company as an Independent Director since the year 2021. She brings with her expertise in governance practices, sustainability, which strengthens the Board's ability to provide strategic guidance and ensure sound governance practices. As an Independent Director, she upholds the highest standards of integrity, objectivity, and corporate governance and provides valuable insights for the balanced and sustainable growth of the company.

In the opinion of the Board, Mrs. Rachana Agarwal fulfills the conditions specified under the Companies Act, 2013 and SEBI LODR for re-appointment as an Independent Director and is independent of the management. Considering her knowledge, experience and valuable contribution to the Board deliberations, the Board considers her re-appointment to be in the best interest of the Company.

Accordingly, the Board recommends the Special Resolution set out at Item No. 3 of the Notice for approval of the Members.

Except Mrs. Rachana Agarwal and her relatives, none of the Directors, Key Managerial Personnel of the Company or their relatives are in any way concerned or interested, financially or otherwise, in the resolution.

ITEM NO. 4

The Members of the Company had approved the "Raw Edge Industrial Solutions Limited – Employee Stock Option Plan 2023" ("ESOP 2023" / "Scheme") at the Annual General Meeting held on September 22, 2023 pursuant to the provisions of Section 62(1)(b) and other applicable provisions of the Companies Act, 2013 read with Rule 12 of the Companies (Share Capital and Debentures) Rules, 2014 and the Securities and Exchange Board of India (Share Based Employee Benefits and Sweat Equity) Regulations, 2021 ("SEBI SBEB & SE Regulations").

Subsequently, the Nomination and Remuneration Committee and the Board of Directors at their respective meetings held on March 23, 2026 cancelled the grant of 79,500 (Seventy-Nine Thousand Five Hundred) Employee Stock Options made on May 18, 2024 as necessary regulatory approvals weren't obtained before making such grant.

Further, the Nomination and Remuneration Committee and the Board of Directors at their respective meetings held on July 30, 2026 decided to cancel/ terminate the ESOP 2023 Scheme, subject to the approval of members.

The Board noted that no equity shares have been allotted under the Scheme till date and therefore no dilution in the existing share capital of the Company has taken place pursuant to the Scheme. Accordingly, the Board considered it appropriate and in the best interest of the Company to discontinue the Scheme.

Upon approval of the Members, the said ESOP 2023 shall stand cancelled and terminated with effect from July 30, 2026 and all rights, obligations and entitlements arising thereunder, to the extent not exercised, shall stand extinguished in accordance with the terms of the Scheme and applicable laws.

The proposed cancellation is in compliance with the applicable provisions of the Companies Act, 2013, the SEBI (Share Based Employee Benefits and Sweat Equity) Regulations, 2021, the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Secretarial Standards and other applicable laws, rules, regulations and circulars as may be applicable.

None of the Directors, Key Managerial Personnel of the Company and their relatives are concerned or interested, financially or otherwise, in the proposed resolution except to the extent of stock options, if any, granted under the Scheme.

The Board recommends the Special Resolution set out at Item No. 4 of the accompanying Notice for approval of the Members.

The company had appointed Mr. Ranjit Binod Kejriwal, Company Secretary in practice, (FCS: 6116, COP: 5985) and a Peer Reviewed Company Secretary, as the Secretarial Auditor of the Company for a period of five consecutive years commencing from April 01, 2025 till March 31, 2030 in accordance with Regulation

24A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.

The Secretarial Audit Report is annexed herewith in **Annexure V**. The Secretarial Auditor's observation(s) in secretarial audit report and directors' explanation thereto –

1. The Company had granted ESOPs on May 18, 2024 under its ESOP Scheme without obtaining prior in-principle approval from BSE Limited as required under Regulation 28 of the SEBI (LODR) Regulations, 2015. Subsequently, the Company cancelled the said grant on March 23, 2026 by treating the same as void ab initio on account of the aforesaid non-compliance. *The lapse occurred due to inadvertent oversight. Considering the non-obtaining of in-principle approval from BSE Limited, the Company cancelled the ESOP grants made on May 18, 2024 vide its decision dated March 23, 2026 by treating the same as void ab initio. Further, the management stated that no equity shares were allotted pursuant to the said grant and, accordingly, no shareholder dilution or financial impact arose.*
2. The Company had initially filed the XBRL report pertaining to the financial results for the quarter ended December 31, 2025 with incorrect mention of the face value of equity shares. Pursuant to a discrepancy communicated by BSE Limited, the Company subsequently revised and re-submitted the XBRL filing. *The incorrect disclosure of face value in the XBRL filing occurred due to an inadvertent clerical/error in data entry and that the revised filing was submitted promptly upon receipt of discrepancy from BSE Limited.*
3. Certain documents required to be disseminated under the applicable provisions were available on the Company's website, however, the same were not placed at their designated location/section on the website. Upon being intimated by BSE Limited, the Company has appropriately updated and repositioned the relevant documents. *The company has initiated measures to strengthen its compliance processes.*

17. **INTERNAL AUDITOR**

The Company had appointed Mr. Tofan Ashok Jena, Surat as an Internal Auditor F.Y. 2025-26 in the Board meeting held on August 01, 2025 after obtaining his willingness and eligibility letter for appointment as Internal Auditor of the Company.

The notes referred to in the Auditor's Report are self-explanatory and as such they do not call for any further explanation.

Limestone reserves are adequate for most of the countries. China is consistently the largest producer of Lime as can be seen in above table. India is the 2nd largest country in the World in terms of production according to data released by U.S. Geological Survey, Mineral Commodity Summaries. All these countries produce adequate quantity of lime for their own consumption.

According to experts, strongest annual growth of lime is expected to come from China, India, US and other developing countries.

As per publicly available data from reliable sources such as the United States Geological Survey (USGS) and global market research reports, the **latest country-wise lime production data is available only up to the year 2025**.

During the financial year 2025–26, the global minerals and limestone industry remained stable despite economic uncertainties in several countries. Demand from key industries such as steel, construction, infrastructure, chemicals, and environmental applications continued to support the market. Although

higher interest rates and geopolitical developments slowed industrial activity in some regions, the overall demand for limestone, lime, and other industrial minerals remained steady.

The industry also witnessed increasing demand for value-added products such as Hydrated Lime, driven by their growing use in water treatment, pollution control, and other industrial applications. China continued to be the largest producer of lime globally, while developed countries maintained stable production to meet domestic industrial requirements. Overall, the global minerals and limestone sector remained resilient and continued to play an important role in supporting industrial and infrastructure development.

- **Global Lime Industry:** According to the U.S. Geological Survey (USGS), global lime production was estimated at approximately 420 million metric tons during 2025.
- **China's Position:** China continued to be the largest producer of lime globally with an estimated production of 310 million metric tons, accounting for a significant share of worldwide output.
- **India's Position:** India remained the second-largest producer of lime globally with an estimated production of 17 million metric tons during 2025.
- **Demand Outlook:** Demand for lime and value-added products such as Hydrated Lime continued to be supported by growth in steel manufacturing, infrastructure development, environmental applications, water treatment and industrial processing activities across major economies.

GROWTH OF INDIAN ECONOMY

The Indian economy continued to demonstrate remarkable resilience during FY 2025–26, maintaining its position as the fastest-growing major economy in the world. As per the provisional estimates released by the Government of India, the country's real Gross Domestic Product (GDP) grew by **7.4% (approx.) during FY 2025–26**, reflecting robust domestic demand, sustained public investment, resilient manufacturing activity, and strong growth in the services sector. A healthy growth of **7.8% (approx.) in the fourth quarter (Q4 FY2025–26)** further underscores the strength of the Indian economy despite ongoing geopolitical tensions, global trade uncertainties, and volatile commodity prices.

The Government has continued its emphasis on infrastructure-led growth by providing a **capital expenditure outlay of approximately ₹11.21 lakh crore** in the Union Budget FY2025–26. This sustained investment in infrastructure development is expected to strengthen logistics, improve connectivity, enhance manufacturing competitiveness, stimulate private sector investments, create employment opportunities, and support long-term economic growth across various sectors.

Asian economies such as **India, China, Japan, and South Korea** continue to remain significantly **dependent on crude oil imports**. Consequently, disruptions in **global supply chains, geopolitical conflicts, and fluctuations in international crude oil prices** continue to pose risks to these economies. Higher energy prices may lead to increased inflationary pressures, elevated transportation and manufacturing costs, and reduced consumer purchasing power.

Although inflation moderated during FY2025–26, central banks across the globe continued to carefully balance the objectives of maintaining price stability while supporting economic growth. The evolving global monetary policy environment, changing interest rate outlook, and capital flow movements continue to influence investment decisions and macroeconomic stability across emerging economies, including India.

The global growth outlook for the coming years, as per the latest estimates, indicates gradual improvement; however, growth continues to remain below the long-term historical average. The key highlights are as follows:

1. Global Growth Estimates:

The International Monetary Fund (IMF) projects global economic growth at approximately 3.0% in 2025, with a modest improvement to around **3.1% (approx.) in 2026**. The upward revision reflects improving economic conditions in the United States, China, and several emerging economies, supported by easing inflation, improving financial conditions, and gradual recovery in global trade.

2. Comparison with Historical Average:

Despite the projected improvement, global growth continues to remain below the historical average of 3.8% (approx.) recorded during the period 2000–2019. This divergence is primarily attributable to the following factors:

- **Monetary Policy Normalization:**

Although inflation has moderated in many economies, central banks continue to maintain cautious monetary policies. Interest rates remain relatively elevated compared to pre-pandemic levels, resulting in tighter financial conditions and moderating investment growth.

- **Reduced Fiscal Space:**

Governments across both advanced and emerging economies continue to face high public debt levels following pandemic-related fiscal spending. Consequently, fiscal consolidation measures and limited budgetary flexibility are expected to constrain public expenditure and economic expansion.

- **Moderate Productivity Growth:**

Despite rapid technological advancements, digital transformation, and increasing adoption of Artificial Intelligence (AI), productivity growth across several economies remains moderate due to structural challenges, labour market mismatches, and slower capital formation.

3. Advanced Economies Outlook:

Advanced economies are expected to witness moderate growth during 2025 and 2026. The United States is projected to maintain resilient economic activity supported by strong labour markets and consumer spending, although growth is expected to moderate from previous highs. The Euro Area is likely to experience a gradual recovery driven by easing inflation, improving domestic demand, and better financial conditions, while Japan is expected to record stable growth supported by corporate investments and accommodative fiscal policies.

Continued Government investment in infrastructure through a capital expenditure outlay of approximately ₹11.21 lakh crore in the Union Budget FY 2025–26 is expected to support industrial expansion, infrastructure development, and manufacturing growth, thereby creating sustained demand for lime-based products.

The Company remains well positioned to capitalize on these opportunities through its focus on product quality, process efficiency, customer satisfaction, and continuous operational improvements. The Company's strategic location, reliable supply chain, experienced management team, and commitment towards maintaining high product standards provide a competitive advantage in serving customers across multiple industries.

The Company also continues to explore new business opportunities by expanding its customer base across specialty chemicals, water treatment, environmental applications, infrastructure projects, and export markets. Growing awareness regarding environmental compliance and increasing investments in wastewater treatment

and emission control systems are expected to create additional demand for Hydrated Lime and other lime-based products.

On the other hand, the industry continues to face challenges arising from fluctuations in limestone availability, volatility in fuel and energy costs, rising transportation expenses, increasing logistics costs, and pricing pressure due to intense competition. "The Return on Net Worth improved from (-4.98%) in FY 2024-25 to (-1%) in FY 2025-26. The improvement was primarily due to a reduction in losses during the year, resulting in a comparatively better return on shareholders' funds. However, the ratio remained negative as the Company continued to incur losses during the financial year."

- The Company had granted ESOPs on May 18, 2024 under its ESOP Scheme without obtaining prior in-principle approval from BSE Limited as required under Regulation 28 of the SEBI (LODR) Regulations, 2015. Subsequently, the Company cancelled the said grant on March 23, 2026 by treating the same as void ab initio on account of the aforesaid non-compliance.
- The Company had initially filed the XBRL report pertaining to the financial results for the quarter ended December 31, 2025 with incorrect mention of the face value of equity shares. Pursuant to a discrepancy communicated by BSE Limited, the Company subsequently revised and re-submitted the XBRL filing.
- Certain documents required to be disseminated under the applicable provisions were available on the Company's website, however, the same were not placed at their designated location/section on the website. Upon being intimated by BSE Limited, the Company has appropriately updated and repositioned the relevant documents.

I further report that, based on the information provided by the company, its officers and authorised representative during the conduct of the audit, and also on the review of reports by CS/CFO and Statutory Auditor of the company, in my opinion, adequate systems and processes and control mechanism exist in the company to monitor and ensure compliance with applicable general laws.

I further report that, the compliance by the company of applicable financial laws, like direct and indirect tax laws and other acts as mentioned in point (vi), has not been reviewed in this audit since the same have been subject to review by statutory financial audit and other designated professionals.

I further report that, the Board of Directors of the Company is duly constituted with proper balance of Executive Directors, Non-Executive Directors and Independent Directors. The changes in the composition of the Board of Directors, if any that took place during the period under review were carried out in compliance with the provisions of the Act.

Adequate notice is given to all directors to schedule the Board Meetings, agenda and detailed notes on agenda were sent at least seven days in advance and a system exists for seeking and obtaining further information and clarifications on the agenda items before the meeting and for meaningful participation at the meeting.

As per the minutes of the meetings duly recorded and signed by the chairman, the decisions of the board were unanimous and no dissenting views have been recorded.

NOTES TO STANDALONE FINANCIAL STATEMENTS

1. Description of the company and significant accounting policies

1.1 Basis of Preparation of Standalone Financial Statements

(i) Corporate Information

Raw Edge Industrial Solutions Limited is a listed company with BSE platform domiciled in India and incorporated on 14th February, 2005 under the provisions of the Companies Act, 1956 (now Companies Act, 2013). The address of its registered office is B1- 401, B wing, Boomerang, Chandivali Farm Road, Andheri East, Mumbai, Maharashtra- 400072. The company is engaged in the trading & manufacturing of minerals and also in providing service of transportation. The company caters to domestic market only. The Company had diversified its operations by trading and distribution of Agro-based food products during the year.

(ii) Statement of compliance

The Standalone Financial Statements of the Company as at and for the year ended March 31, 2026 have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015 (as amended from time to time) and presentation requirements of Division II of Schedule III to the Companies Act, 2013, (Ind AS compliant Schedule III). as amended from time to time, guidelines issued by the Securities and Exchange Board of India ("SEBI") and other relevant provisions of the Act and accounting principles generally accepted in India.

The Standalone Financial Statements have been prepared on a historical cost basis and on an accrual basis, except for certain financial instruments which are measured at fair values or amortised cost depending upon classification. Historical cost is generally based on the fair value of the consideration given in exchange of goods or services.

The Standalone Financial Statements of the Company comprises of its Standalone Statement of Assets and Liabilities as at March 31, 2026, and Standalone Statement of Profit and Loss, Standalone Statement of Changes in Equity and Standalone Statement of Cash Flows for the year then ended.

(iii) Going concern

The company intends to continue its business as a going concern and accordingly financial statements are prepared on that basis.

(iv) Statement of Consistency of Accounting Policy

The accounting policies are applied consistently to all the periods presented in the financial statements, except where a newly issued accounting standard is initially adopted or a revision to an existing standard requires a change in the accounting policy hitherto in use.

(v) Functional and Presentation Currency and rounding of amounts

The financial statements are presented in Indian Rupee (Rs.) which is also the functional currency of the Company. All amounts disclosed in the financial statements and notes have been rounded off to the nearest lakhs with two decimal thereof as per the requirement of Schedule III, unless otherwise stated.

1.2 Use of estimates and judgements

The preparation of the Standalone Financial Statements in conformity with Ind AS requires the management to make estimates, judgments and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities at the date of the Standalone Financial Statements and reported amounts of revenues and expenses during the period. Actual results may differ from those estimates.

NOTES TO STANDALONE FINANCIAL STATEMENTS

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised and in any future periods affected. Actual results could differ from those estimates. Appropriate changes in estimates are made as the Management becomes aware of changes in circumstances surrounding the estimates. Changes in estimates are reflected in the financial statements in the period in which changes are made and, if material, their effects are disclosed in the notes to the Standalone financial statements. In particular, information about significant areas of estimation, uncertainty and critical judgment in applying accounting policies that have the most significant effect on the amounts recognized in financial statements are included in the following notes:

- Useful lives of Property, plant and equipment
- Measurement of defined benefit obligations
- Provision for inventories
- Measurement and likelihood of occurrence of provisions and contingencies
- Deferred taxes

1.3 Current versus non-current classification

The Company presents assets and liabilities in the Standalone balance sheet based on current/ non-current classification. An asset is treated as current when it is:

- Expected to be realised or intended to be sold or consumed in normal operating cycle;
- Held primarily for the purpose of trading;
- Expected to be realised within twelve months after the reporting period, or
- Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All other assets are classified as non-current.

A liability is current when:

- It is expected to be settled in normal operating cycle.
- It is held primarily for the purpose of trading.
- It is due to be settled within twelve months after the reporting period, or
- There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

The Company classifies all other liabilities as non-current.

Deferred tax assets and liabilities are classified as non-current assets and liabilities.

All assets and liabilities have been classified as current or noncurrent according to the Company's operating cycle and other criteria set out in the Act. Based on the nature of products and the time between the acquisition of assets for processing and their realisation in cash and cash equivalents, the Company has ascertained its operating cycle as twelve months for the purpose of the current non-current classification of assets and liabilities.

1. 4 Fair value measurement

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorized within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 - Quoted (unadjusted) prices in the active market for identical assets or liabilities.
- Level 2 (if level 1 feed is not available/appropriate) - Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable.
- Level 3 (if level 1 and 2 feed is not available/appropriate) - Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable.

For financial assets and liabilities maturing within one year from the Balance Sheet date and which are not carried at fair value, the carrying amount approximates fair value due to the short maturity of these instruments.

NOTES TO STANDALONE FINANCIAL STATEMENTS

1.5 Revenue recognition

Revenue from contracts with customers is recognised when control of the goods or services are transferred to the customer at an amount that reflects the consideration to which the Company expects to be entitled in exchange for those goods or services. Revenue is measured at the fair value of the consideration received or receivable, taking into account contractually defined terms of payment and excluding taxes or duties collected on behalf of the government.

(i) Sale of goods

Revenue is recognised when the significant risks and rewards of ownership of the goods have been passed to the buyer. Sales are disclosed at exclusive of GST. Trade discounts are shown net from gross sales.

(ii) Sale of services

Revenue from services is recognised as and when services are rendered.

(iii) Other Income

Other income is recognised when no significant uncertainty as to its determination or realisation exists.

1.6 Taxes

Tax expenses comprise of current and deferred tax:

Current income tax

(a.) Current income tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, at the reporting date.

(b.) Current income tax relating to items recognised outside profit or loss is recognised outside profit or loss (either in other comprehensive income or in equity).

Deferred tax

Deferred tax is recognized in respect of temporary differences between the carrying amount of assets and liabilities for financial reporting purposes and the corresponding amounts used for taxation purposes.

A deferred tax liability is recognized based on the expected manner of realization or settlement of the carrying amount of assets and liabilities, using tax rates enacted, or substantively enacted, by the end of the reporting period. Deferred tax assets are recognized only to the extent that it is probable that future taxable profits will be available against which the asset can be utilized. Deferred tax assets are reviewed at each reporting date and reduced to the extent that it is no longer probable that the related tax benefit will be realized.

1.7 Earning Per Share

The Company presents basic and diluted earnings per share ("EPS") data for its ordinary shares. Basic EPS is calculated by dividing the profit or loss attributable to ordinary shareholders of the Company by the weighted average number of ordinary shares outstanding during the period. Diluted EPS is determined by adjusting the profit or loss attributable to ordinary shareholders and the weighted average number of ordinary shares outstanding for the effects of all dilutive potential ordinary shares.

NOTES TO STANDALONE FINANCIAL STATEMENTS

1.8 Property, Plant and Equipment Recognition and measurement

Construction in progress is stated at cost, net of accumulated impairment losses, if any. Property, plant and equipment are initially recognized at cost after deducting refundable purchase taxes and including the cost directly attributable to bring the asset to the location and conditions necessary for it to be capable of operating in the manner intended by the management, borrowing cost in accordance with the established accounting policy, cost of restoring and dismantling, if any, initially estimated by the management.

After the initial recognition the property, plant and equipment other than freehold land are carried at cost less accumulated depreciation and impairment losses. Cost of Self-constructed asset is determined using the same principles as for acquired assets after eliminating the component of internal profits.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits attributable to such subsequent cost associated with the item will flow to the Company. All other repair and maintenance costs are recognised in Standalone statement of profit or loss as incurred.

The cost of replacing part of an item of property, plant and equipment is recognised in the carrying amount of the item if it is probable that the future economic benefits embodied within the part will flow to the Company and its cost can be measured reliably. The costs of repairs and maintenance are recognised in the Standalone statement of profit and loss as incurred.

Advances paid towards the acquisition of property, plant and equipment outstanding at each reporting date is disclosed as capital advances under non-current assets.

Capital work-in-progress included in property, plant and equipment are not depreciated as these assets are not yet available for use. Any gain or loss on disposal of an item of property, plant and equipment is recognized in Standalone profit or loss.

Depreciation has been provided on straight line method in terms of expected life span of assets specified in Schedule – II of the Companies Act, 2013 or as determined by management.

The residual value and useful life are reviewed annually, and any deviation is accounted for as a change in estimate. The estimated useful lives, residual values and depreciation method are reviewed at each financial year end and the effect of any change is accounted for on prospective basis. The carrying amount of the all property, plant and equipment are derecognized on its disposal or when no future economic benefits are expected from its use or disposal and the gain or loss on de-recognition is recognized in the Standalone statement of profit & loss.

1.9 Intangible Assets

Acquired intangible assets are initially recognized at cost after deducting refundable purchase taxes and including the transaction cost, if any.

After initial recognition, intangibles are carried at cost less accumulated amortization and impairment losses. Acquired computer software licenses are capitalised on the basis of the costs incurred to acquire and bring to use the specific software. The amortization of an intangible asset with a finite useful life reflects the manner in which the economic benefit is expected to be generated. The estimated useful lives, residual values and amortization method are reviewed at each financial year end and the effect of any change is accounted for on prospective basis.

1.10 Borrowing Costs

Borrowing costs directly attributable to the acquisition, construction or production of an asset that necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of the asset.

NOTES TO STANDALONE FINANCIAL STATEMENTS

All other borrowing costs are expensed in the period in which they occur. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds. Borrowing cost also includes exchange differences to the extent regarded as an adjustment to the borrowing costs.

1.11 Leases

The Company determines that a contract is or contains a lease, if the contract conveys right to control the use of an identified asset for a period of time in exchange for a consideration. At the inception of a contract which is or contains a lease, the Company recognises lease liability at the present value of the future lease payments for the non-cancellable period of a lease which is not short-term in nature except for lease of low value items. The future lease payments for such non-cancellable period is discounted using the Company's incremental borrowing rate. However in the current year, the company has not entered into any lease transaction.

1.12 Inventories

Inventories consist of raw materials, stores & spares, work-in-progress, stock-in-trade and finished goods. Inventories are valued at lower of cost and net realizable value (NRV) except for raw materials which is valued at cost.

The cost of raw materials and stores & spares includes the cost of purchases and other costs incurred in bringing the inventories to their present location and condition.

Cost of work-in-progress and finished goods includes direct materials, labour and proportion of manufacturing overheads based on the normal operating capacity, wherever applicable.

The cost of stock-in-trade includes cost of purchase and other costs incurred in bringing the inventories to their present location and condition.

Net realizable value is the estimated selling price in the ordinary course of business, less estimated costs of completion and estimated costs necessary to make the sale. However, materials and other items held for use in the production of inventories are not written down below cost if the finished products in which they will be used are expected to be sold at or above cost.

1.13 Foreign currency

Functional and presentation currency: Items included in the financial statements are measured using the currency of the primary economic environment in which the company operates ('the functional currency'). The financial statements are presented in Indian Rupees (INR), which is the company's functional and presentation currency.

Foreign currency transactions: Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are generally recognized in Statement of Profit and Loss and reported within foreign exchange gains/ (losses).

1.14 Provisions, Contingent Liabilities and Contingent Assets

A provision is recognised if, as a result of a past event, the Company has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. If the effect of the time value of money is material, provisions are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. Where discounting is used, the increase in the provision due to the passage of time is recognized as a finance cost.

NOTES TO STANDALONE FINANCIAL STATEMENTS

Contingent Liabilities

A contingent liability is a possible obligation that arises from past events whose existence will be confirmed by the occurrence or non-occurrence of one or more uncertain future events beyond the control of the company or a present obligation that is not recognized because it is not probable that an outflow of resources will be required to settle the obligation.

Contingent Assets

Contingent assets are not recognised in the financial statements. However, contingent assets are assessed continually and if it is virtually certain that an inflow of economic benefits will arise, the asset and related income are recognised in the period in which the change occurs.

1.15 Employee benefits

(i) Short Term Employee Benefits

All employee benefits payable wholly within twelve months of rendering the service are classified as short-term employee benefits. Benefits such as salaries, wages, short-term compensated absences, etc., and the expected cost of bonus, ex-gratia are recognized in the period in which the employee renders the related service.

(ii) Post-Employment Benefits

Defined Contribution Plans - State governed Provident Fund Scheme and Employees State Insurance Scheme are defined contribution plans. The contribution paid / payable under the schemes is recognised during the period in which the employees render the related services.

Defined Benefit Plans - The Company has Defined Benefit Plan for post-employment benefit in the form of Gratuity for eligible Employees. Gratuity Liability based on actuarial valuation as per Ind AS 19 recognized in the balance sheet is the present value of the defined benefit obligation at the end of each reporting period less the fair value of plan assets. The defined benefit obligation is calculated annually by actuary using the projected unit credit method. The present value of defined benefit is determined by discounting the estimated future cash outflows by reference to market yield at the end of each reporting period on government bonds. The interest cost is calculated by applying the discount rate to the net balance of the defined benefit obligation and the fair value of plan assets. The cost is included in employee benefit expense in the standalone statement of profit and loss. Actuarial gain / loss arising from experience adjustments and changes in actuarial assumptions are credited / debited to "other comprehensive Income" forming part of other equity.

1.16 Financial Instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

Financial Assets

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

Financial assets and liabilities are recognised when the Company becomes a party to the contractual provisions of the instrument.

NOTES TO STANDALONE FINANCIAL STATEMENTS

Financial assets

Classification

The Company classifies its financial assets in the following measurement categories:

- Those to be measured subsequently at fair value (either through other comprehensive income, or through the Statement of Profit and Loss), and
- Those are measured at amortized cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

Initial recognition and measurement

Financial assets are recognized when the Company becomes a party to the contractual provisions of the instrument. Financial assets are recognized initially at fair value plus or minus, in the case of financial assets not recorded at fair value through Profit and Loss, transaction costs that are attributable to the acquisition of the financial asset.

Transaction costs of financial assets carried at fair value through Profit and Loss are expensed in the Statement of Profit and Loss.

Subsequent measurement

After initial recognition, financial assets are measured at:

- fair value (either through other comprehensive income or through Profit and Loss), or
- Amortized cost.

Debt instruments

Debt instruments are subsequently measured at amortized cost, fair value through other comprehensive income ('FVOCI') or fair value through Profit and Loss ('FVTPL') till de-recognition on the basis of (i) the entity's business model for managing the financial assets and (ii) the contractual cash flow characteristics of the financial asset.

Amortised cost

Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortized cost. A gain or loss on a debt investment that is subsequently measured at amortized cost is recognized in the Statement of Profit and Loss when the asset is derecognized or impaired. Interest income from these financial assets is included in other income using the effective interest rate method.

Fair Value through Other Comprehensive Income (FVOCI)

Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at FVOCI. Movements in the carrying amount are taken through OCI, except for the recognition of impairment gains or losses, interest revenue and foreign exchange gains and losses which are recognized in the Statement of Profit and Loss.

When the financial asset is derecognized, the cumulative gain or loss previously recognized in OCI is reclassified from equity to Statement of Profit and Loss and recognized in other gains/ (losses). Interest income from these financial assets is included in other income using the effective interest rate method.

Fair Value through Profit and Loss (FVTPL)

Assets that do not meet the criteria for amortized cost or FVOCI are measured at FVTPL.

A gain or loss on a debt investment that is subsequently measured at FVTPL is recognised in Statement of Profit and Loss in the period in which it arises. Interest income from these financial assets is recognised in the Statement of Profit and Loss.

NOTES TO STANDALONE FINANCIAL STATEMENTS

Equity instruments

All equity investments in scope of Ind AS 109 are measured at fair value. Equity instruments which are held for trading are classified as at FVTPL. For all other equity instruments, the Company decides to classify the same either as at FVTOCI or FVTPL.

The Company makes such election on an instrument-by-instrument basis. The classification is made on initial recognition and is irrevocable.

If the Company decides to classify an equity instrument as at FVTOCI, then all fair value changes on the instrument, excluding dividends, are recognized in Other Comprehensive Income (OCI). There is no recycling of the amounts from OCI to Statement of Profit and Loss, even on sale of such investments.

Equity instruments included within the FVTPL category are measured at fair value with all changes recognized in the Statement of Profit and Loss.

Financial liabilities

Initial recognition and measurement

Financial liabilities are initially measured at its fair value plus or minus, in the case of a financial liability not at FVTPL, transaction costs that are directly attributable to the issue/origination of the financial liability.

Subsequent measurement

Financial liabilities are classified as measured at amortized cost or FVTPL. A financial liability is classified as at FVTPL if it is classified as held for trading, or it is a derivative or it is designated as such on initial recognition. Financial liabilities at FVTPL are measured at fair value and net gains and losses, including any interest expense, are recognized in statement of profit and loss. Other financial liabilities are subsequently measured at amortized cost using the effective interest method. Interest expense and foreign exchange gains and losses are recognized in Statement of profit and loss. Any gain or loss on de-recognition is also recognized in statement of Profit and Loss.

De-recognition

A financial liability is derecognized when the obligation specified in the contract is discharged, cancelled or expires.

1.17 Cash and cash equivalents

Cash and cash equivalent in the balance sheet comprise cash at banks and on hand and short-term deposits with an original maturity of three months or less, which are subject to an insignificant risk of changes in value.

1.18 Cash Flow Statement

Cash flows statement are reported using the Indirect Method, as set out in Ind AS 7 'Statement of Cash Flow', whereby profit for the year is adjusted for the effects of transaction of non-cash nature, any deferrals or accruals of past or future operating cash receipts or payments and item of income or expenses associated with investing or financing cash flows. The cash flows from operating, investing and financing activities of the Company are segregated.

1.19 Trade receivables

Trade receivables are amounts due from customers for goods sold or services performed in the ordinary course of business and reflects Company's unconditional right to consideration (that is, payment is due only on the passage of time).

NOTES TO STANDALONE FINANCIAL STATEMENTS

1.20 Trade and other payables

These amounts represent liabilities for goods and services provided to the Company prior to the end of financial year which are unpaid. The amounts which are unsecured are presented as current liabilities unless payment is not due within 12 months after the reporting period.

1.21 Government Grants

Government grants are initially recognised as deferred income at fair value if there is reasonable assurance that they will be received and the Company will comply with the conditions associated with the grant;

- In case of capital grants, they are then recognised in Statement of Profit and Loss on a systematic basis over the useful life of the asset.
- In case of grants that compensate the Company for expenses incurred are recognised in Statement of Profit and Loss on a systematic basis in the periods in which the expenses are recognised.

1.22 Share based payment

The Board of Directors of Raw Edge Industrial Solutions Limited ("the Company") had approved the Raw Edge Industrial Solutions Limited – Employee Stock Option Plan 2023 (ESOP 2023) on August 18, 2023, which was subsequently approved by the shareholders at the Annual General Meeting held on September 22, 2023.

The Company vide resolutions dated 23rd March, 2026, have resolved to cancel and rescind ab initio the grant of 79,500 (Seventy-Nine Thousand Five Hundred) Employee Stock Options made to eligible employees of the Company under the REISL ESOP 2023.

The reason for cancellation is that the aforesaid grant was made without obtaining the in principle approval from BSE Limited prior to the grant, as required under Regulation 12(3) of the SEBI (Share Based Employee Benefits and Sweat Equity) Regulations, 2021. No options under the said grant had vested or been exercised as of the date of cancellation. No shares have been allotted under the said grant.

As no options have been allotted or exercised, the cancellation of the invalid grant has no impact on the issued, subscribed, and paid-up equity share capital of the Company. The paid-up equity Share capital remains at Rs. 1005.84 Lakhs comprising of 1,00,58,400 equity shares of Rs. 10/- each.
