In compliance with Regulation 30 read with Para A (20) of Part A of Schedule III of SEBI Listing Regulations, we wish to inform that Superintendent (Adjudication), CGST Commissionerate, Faridabad Haryana, has passed an order dropping the Service Tax Demand (including Education Cess) of Rs. 1,55,93,215/- for the period 2007-08 to 2013-14 and penalty under Section 76, 77 and 78 of the Finance Act, 1994. Further, the aforesaid order confirms service tax demand of Rs. 8,25,59,276/- (including Education Cess) alongwith applicable interest thereon and penalty of Rs. 8,25,60,276/-, on account of taxability issues on certain transactions.

In this regard, the Company intends to file an appeal before the appellate authority.
