**Subject: Reminder Letter to holders of physical securities to update KYC details**

Dear Sir/ Ma'am,

This is to inform you that the Securities and Exchange Board of India ("SEBI"), vide its Master Circular No. HO/38/13/(4)2026-MIRSD-PoD/I/4298/2026 dated February 6, 2026 (as amended and updated from time to time) ("Master Circular"), has consolidated the regulatory framework relating to furnishing of PAN, KYC details and nomination by holders of physical securities.

Pursuant to the said Master Circular, securityholders holding securities in physical mode are mandatorily required to furnish/ update their Permanent Account Number ("PAN") and complete Know Your Customer ("KYC") details, including postal address with PIN code, mobile number, bank account details and specimen signature, with the Company's Registrar and Share Transfer Agent ("RTA") Skyline Financial Services Private Limited. Giving your Email ID and choice of Nomination are optional. Security holders are requested to register email id to avail online services and register the Nomination in their own interest.

In this connection, please note that the holders of physical securities who have not updated their PAN, contact details, Bank Account details and Specimen Signature shall not be eligible to lodge grievance or avail any service request from the RTA. The Security Holder shall be:

1. eligible to lodge grievance or avail of any service request from the RTA/ Company only after furnishing all the aforesaid details in entirety.
2. with effect from April 1, 2024, eligible for any payment including dividend, interest or redemption (if any) in respect of such folios, only through electronic mode upon furnishing all the aforesaid details.

The formats for registering/ updating the KYC details viz; Forms ISR-1, ISR-2, ISR-3, SH-13, SH-14 and SEBI circulars are available on the website of the RTA at [www.skylinerta.com](http://www.skylinerta.com) and on the website of the Company at [www.quintdigital.in](http://www.quintdigital.in) and can be downloaded by following below steps or through accessing given QR Code:

The holders of physical securities are kindly requested to dematerialise their holdings. Those who have already submitted their KYC documents or have dematerialised their holdings are advised not to resubmit the same.
