Sub: Clarification on Observations Raised in the Financial Results Submission

With reference to your email dated 29-Jun-2026 regarding the deficiencies observed in our submission of the financial results, we wish to submit the following clarification:

1. Financial Results not signed by authorized signatory(ies)

The financial results submitted with the Exchange were duly signed by the authorized signatories, namely:

- Mr. Nikesh Kishorchandra Choksi – Managing Director
- Mr. Richi Nikesh Choksi – Whole-time Director
- Mr. Dipesh Patel - Chief Financial Officer (CFO)
- Ms. Kavaljit Paramr - Company Secretary (CS)

However, we would like to clarify that while the documents were duly signed by the above-mentioned authorized signatories, the specific designations of Mr. Nikesh Kishorchandra Choksi and Mr. Richi Nikesh Choksi were inadvertently mentioned only as "Director" instead of "Managing Director" and "Whole-time Director," respectively. This was an inadvertent clerical error. We assure you that the financial results were duly approved and signed by the authorized signatories.

2. Discrepancies in the Standalone XBRL Filing

(a). EPS of Yearly figures not mentioned in Standalone XBRL

The omission of the Earnings Per Share (EPS) for the annual figures in the Standalone XBRL filing was caused by a technical glitch during the generation of the XML file from the XBRL file, resulting in the inadvertent omission of the relevant data.

To rectify the same, we have re-filed the Standalone XBRL financial results with the correct EPS details. A copy of the acknowledgment of the revised XBRL filing is enclosed herewith for your kind reference.

(b). Mismatch in PAT figures mentioned in Consolidated XBRL and PDF

The mismatch in the Profit After Tax (PAT) figures reported in the Consolidated XBRL and the PDF financial statements is attributable to the treatment of minority interest. The discrepancy arose due to a technical glitch encountered while generating the XML file from the XBRL file, which resulted in an inconsistency in the reported figures.
