Manuel, who had gone to the post as the favourite, tried hard to bridge the gap but found the filly equal to the task. Noraiah travelled well during the race and responded strongly to Antoy Raj’s urgings

in the final stages. Once she hit the front, she maintained her advantage and held on comfortably enough to register an important victory for her connections. For jockey Antoy Raj S, the success was his second win of the day and capped a rewarding afternoon at the Pune track. He handled Noraiah confidently and timed his challenge perfectly when the race entered its decisive phase. The victory will give Todywalla and his team plenty of encouragement, with Noraiah showing that she has the ability to compete successfully against more fancied rivals. Manuel had to settle for second place, while Noraiah emerged as the star of the afternoon.

US Open

Qinwen makes big comeback, Osaka joins her in Rd 4

Zheng Qinwen was on her back with her arms in the air, celebrating a US Open victory maybe only she believed was possible. Madison Keys fought off tears as she tried to explain how Zheng, way down and all but out, somehow got the win. Zheng, the Olympic gold medalist, extended her return to the US Open with a spectacular and stunning rally, winning the final seven games to eliminate No. 22 Keys 1-6, 7-6 (3), 7-5.

“I feel like I obviously got off to a really good lead, and then I just got really — I mean, got really scared, like I couldn’t swing,” Keys said. “I don’t know. Tennis just feels really hard right now, so I feel like that kind of took over.” Hours later, 13th-seeded Naomi Osaka joined her in the fourth round by defeating Elise Mertens 6-3, 3-6, 7-5. The two-time champion from Japan put her head on her racket after the final point, stunned herself at the victory. “Honestly, I can’t believe I

won this match,” Osaka said. Not quite as big a comeback as Zheng, but Osaka was down 4-2 in the third set and apologized for expressing so much frustration throughout a tough night. “There was a certain point, I don’t know, I felt like I put

my entire heart on the court and then I just kept trying every single point,” Osaka said. “I didn’t feel like I played amazing, and it was really getting me down. I was very negative on myself” Osaka avoided the kind of exit
