Sub: Disclosure under Regulation 30 read with sub-clause 5 of Para B of Part A of Schedule III of the SEBI (LODR) Regulation, 2015: cancellation/termination of Agreement for purchase of 2000 sq. mt. semi built-up tin shed from Gajra Bevel Gears Limited developed on 22945 sq. mt. lease hold land of Department of Trade and Industries, Dewas (M.P.).

Dear Sir,

Pursuant to the Regulation 30 read with sub-clause 5 of Para B of Part A of Schedule III of the SEBI (LODR) Regulation, 2015 and SEBI Master Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026 we wish to inform the Exchange regarding a material development concerning our previous corporate announcements dated December 23, 2024, and January 22, 2025.

The Company, by mutual consent with Gajra Bevel Gears Limited (party of agreement), has officially cancelled the Agreement for the purchase of a 2,000 sq. mt. semi-built-up tin shed.

The proposed transaction could not be concluded due to exceptional and prolonged delays in obtaining the requisite regulatory approvals from the Department of Trade and Industries, Dewas (M.P.), rendering the project commercially unviable. Accordingly, the Company decided to discontinue the proposal. Company had earlier paid an advance amount of Rs. 21,00,000/- (Rupees Twenty-One Lakhs only) toward this agreement which was refunded by the party.

Previously, Company had entered into an Agreement for purchase of 2000 sq. mt. semi built-up tin shed developed on 22942 sq. mt. lease hold land of Department of Trade and Industries, Dewas (M.P.) situated at 7A, I.S. Gajra Industrial Area 1, A. B. Road, Dewas (M.P) and In connection with the said agreement, the Company had paid an initial advance of Rs. 21,00,000/- (Rupees Twenty-One Lakhs only).

You are requested to kindly take the same on record for your further needful.
